DEFENDANTS' REPLY MOTION TO ATTORNEY KYLE BRISTOW'S AND THE FMI/ZPLC MOTION TO DISMISS FOR LACK OF JURISDICTION AND ALLEGED FAILURE TO STATE A CLAIM UNDER F.R.Civ.Proc 12(B)(2) and 12(B)(6) (Doc. 25)

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to make this Reply (Dispositive) Motion to Attorney Kyle Bristow, Executive Director of the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) and Bristow/Reo FMI/ZPLC frivolous and perjurous Motions to Dismiss for Lack of Jurisdiction and Alleged Failure to State a Claim under Fed. Rule. Of Civil Procedure 12(B)(2) and 12(B)(6). Both Bryan Reo and Attorney Kyle Bristow have acted as professional agents provocateur against the White Supremacist and Christian Identity Religious Movements for at least a decade in the case of Kyle Bristow and 20

years in the case of Bryan Reo, and have been caught out acting against Pastor Lindstedt and Pastor Lindstedt's long-standing Aryan Nations Church for purposes of destroying dissent as 'anti-domestic terrorist organizations and to practice "lawfare" against Pastor Lindstedt and Pastor Lindstedt's Church as the Lake County Courts, Judge Patrick Condon, the State of Ohio and Federal Governments cannot act openly and be seen engaging in state-sponsored terrorism and/or repression against real "White Supremacists" and Dual-Seedline Christian Identity Aryan Nations practictioners of a White Supremacist racial religion. Attorney Kyle Bristow and Bryan Reo are officers in the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center has been established by Pastor Lindstedt filing as proof Doc 26-1Exhibit #1 the 2017 IRS Short Form for a 501(c)(3) Tax Return pages 251-254. This document showing that all the major figures like Richard Spencer and Mike Isaac "Enoch" Peinovich and Attorney Augustus Invictus and many many more were at the Charlottesville Massacre in which many young whites were set up for detection and imprisonment under color of law was a feature, not a bug of the FMI/ZPLC, and thus the purpose of Kyle Bristow and the patently non-white Bryan Reo was and is to destroy the White Supremacy and Christian Identity Movements in general and Pastor Lindstedt and Pastor Lindstedt's Aryan Nations Church in particular and render the violations of the First Amendment under color of law to where the State of Ohio and Federal Government have plausible deniability. As this case proceeds, Pastor Lindstedt intends to joinder the rest of the FMI/ZPLC attorneys and ZOGbots into this litigation and the other Bryan Reo litigation for purpose of rendering Pastor Lindstedt "destitute and penniless" as Bryan Reo gloated on William "Baal" Finck's Christogenea forum on 24 Aug. 2014, See Doc 26-2, "Prey for My Suckcess", pages 255-257.

Therefore, contrary to Attorney Bristow's lying claims, this Court has jurisdiction as Bryan Reo and Kyle Bristow have been working together in criminal conspiracy against Pastor Lindstedt and Lindstedt's Church using color of law, namely the federal and Lake County Courts since at least early 2016 via "defamation litigation" and provable by their filing a recent joint Rule 26(F) Conference Report in which Kyle Bristow and Bryan Reo got together to file in unison as as one. (Doc. 28). A filing, be it a Motion to Strike or Motion to Dismiss or Motion for Summary Judgment by Kyle Bristow reads identically to one filed by Bryan Reo except Kyle Bristow has a flat stapler and color printer. Attorney Brett Klimkowsky would send Pastor Lindstedt before Bryan Reo got a law license the very same lunatic crap with a laser printer low on toner using Christmas Card envelopes and re-used envelopes from the county prosecutor and postage due until Kyle Bristow hit it big suing the state universities on behalf of letting Dickie Spencer yawp on campus. This "White Supremacist" "lawfare" organization was set up by the federal and state fusion center regimes in order to trap the young whiggers looking for a political solution to impending collapse. Old-time White Supremacist organizations like Pastor Lindstedt's Aryan Nations have always counseled against anything other than mostly passive resistance and preparing for the inevitable collapse and having nothing to do with organizations on the "Alt-Right" and FMI/ZPLC which have jews, mongrels, and homosexuals like Bryan Reo and Richard Spencer running things. Now these poseurs after years of claiming to be a White Supremacist "lawfare" organization claims that they are offended by Pastor Lindstedt's and Pastor Lindstedt's Aryan Nations Church's racist replies to a case initiated by Bryan Reo, and want this Court to hold in criminal contempt Pastor Lindstedt for violating their proposed gag order on Pastor Lindstedt's pro se non-lawyer defense. Thus this Court has jurisdiction under 42 U.S.C. 42 § 1983 and 1985 for these ZOGbot lawyer's "lawfare" conspiracy to violate Pastor

Lindstedt's and Lindstedt's Church's First Amendment rights to Freedom of Speech and of the press and of religion in speaking and writing and publishing the truth about these regime-criminals and lawyers acting in collusion with the Lake County Courts / Judge Patrick Condon, the State of Ohio and the U.S. Government to destroy racial and religious dissent. Pastor Lindstedt has thus demolished the lying claims of Kyle Bristow and Bryan Reo that this Court lacks jurisdiction to hear Pastor Lindstedt's and Lindstedt's non-501 (c) (3) organic and non-corporate Church's counter-complaint. A fraudulent complaint by a limited-purpose public figure concerning "defamation" from over 900 miles away against Bryan Reo cannot likewise claim that a counter-claim against Attorneys and Officers of this Court Bryan Reo and Kyle Bristow over this vexatious and malicious litigation somehow fails for a lack of jurisdiction based upon the self-serving lies of these lawyers. Thus this Court should punish both of their errant officers of their court bringing this Court into disrepute under Fed. Rule of Civil Procedure Rule 11 for deliberately misstating both the facts and law of this case.

Therefore Attorney Kyle Bristow – still a "White Supremacist" lawyer for David Duke – is still working as a ZOG false-flag operation along with Bristow's 'former' law clerk to try to claim that Pastor Lindstedt fails to make a claim against himself and his organization including Bryan Reo and Brett Klimkowsky for their working in conspiracy with the Lake County Courts / Judge Patrick Condon, the State of Ohio and the U.S. Government to violate the First Amendment 'rights' of Freedom of Speech, of the Press, and of Religion for saying that Bryan Reo and Bryan Reo's attorney friends are jews, mongrels, homosexuals and/or ZOGbots (the Movement term for government agents provocateurs). Attorney Bristow claims that this federal court lacks jurisdiction upon Pastor Lindstedt's counter-claim yet puts the lie to that claim by working together with Bryan Reo to draft a joint communication – Doc 28 – of a planning

conference in which Pastor Lindstedt was not invited although Pastor Lindstedt did say that a

conference when most of the parties joindered did respond like the Lake County Courts / Judge

Patrick Condon via their counsel Lindsey Upton & Lisa Zaring (Docs, 29, 30) would be best. In

fact, Attorney Bristow's entire Motion to Dismiss is a packet of lies and misstatements while

calling Pastor Lindstedt a child molester based upon an ADL (and what is a so-called White

Supremacist "lawfare" organization doing quoting a jew "lawfare" operation) press release from

2005 and not pointing out that Pastor Lindstedt's Church's forum that Bryan Reo and Kyle

Bristow are trying to get banned points out that the bogus charges had to be dismissed in 2009?

WHEREFORE, Defendant Pastor Lindstedt asks that this Court:

A. Strike Attorney Bristow's frivolous and fraudulent Motions to Dismiss and force Bristow to
