**DEFENDANTS' REPLY MOTION TO AMEND PLEADINGS TO JOIN ADDITIONAL
BRYAN REO CO-CONSPIRATORS / COUNTER DEFENDANTS VERSUS BRYAN
REO'S OPPOSITION (Doc46) ACCORDING TO THIS COURT'S CASE
MANAGEMENT CONFERENCE ORDER & REPLY TO OHIO'S Doc 47**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to make this Reply Motion countering Bryan Reo's Opposition (Doc 46) to Pastor Lindstedt's Motion to Joinder Additional Parties and to Amend Pleadings (Doc 45) in order to join additional Bryan Reo co-conspirators / counter-defendants / third party defendants as in this Court's 15 May 2020 Case Management Conference Order. Also responded to is the State of Ohio's Notice of Service (Doc 47) to the Bryan Reo co-conspirator / counter-defendant Attorney Brett Klinkowsky who as a fellow

founding member of the Board of Directors for the Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) was and is a federal and possibly state agent provocateur against Pastor Lindstedt and Lindstedt's Aryan Nations Church. Bryan Reo, Kyle Bristow and Richard Spencer and Mike Enoch (Peinovich) set up the planned riot at Charlottesville Virginia nearly two years ago as can be seen by Doc 26-1 the 2017 IRS 501(c)(3) Tax Form already posted in this and the other four cases. Bryan Reo has been engaged as a homosexual mongrel Satanic abomination working against Pastor Lindstedt and Lindstedt's Church since 2009 and engaged in "lawfare" of sorts since 2010. Pastor Lindstedt is engaged in trying to defend his inheritance -- since given away to his sister in late October and being fought over in South Dakota -- and these additional counter-defendants added (like Attorney Robert Konrad) and always present FMI/ZPLC Attorneys Kyle Bristow and Brett Klimkowsky have been working with Bryan Reo working for the Mighty Evil ZOG (Zionist Occupied Government) / Neo-Babylonian Empire and thus are properly part of this never-ending Bryan Reo litigation and should be added to and hunted down for counter-suit.

This will of course make Bryan Reo's neverending frivolous Motions for summary judgment on behalf of itself and its wife (Stefani Rossi Reo v. Martin Lindstedt 19-cv-02786) even more ridiculous and foolish than usual. Bryan Reo has been stalking Pastor Martin Lindstedt and Lindstedt's Aryan Nations Church for 11 years now and suing in federal and Lake County courts since 2014 and has branched out in its harassment to Granby Missouri and against Pastor Lindstedt's inheritance in Stanley County South Dakota using corrupt lawyers affiliated with Bryan Reo's Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) and under this litigation which is ongoing solely because of Bryan Reo refusing to allow Pastor Lindstedt and Lindstedt's Church to be left alone in peace. These additional

Bryan Reo parties should not be allowed to skulk in the shadows and should be dragged out to public scrutiny through this Bryan Reo litigation. There are the four current Bryan Reo v. Lindstedt federal lawsuits in the Northern District of Ohio:

In each of them Bryan Reo refuses to render the Rule 26 initial disclosures, writes up pages and pages of discovery / admissions over what Pastor Lindstedt published openly on Pastor Lindstedt's Church's web pages about public figure Bryan Reo and Reo's lawyer friends of the FMI/ZPLC, then files motion after motion to strike, for summary judgment while with Attorney Kyle Bristow refusing to allow Pastor Lindstedt any discovery except at tremendous expense and of dubious information. In fact the best place to go if one wants to research Bryan Reo and Reo false-flag operations is to Pastor Lindstedt's Aryan Nations Church's web page because there is where Bryan Reo, FMI/ZPLC and such court records and information are stored.

Pastor Lindstedt's elderly domestic partner Roxie Fausnaught died of renal failure around 3:00 am on 4 August 2020 after a full year of hospital visits and nursing home stays and was diagnosed with inoperable cancer since June. Pastor Lindstedt has been engaged in taking care of her and her Veterans Administration's widows check is what has been sustaining Pastor Lindstedt after he gave away his inheritance. Bryan Reo sued this inoffensive illiterate elderly bed-bound woman with a broken hip and bed-bound since Dec. 2013 and now is adding Pastor Lindstedt's sister to the persecution. Since Pastor Lindstedt no longer has to intensively nurse and sustain Roxie he will have far more time to attend to Bryan Reo and Reo's ZOG lawyer

friends and supporting state and federal criminal regimes. Perhaps stock sales in the sundry Lake, Newton and Stanley County Geldings & Walking Wombs Inc. as a part of the Aryan Nations local warlordism white supremacist “domestic terrorism” political and religious franchise.

REGARDING THE ADDITIONAL BRYAN REO COUNTER-DEFENDANTS

Bryan Reo pretends that this never-ending litigation which is solely caused by Bryan Reo is only frivolous when Pastor Lindstedt engages in adding all the Bryan Reo co-conspirators so that Bryan Reo can use the Ohio federal and state courts to (Doc 26-2 Prey for My Suckcess of 24 August 2014) “render Lindstedt destitute and penniless.” This is an improper use of the courts which will lead to civil war. Since Bryan Reo is a founding member of the Foundation for the MarketPlace of Ideas (FMI/ZPLC) along with Attorneys Kyle Bristow and Brett Klimkowsky and South Dakota lawyer Robert Konrad shows every sign of being a secret member then adding them to Defendant’s counter-suit makes perfect sense in that it makes Bryan Reo pursuit of a genuine long-time political White Supremacist and his Aryan Nations Church which calls for the destruction of this Neo-Babylonian Mighty Evil Empire have a downside of its own.

None of this litigation would exist except for the Lake County Courts, Judge Condon, the States of Ohio and South Dakota and the federal government allowing Bryan Reo & friends as a licensed attorneys to abuse legal process and do the “lawfare” against Pastor Lindstedt and Lindstedt’s family and Church. If Bryan Reo had accepted back in Oct. 2010 when Pastor Lindstedt found out that “SwordBrethren” was a known homosexual mongrel of mixed negroid, oriental and jew bloodlines notorious for its viciousness and for being a federal and state informant and provocateur from Mentor Ohio – the Mamzer from Mentor – Bryan Reo followed his agreement to leave both White Supremacy and Christian-Identity for the second time then none of this litigation would be necessary. By engaging in this frivolous and abusive litigation on

both the state and federal level Bryan Reo ensures that Pastor Lindstedt and Lindstedt's Church must defend themselves by adding Bryan Reo co-conspirators and the corrupt governmental actors enabling Bryan Reo to persecute Pastor Lindstedt and Lindstedt's Church. Thus this litigation escalates out of control as the System fails. Bryan Reo gets further delusional and paranoid as Reo realizes that it is his own allies and regimeist handlers who will take Reo down as Reo – armed to the teeth and cowardly – readies itself for killing innocent people available within Reo's easy reach. Judging from some StormFront postings it is clearly obvious that Bryan Reo is far more dangerous to the school children at Mentor Elementary School than Reo is to the FBI, BATFE, and Lake County Sheriff's Department.

Nor in Reo's Response (Doc 46) does Reo bother to defend the City of Granby or its lawyers and officials and employees who sold him that bogus judgment for \$4000 as sanctions for daring to file a Missouri Sunshine Act Enforcement Action for \$1000. Where did Bryan Reo get the \$1000 to buy that "judgment"? Probably from Reo's state or federal handlers. All of which goes to show that Bryan Reo doesn't bother to defend those peripheral to Reo's work of subverting the old-line White Supremacist Resistance in general and Pastor Lindstedt in particular. Back in 2015 when Pastor Lindstedt counter-sued about 40 Bryan Reo counter-defendants including Bryan Reo's father in Reo v. Lindstedt 3:14-cv-05093 and then before the Lake County Courts Bryan Reo only bothered to defend its father and William (Baal) Finck and Finck's girlfriend Melissa Epperson and not the other co-conspirators. Likewise with Reo's Reply (Doc. 46). The only individual defended is Reo's South Dakota lawyer (who seems to be another antifa working with the FMI/ZPLC) Attorney Robert Konrad. Robert Konrad used to work for the law firm which handled Pastor Lindstedt's sister who was the executor of Lindstedt's grandmother's estate. It is believed that Reo cocontacted Konrad as part of a ZOG

“lawfare” group like FMI/ZPLC working for the Ollinger law firm and that the Ollinger law firm notified Bryan Reo (and other Reo conspirators) about the South Dakota inheritance. Konrad took these Ollinger files with himself to his new law firm and notified Bryan Reo and Kyle Bristow about the sister’s e-mail and personal information. Reo sent Pastor Lindstedt’s sister an e-mail which she refused to open and sent on to her lawyer defending her interests in Reo v. Lindstedt and Bessman 58CIV20-07 (Stanley County South Dakota). In short, Attorney Robert Konrad violated ethics rules and South Dakota law in an effort to steal Pastor Lindstedt’s inheritance and using Konrad to try to force Lindstedt to take back his inheritance given back to Lindstedt’s sister through a South Dakota law made so that lawyers could steal property by preventing their proposed victims from transferring property to others not party to abusive litigation. Since Attorney Konrad dares not appear to state his case as to why he shouldn’t be sued along with Bryan Reo for this abusive and never-ending litigation against Pastor Lindstedt and Lindstedt’s Church they got theys heads together and the result is Bryan Reo’s evasive and dishonest plea for this Court to not make Attorney Konrad and Konrad’s past and present law firms as Bryan Reo co-conspirator(s) (Doc. 46). In it there is no mention of South Dakota law.

Pastor Lindstedt’s sister used to work for the Newton County social services, not working for the baby-stealers (thank YHWH !!!) but to see that the poor white trash, the welfare sluts, the geezers & the retards got their welfare checks. She also worked as executor for the Lindstedt family estates. Pastor Lindstedt thought of transferring his properties to his Aryan Nations Church as it only has \$400 judgment against it by Bryan Reo but decided that simply deeding it back to his sister meant not having to go through title insurance and bringing up the Lake County judgment under appeal to her attention. Accordingly Attorney Robert Konrad as having worked for the law firm which handled her business in the past is using that knowledge on behalf of

Bryan Reo's deliberate attempts as both a ZOGbot and an annoyed Satanic homosexual mongrel abomination to destroy Pastor Lindstedt and Lindstedt's family for blowing the whistle on it and the rest of its lawyer ZOGbot friends responsible for the Charlottesville provocation.

Pastor Lindstedt endeavored to have Bryan Reo's and Lawyer Konrad's fraudulent and frivolous action dismissed but Attorney Konrad is allowed to make *ex parte* communications usually at night before the South Dakota courts and have them ruled upon summarily without Pastor Lindstedt getting to make a response the next morning. It is obvious that this South Dakota statute was made in order to allow lawyers to prey upon the general public and thus as a matter of policy both the members of the bar, judiciary and legislature should be liquidated (if non-white) and their entire estates forfeited and their treasonous blood corrupted and their offspring turned into geldings and walking wombs for their treason. However Pastor Lindstedt's sister doesn't want to do things that way and has hired an attorney who charged her a \$5000 retainer and who sends her a bill for \$500 per month to do nothing and Pastor Lindstedt has promised to not finish him and the rest of his law firm with all the rest so she could find a lawyer. However Pastor Lindstedt and Lindstedt's Aryan Nations Church has the religious and racial position that the legal profession represents Satan and Satan's government and thus as policy should be sent screaming to Hell – root, branch and tender twig – along with anyone who sides with them as well. The South Dakota court has set 31 August 2020 as a time to make the injunction permanent until the Bryan Reo Ohio cases are through. Since Pastor Lindstedt's elderly bed-bound illiterate domestic partner Roxie Fausnaught (who Bryan Reo sued out of sheer maliciousness in Lake County) died around 3:00 am on August 3, 2020 Pastor Lindstedt no longer has to devote time and attention to attending to her and will choose to challenge the entire basis for this litigation. Pastor Lindstedt has filed for leave of this Court to Amend his Complaint

to joiner Bryan Reo's lawyer Robert Konrad, Konrad's law firm, the Ollinger law firm so that they have something to lose for engaging in this baseless, fraudulent, and malicious litigation against Pastor Lindstedt and Lindstedt's sister. By freezing their assets and putting them on the litigation table then they will be more inclined to come to a settlement with Pastor Lindstedt and to dismiss the Stanley County litigation. See **Exhibit #1**: 7 Aug 2020 e-mail sent to Clerk of Courts re Reo v. Lindstedt & Bessman.

Upon the founding of this Mighty Evil Empire there was no such thing as "immunity" for corrupt federal, state or local governments and certainly none for lawyers using their access as officers of the courts to abuse legal process in destroying productive White People, and certainly to not destroy their pre-constitutional rights to free speech and religion and certainly not to freeze transfer of their real and personal property simply because some crooked lawyer wants it to destroy his enemies. Neither Bryan Reo nor his lawyer friends working to do "lawfare" have any immunity from being counter-sued. Nor do Reo's friendly courts nor regimes from being overthrown and liquidated by an incensed population regardless of the legal monkey-talk put out in venues of their own pretend jurisdiction.

On 28 April 2020 Bryan Reo's alleged Aryan homosexual lover, past employer, figurehead director of the Foundation for the MarketPlace of Ideas (FMI/ZPLC) (Doc 26-1) sent an e-mail to Bryan Reo and Pastor Lindstedt making an extortionary threat to render Pastor Lindstedt's sister "destitute". See **Exhibit #2** Tues. Apr 28, 2020 @ 8:07 "Reo always wins" e-mail.

You should just give Bryan Reo what he is owed and call it quits. He decisively won and you horrifically lost. You keep digging yourself a hole, and you will only drag others—like your dear sister—down with you. Do you want to make your sister destitute, too?

We all end up where we deserve in life. You possessing millions of dollars worth of land despite you being a deranged lunatic who spent time in a mental institution in relation to you allegedly

sodomizing your step-grandson is offensive to the Cosmos. (You being with Roxie is probably appropriate, though. You deserve an intelligent supermodel like her to be your significant other.)

If you truly believe that Reo is an “agent of ZOG,” then you should just surrender now, for you would have no chance against his people who are in the top echelons of society. Reo always wins. Always. He will do to you what Rome did to Carthage.

Thus this federal Court has ample reason to allow Pastor Lindstedt to proceed in his litigation with additional Bryan Reo counter-defendants associated with Bryan Reo, especially Bryan Reo attorneys working against Pastor Lindstedt and innocent third parties like Pastor Lindstedt’s sister who never even heard of Bryan Reo until she was sued and had to hire a lawyer

Regarding Attorney Brett Klimkowsky

The State of Ohio gave a Notice of Service to Bryan Reo Counter-Defendant Attorney Brett Klimkowsky Fellow Board Member of FMI/ZPLC. (Doc. 47) Attorney Klimkowsky is presently avoiding service not being man enough to personally pay up for his crimes as a misbehaving Spawn of Japheth & Pastor Lindstedt has no intention of hunting him down just yet.

On Nov. 9, 2018 Attorney Klimkowsky, formerly Bryan Reo’s lawyer in the Reo v. Lindstedt and other Reo litigation called Pastor Lindstedt twice, once for 45 minutes then for nearly two hours. Never asked was “What will you do to me for my fraudulent oppression of you working for Bryan Reo.” Never told was that Attorney Klimkowsky who took great pains to inform myself that he was a Czech not a Pollack was a mere Genesis Chapter 9 guest in the
