**DEFENDANTS' RULE 56(d) DECLARATION IN RESPONSE TO PLAINTIFF'S  
FRAUDULENT MOTION FOR SUMMARY JUDGMENT, ASKING FOR DISCOVERY  
TO BE EXTENDED TO COVER ALL PARTIES ONCE ESTABLISHED. MOTION TO  
CONSOLIDATE ALL FOUR CURRENT BRYAN REO FEDERAL LITIGATION INTO  
ONE OVERALL CASE.**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) respond with a F.R.Civ.Proc. Rule 56(d) Declaration asking that Discovery be Extended in order to Consolidate all the current Bryan Reo frivolous litigation against Pastor Martin Lindstedt in four now-separate federal cases, all brought up from the Lake County Ohio Court of Common Pleas. This Court has in a flurry recommended Dismissing Lindstedt's Counter-Claims against Ohio, against Bryan Reo Aryan homosexual fellow Executive Director on the Foundation for the MarketPlace of Ideas

(FMI) / ZOGbot Poverty [F]Law Center Attorney Kyle Bristow (Doc 53), and Bryan Reo co-conspirators in Granby Missouri and Missouri judges and officials and fellow likely FMI/ZPLC member Attorney Robert Konrad and Konrad's present and past law firms and the State of South Dakota (Doc. 52). Pastor Lindstedt made objections to Judge Parker's Recommendation regarding Ohio (Doc 50) which is in the mail, Pastor Lindstedt not having access to Electronic Case Filing as a non-lawyer. Pastor Lindstedt intends to make Objections to Judge Parker's Recommendations. (Doc. 52 & 53). So this leaves the state of discovery subject to whomever is left or who remains a party to this litigation.

Pastor Lindstedt was engaged in caring for a dying bed-bound illiterate elderly domestic partner Roxie Fausnaught (whom Bryan Reo maliciously sued in Lake County for being a director of Pastor Lindstedt's Aryan Nations Church) the past year. Roxie died the morning of 4 August 2020 and Pastor Lindstedt buried her on 13 August 2020. As a result Pastor Lindstedt has fallen behind in responding to Bryan Reo frivolous motions the past few months. Bryan Reo has deliberately violated F.R.C.P. 26 regarding initial disclosures, especially regarding damages, has refused to conduct pre-trial conferences according to L.R. 16, has with Attorney Kyle Bristow indulged in trying to do ex parte practice, was caught by this Court and admonished for doing so on March 30<sup>th</sup> in this and the Steffani Rossie Reo as [fake] plaintiff case. Bryan Reo has deliberately violated Local Civil Rule 37.1 expounded upon by this Court's Case Management Conference Order (Doc 37, pages #375. 376 Discovery Disputes). Bryan Reo has not sent out any e-mails (the preferred method of dealing with Bryan Reo the past decade) and Pastor Lindstedt has not publicly posted to Lindstedt's Church Christian\_Nationalist Forum his responses to Reo. (Pastor Lindstedt's favored way of dealing with Reo litigation matters for everyone to see.) These Reo responses via e-mail have especially dried up since Reo was caught

out by Lake County Magistrate Judge Andre and Judge Lucci filing another bogus Civil Stalking Protection Order (CSPO) on 4 June 2020 which Pastor Lindstedt brought to the attention of this Court as well. (Doc 42-1, pgs # 392-395). The only “discovery” which has been made available is on Pastor Lindstedt’s Church’s Forum, especially in the thread in which Bryan Reo made a public Quora post bewailing the Mrs. Reo deceived Reo by claiming to want to have children to get married and then when pending divorce claimed to want one or two then deceived Reo again after the proposed divorce was set aside. It seemed obvious that Bryan Reo married a Brazilian Sephardic jewess in order to pretend not to be a homosexual and that one or both parties broke some sort of deal. The other post was about seeing [fake] Plaintiff Steffani Rossi Reo – never referred by name but rather as “Mrs. Niggerlips” – jumping up and down like a fool trying to gain the attention of what Pastor Lindstedt thought were two homosexual mongrels the afternoon of 25 June 2019 in the hallway of the first floor of the Lake County Courthouse where Bryan Reo was engaged in a jury trial against Pastor Lindstedt and Lindstedt’s Aryan Nations Church. Mrs. Niggerlips’s tits were nothing to write home about but she sure did have a huge jewess beak. Pastor Lindstedt didn’t think that what Pastor Lindstedt thought was yet another homosexual mongrel was Bryan Reo’s father because the day previously Pastor Lindstedt overheard Bryan Reo telling what was likely his father to not show up because “Lindstedt is so vile.” Pastor Lindstedt had counter-sued Bryan Reo’s father in that litigation and Bryan Reo had evaded service upon his father then like Reo does to this very day. What Lindstedt took to be another homosexual mongrel wasn’t very old looking so it wasn’t until Bryan Reo said that Reo was going to sue on behalf of his father, Anthony D. Reo that Pastor Lindstedt figured it out. The thread which started two of these Reo cases was closed and locked down on the Church forum so nothing could be changed the minute Pastor Lindstedt was notified he was going to be sued:

There are the four current Bryan Reo v. Lindstedt federal lawsuits in the Northern District of Ohio. Pastor Lindstedt wants to consolidate all of them into one case:

*Bryan Anthony Reo v. Martin Lindstedt* 1:19-cv-02103-SO

*Bryan Anthony Reo v. Martin Lindstedt* 1:19-cv-02589-CAB ← **This One**

*Anthony Domenic Reo v. Martin Lindstedt* 1:19-cv-02615-JRA

*Stefani Rossi Reo v. Martin Lindstedt* 1:19-cv-02786-CAB ← This one as well

The Bryan Anthony Reo v. Lindstedt 1:19-cv-02589 and the Steffani Rossi Reo 1:19-cv-02786 case is being heard by the same Judge Boyko and Magistrate Judge Thomas Parker so these two cases are ripe for Consolidation. Pastor Lindstedt will file a Motion to Consolidate the cases for Bryan Reo v. Lindstedt 1:19-cv-02103 before Judge Solomon and Anthony Domenic Reo v. Martin Lindstedt 1:19-cv-02615 and use this filing as an exhibit.

This Rule 56(d) Declaration asking that Discovery be Extended in order to Consolidate all the current Bryan Reo frivolous litigation against Pastor Martin Lindstedt is also used for responding to the ORDER (Doc. 25) filed by Magistrate Judge Parker in the Steffani Rossi Reo 1:19-cv-02786 case. Two separate copies, each for each separate case will be mailed to be filed.

What Bryan Reo has done since April 2014 in both the federal and state courts is to refuse to render to Pastor Lindstedt his Rule 26 Initial Disclosures, especially regarding damages because Bryan Reo cannot demonstrate that he has been actually damaged. Reo in fact will state that he will not give Pastor Lindstedt any initial disclosures, respond regarding himself in any depositions Reo may set up, or admit to anything. The end result in the Reo v. Lindstedt 14-5093-MJW (WDMo) was that the Magistrate Judge Whitworth ruled that Bryan Reo has to

provide evidence that he was damaged \$75,000 worth to try to get \$10.75 million from Lindstedt. Even given 50 days to prove this Reo couldn't so the federal lawsuit by Reo was dismissed. (And Pastor Lindstedt had counter-claimed 40 Reo counter-defendants and that was dropped as well.) Then Reo refilled in Lake County Ohio courts and over the course of five years again refused to provide any initial disclosures but said that its "admissions" proved its case. Bryan Reo refuses to obey the rules of discovery but rather files motion after motion to strike or dismiss or for summary judgment bases upon its self-serving claiming of the rules. The Lake County Courts on the first day of trial 24 June 2020 allowed Pastor Lindstedt to rescind his "admissions" because of Bryan Reo discovery games. Bryan Reo has been whining since.

Pastor Lindstedt will finish answering Bryan Reo "discovery." Pastor Lindstedt has denied all Reo claims of alleged "homosexual incest" – the Reo household must be far wilder than a mere mamzeriary or claims of Mrs. Reo being a "transsexual prostitute" – Pastor Lindstedt just looked at her nose, not under her tail – or claims that Pastor Lindstedt has damaged Bryan Reo or Reo friends or family in any way. Pastor Lindstedt shall do this by posting the answers or "admissions" to the Church web page of whom Bryan Reo and Reobots are the most avid readers. Pastor Lindstedt has a number of questions, especially given the interactions between Bryan Reo and Bryan Reo counter-defendants that he wants answered. As it is, Pastor Lindstedt has found out quite a bit of information the past year, usually by watchdog groups like the FMI 501(c)(3) Tax form for 2017 but also as a result of Bryan Reo misconduct like on the CSPO bogus stalking order.

The genuine material facts necessary for a Bryan Reo Motion for Summary Judgment to succeed are absent or prove the frivolity of Bryan Reo's malicious case. Pastor Lindstedt said nothing about "homosexual incest" or "transsexual prostitution" or that homosexual relations had

taken place between known homosexual judges or lawyers 900 miles apart. Bryan Reo has made all this up, which is why Bryan Reo doesn't want to give out Initial Disclosures. In fact, any summary judgment should be awarded Pastor Lindstedt's counter-claims due to Bryan Reo malicious litigation without any merit whatsoever. Pastor Lindstedt has presented as exhibits to this Court that Bryan Reo wants to render Pastor Lindstedt "destitute" by abusing legal process to take Lindstedt's South Dakota inheritance. (Prey for My Suckcess, Doc 26-2 pgs 255-257 in 02589, Doc 11-2 pg 107-109 in cv-02786). In Doc 52-2 pg. # 516 filed 13 Aug 2020 Bryan Reo's counter-defendant Attorney Kyle Bristow threatens to make Pastor Lindstedt's sister "destitute" (working with Bryan Reo attorney Robert Konrad. So therefore there is plenty of discovery to be harvested once the parties privy to all these Bryan Reo cases are joinded and the cases consolidated into one huge overall file.

Consolidating all this Bryan Reo litigation into one case, settling which Bryan Reo counter-defendants can be sued, and once settling this proceeding with discovery for the consolidated cases would be the best policy to end confusion and come to the same end result in all these cases.

In any case, this is a Rule 56(d) Declaration in response to Bryan Anthony Reo v. Martin Lindstedt 1:19-CV-02589-CAB to Doc 48 ORDER of 23 July 2020 and Steffani Rossi Reo v. Martin Lindstedt 1:19-CV-02786 to Doc 25 ORDER of 27 July 2020. Two separate copies will be sent to this Court in one mailing. The very same Magistrate Judge Parker made the very same ruling on both cases being heard by himself and these two cases are thus easily consolidated into one as a starting point. This is also a Reply Brief to both of Bryan Reo's frivolous and dishonest dispositive Motions for Summary Judgment (Doc 49 dated July 23 on cv-02589) (and Doc 26 dated July 27, 2020 on cv-02786) given that there is plenty of genuine material fact disproving



Bryan Reo's allegations and claims made and thus Bryan Reo and Bryan Reo's wife are not entitled to judgment as a matter of law.

For the past decade Pastor Lindstedt has called Bryan Reo a crazed delusional Satanic homosexual mongrel agent provocateur abomination and Bryan Reo (and Reo's father, wife, Aryan homosexual lawyer lover on the FMI/ZPLC Board of Directors) has called Pastor Lindstedt a child molester and a pedophile over the Internet and since 8 April 2014 before the federal and state courts as well. None of this litigation should have ever been started. It is never-ending and will not ever end until either the parties or ZOG/Babylon is dead. Pastor Lindstedt is merely asking for the full due process of law in this matter. Judicial economy will be served by both parties engaging in proper discovery procedures in which what is asked is answered and then posted onto the Internet for the public to witness. Consolidation of these cases will make it more streamlined and easier to follow.
