**DEFENDANTS' OBJECTIONS TO MAGISTRATE PARKER'S REPORT AND
RECOMMENDATION (Doc 52) DENYING PASTOR LINDSTEDT'S MOTION FOR
LEAVE TO AMEND PLEADINGS (Doc 45).**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to timely make Objections to Magistrate Judge Parker's (Doc 52) Report and Recommendation to DENY Pastor Martin Lindstedt's (Doc 45) Motion for Leave To Amend Pleadings. The magistrate judge has made the determination that these Amendments to the present case would be "futile" and might cause further delay then he recommends that the Court DENY Lindstedt's motion for leave to amend. Pastor Lindstedt makes an Objection for the following reason(s) and thinks that the proposed new parties should be the ones to file Rule 12 (b)(2) & (6) Motions defending their actions in conspiracy with Bryan Reo, not this magistrate judge.

Background. The corrupt City of Granby Defendants in order to keep Pastor Lindstedt from peacefully disputing with them their corrupt and thieving practices decided to make out a bogus “domestic protection order” on behalf of their Granby City Clerk Lawna Price and City Collector Carra Jo Coffey. The crooked Newton County judges GRIDS-Grindr Gregg Stremel and ‘The Monster’ Kevin Lee Selby without any valid jurisdiction under Missouri law granted them that protection ORDER and then refused to allow Pastor Lindstedt an appeal of that bogus protection order. Then Assistant Missouri General Caleb Wagner at the behest of Missouri Attorney General (and present U.S. Senator pretending to be for “free speech”) Josh Hawley defended the two corrupt Newton County judges. So Bryan Reo, who incessantly in its stalking and “lawfare” actions against Pastor Lindstedt and Lindstedt’s Church claims to suffer emotional damages bought for \$1000 the fraudulent judgment for \$4000 against Pastor Lindstedt. Pastor Lindstedt confronted Councilman Ashley Edgemon – who won in the June 2020 race for South Ward City Councilman then ran off to Florida so that Pastor Lindstedt would be denied his City Council Seat (litigation pending) admitted to signing the purchase with the rest of the Granby City Council the night of Oct. 14, 2019. This caused Pastor Lindstedt distress. The next day without any valid lawful reason the City of Granby bulldozed the grass and small trees of Pastor Lindstedt’s and Roxie Fausnaught’s and niece and nephews property.

Pastor Lindstedt at the time considered shooting these worthless thieving evil swine but decided to cool down and return his South Dakota inheritance to his sister before shooting anyone.
