# DEFENDANTS' OBJECTIONS TO MAGISTRATE PARKER'S REPORT AND RECOMMENDATION (Doc 53) RELEASING BRYAN COUNTER-DEFENDANT ATTYORNEY KYLE BRISTOW FELLOW FMI/ZPLC "WHITE SUPREMACIST" LAWFARE AGENT PROVACATEUR FROM COUNTER-SUIT AGAINST PASTOR LINDSTEDT AND LINDSTEDT'S ARYAN NATIONS CHURCH

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to timely make Objections to Magistrate Judge Parker's (Doc 53) Report and Recommendation releasing long-time suspected homosexual lover and fellow Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty Law Center (ZPLC) Board member (See Doc. 25, Doc 26-1 IRS Short Form 501(c)(3) Tax Form page 251-254 19 March 2020) and long-time "White Supremacist" pretending lawyer and still on the edges of the Movement Attorney Kyle Bristow. Attorney Kyle Bristow has been in intimate contact with non-white antifa "white supremacist" since at least 2014 and likely before and has

been oppressing through "lawfare" Pastor Lindstedt and Lindstedt's Aryan Nations Church since early 2016 when officers of the Ohio courts Attorneys Reo, Bristow, and Brett Klimkowsky decided to set up FMI/ZPLC to act as a federal government agents provocateur to infiltrate, harass, and oppress under color of state and federal law the genuine racial Resistance Movement in general and Pastor Lindstedt and Lindstedt's Aryan Nations Church. This Court by recommending that sundry Bryan Reo "counter-defendants" who happen to be officers of their own courts be dismissed from counter-litigation under sundry pretexts is morally and legally no different than every failed totalitarian and foreign authoritarian regime in allowing its secret political police & agents provocateur and employees & officials to run wild in an official and quasi-official capacity in making the Collapse and the [dis]organized Revolution both inevitable and the consequences bloody. This Court is legally, politically and morally wrong in its Recommendations and so Pastor Lindstedt does Protest and Object.

This Recommendation was mailed out on the day it was ORDERED on 12 August 2020 and received when Pastor Lindstedt picked up his mail at the foot of the hill on 22 August, leaving not much time for Pastor Lindstedt to object via two-day Priority Mail. Pastor Lindstedt requests that the courts of the Northern District of Ohio consolidate all of the Bryan Reo litigation against Pastor Lindstedt, accept Lindstedt's Rule 56(d) Declaration, force Bryan Reo and Reo counter-litigants (if any are left) to provide Rule 26 Initial Disclosures whereupon Pastor Lindstedt will finish up with his "[Non]Admissions" of calling Bryan Reo a Satanic homosexual mongrel ZOGbot abomination for the past decade or so in response to Bryan Reo, Bryan Reo's wife and father and homosexual pencil-necked geek Aryan whigger lover Lawyer Kyle Bristow calling Pastor Lindstedt a child molester and pedophile – and convicted no less. Within a year or so if the Mighty Evil Empire of ZOG/Babylon is still around and hasn't

devolved into Ten Thousand Warlords over 10-20 million ex-whiggers there can be a jury trial in Cleveland (if the North Perry Nuclear Power Plant exists) over a selected jury of either negros or surviving ex-gliberal whiggers. In any case, Pastor Lindstedt now not having any South Dakota inheritance and now that Roxie Fausnaught's \$1200 per month VA check dried up when she died earlier this month and it will take a while before Pastor Lindstedt gets his \$700 SSI Disability check (unless sale of stock in Lake County/Stanley County/Newton County Geldings & Walking Wombs picks up) Pastor Lindstedt would appreciate being able to participate in electronic filing. That way it will be more than 10-15 minutes before Bryan Reo files some legalistic crap against Pastor Lindstedt's filing arriving via the U.S. [snail]mail and being docketed having got an email or reading it on Pastor Lindstedt's Aryan Nations Church's Christian\_Nationalist forum.

Bryan Reo has filed four actions before the Lake County Courts which Pastor Lindstedt removed back when he had money to this federal district court. There are the four current Bryan Reo v. Lindstedt federal lawsuits in the Northern District of Ohio:

# II. This Court's Faulty Background

Attorney Kyle Bristow has been working with Bryan Reo well before they founded FMI/ZPLC in early 2016 and has been working with Bryan Reo up until this latest moment and still is working with other agents of the FMI/ZPLC in order to bring about the same post-Charlottesville results of infiltration and subversion of the White Supremacist Resistance. How Pastor Lindstedt and Lindstedt's Aryan Nations Church has been affected – how they relate to

him and his Church – is through this "lawfare" of Bryan Reo and Reo lawyers in Ohio and South Dakota like Attorney Robert Konrad. Attorney Kyle Brtistow – located in Michigan but licensed in Ohio – has drafted up much of Bryan Reo's litigation over the past and now present year. They have been in constant coontact with each other as Document 28 "Joint Report of Planning Meeting held between Reo and Bristow' attests 10 April 2020; Doc 36 of 15 May 2020 with emails sent between Reo, Bristow & Lindstedt, Doc 36-1, Exhibit #1, of the Monday Feb 24<sup>th</sup> preconference Bryan Reo was supposed to set up but didn't. There is the April 28, 2020 e-mail in where Lawyer Bristow threatens Pastor Lindstedt's sister with "destitution" for accepting back Pastor Lindstedt's inheritance in conjunction with Bryan Reo's efforts with probable FMI/ZPLC SD lawyer Konrad. See Doc 52-2 page 516. There is much much more from 2016 to an 2017 telephone call to 2019 drafting up a Motion for Pre-Trial interest and lawyers fees along with attorney Brett Klimkowsky. Attorneys Bryan Reo and Kyle Bristow have been working hand-inhand & ass-to-mouth against Pastor Lindstedt and Lindstedt's Aryan Nations Church since from likely before 2016 until this very day both as ZOGbots and deranged Satanic homosexuals. Or so Pastor Lindstedt alleges and wants to prove before a jury of whatever exists at time of trial.

Bryan Reo dare not attend a Klan or DSCI Church meeting in real life in the areas of peak activity for the Old Resistance in Missouri and abouts for fear of disappearing. So Reo must infiltrate over the Internet from liberal NorthEastern Ohio which is the opposite of Ozark community values. This is why Pastor Lindstedt has sued the Lake County Courts, Judge Patrick Condon, the federal government using Bryan Reo and the States of South Dakota. Any Ohio or South Dakota court which drags an Aryan Nations pastor and Church 900 miles to be tried by a non-white lynch mob jury and crooked judge for a plain statement of religious racial principles that a Satanic homosexual mongrel ZOGbot abomination like Bryan Reo is what it is and then is

punished for those religious racial principles in defiance of their fraudulent paper guarantees needs to have their non-white population exterminated and their surviving whigger population enslaved and the federal imperial regime abolished. Today there is fighting before this federal court; tomorrow implementation of the resulting racial and religious civil warfare.

Because Bryan Reo and Brett Klimkowsky and Kyle Bristow pretended to be legitimate "White Supremacist" "lawfare organizations FMI/ZPLC over the years they could not be directly seen going against Pastor Lindstedt and Lindstedt's Aryan Nations Church from 2016-2018. Today they whine about Pastor Lindstedt's racism and "homophobia" against them. This Court itself admits to a connection between Bryan Reo and Kyle Bristow but uses Talmudic logic to claim both lack of personal jurisdiction and failure to state a claim pursuant to Rules 12(b)(2) and (6) according to the Federal Rules of Civil Procedure.

# III. Alleged Lack of Personal Jurisdiction Fed.R.Civ.P. 12(b)(2)

This Court goes through a lot of legal logic-chopping to arrive at the desired conclusion that Attorney Kyle Bristow hasn't done anything regarding this case sufficient to generate any personal jurisdiction for Pastor Lindstedt's counter-claim. Yet Bristow working with Bryan Reo held an ex-parte meeting and reported on this meating, cf. Document 28 "Joint Report of Planning Meeting held between Reo and Bristow" filed 10 April 2020. Thus any lying claims or an affidavit (ECF Doc 25 at 21) that Bristow "has not have any active cases pending in Ohio" is undone by Bristow's Document #28 filed a month later. In fact Doc 28, signed jointly by Bryan Reo and Kyle Bristow and mentioning the fraudulent Civil Stalking Protection Order (CSPO) filed by Bryan Reo which failed on Page 264 proves that Attorney Bristow has been conspiring with Reo to file fraudulent documents before both the Lake County and this federal court. Doc. 28 proves that Attorney Bristow has been working rather closely with Bryan Reo to destroy

Pastor Lindstedt and Lindstedt's Church, and thus this Court has personal jurisdiction, like it or not. So by jointly filing Doc. 28 before this Court Bristow has proven that he is under this Court's jurisdiction. Since all these claims are over what happened over the Internet anyways, Bristow working in Michigan to facilitate Reo's frivolous lawsuit in Ohio over what was said by Pastor Lindstedt on Lindstedt's Aryan Nations Church in Granby Missouri then there probably isn't any real jurisdiction by anyone over anything if that is to be the standard set by this Court. If this Court is to take that approach in determining jurisdiction then the end result is that Pastor Lindstedt and Lindstedt's Church is justified in spreading the non-white affecting Covid-19 to densely packed and diverse Ohio and in chernobyling their nuclear power plants because this Aryan Nations pastor and Church were annoyed at being dragged 900 miles away to face a Lake County lynch mob jury and crooked judge just for calling an evil mamzer faggot ZOGbot names.

On pages 8-11 this Court engages in Talmudic logic-chopping to explain why Attorney Bristow in un-natural and long-time conjunction with Bryan Reo to abuse legal process against Pastor Lindstedt and Lindstedt's Church has somehow managed to evade jurisdiction before an Ohio federal court even though it is precisely because Pastor Lindstedt and Lindstedt's Church are being victimized by Ohio state and federal courts that Reo and Reo lawyers in Missouri and South Dakota are using this claimed jurisdiction to go after Pastor Lindstedt's inheritance. If the Ohio state and federal courts do not have jurisdiction over Bryan Reo's family and lawyers friends for Pastor Lindstedt and Lindstedt's Church to make a counter-claim given Bryan Reo frivolous litigation then whence arises jurisdiction for Bryan Reo and Reo friends and family to go after Pastor Lindstedt and Lindstedt's Church?

Pastor Lindstedt hereby pro-offers the "Pet Sematary" Doctrine of jurisdiction. Some barriers are not meant to be crossed, like between the living and the dead and between religious

practice and free speech between the Ohio state and federal courts and a Revolutionary Racial Religious Church and its pastors. But when this jurisdictional barrier like a membrane or Plane of Existence is broken, like between Bryan Reo vs. Pastor Lindstedt, or the Texas Rangers or drug cartels over the border or Genghis Khan's ambassadors before the Baghdad's Caliphate or in Steven King's Pet Sematery, then the consequences can be dire, like invasions, or exterminations of millions or quantrillizations or merely the evil dead running amok and stinking up the place. Once this is done it cannot be undone.

Hence the Bryan Reo counter-defendants or third-party practice or whatever title this Court wants to give them should face consequences for their bringing up these claims in the first place. This Court seems to favor not "rule of law" but "rule of lawyer."

### IV. Fed.R.Civ.P. 12(b)(6) – Failure to State a Claim

A. Defamation. Bryan Reo, Bryan Reo's wife and father, and Bryan Reo's lawyers like to constantly claim that Pastor Lindstedt is a "pedophile" and "child molester" and sometimes a convicted one at that. Since Bryan Reo and friends have called Pastor Lindstedt such and Pastor Lindstedt is not any such thing – much less convicted then Pastor Lindstedt thought it was entirely correct to name these mongrels and homosexuals and ZOGbots as such over the years. This Court itself allows that Bristow has committed libel per se and that Lindstedt has arguably stated a valid defamation *per se* claim against Bristow (Doc. 53, p501). And that this Court doesn't recommend that this claim be dismissed pursuant to Fed. R.Civ.P. 12(b)(6). However, because this Court recommends that the federal court dismiss because of an alleged lack of jurisdiction under 12(b)(2) that Attorney Bristow be given a two-fer and this case be dismissed because it is "not even necessary that the Court consider this alternative." How convenient.

Whenever Pastor Lindstedt does have an admittedly valid claim it is to be dismissed because this magistrate judge gave Attorney Bristow a win under a different pretext.

**B. Civil Conspiracy.** Not withstanding Attorneys Bryan Reo's and Kyle Bristow's proven coonections as "white supremacist" "lawfare attorneys" working in tandem against Pastor Lindstedt and Lindstedt's Church cf. Doc. 28 Joint Report and various sundry e-mails as exhibits this magistrate judge claims that Pastor Lindstedt has failed to "adequately allege" that the two are acting in conspiracy against Pastor Lindstedt, Lindstedt's Church and Lindstedt's sister.

This magistrate judge should not be the tryer of facts but rather a jury — even of Ohio negroes and gliberal whiggers — should have that role. Then, as in Lake County Ohio and the State of Ohio acting like Sodom & Gomorrah and being destroyed accordingly, Pastor Lindstedt and Lindstedt's Church can in turn act accordingly. Pastor Lindstedt has not only alleged sufficient facts, but Bryan Reo and Kyle Bristow through their Document 28 — Joint Report dated 10 April 2020 have proven that both are acting in concert as are numerous e-mails of Bryan Reo and Kyle Bristow brought into the record and not addressed by this magistrate judge.

### V. Objections

Neither Pastor Lindstedt nor Pastor Lindstedt's Aryan Nations Church has initiated this Bryan Reo frivolous and fraudulent litigation. Rather Bryan Reo and Reo family and lawyer friends working for the state and federal governments have initiated this "lawfare" under their own fraudulent jurisdiction and Pastor Lindstedt and Lindstedt's Church have fought this before their own courts without jurisdiction. This "lawfare" is nothing other than political racial and religious civil warfare under color of "law" engaged in by lawyers. Pastor Lindstedt never had the option of refusal to fight this fight as YHWH commands that His Servants of YHWH's Servant Nation of Aryan Christian Israel must fight with Satan's Spawn both real and adopted.

And so Pastor Lindsted has counter-sued Bryan Reo and Bryan Reo family and friends before the very state and federal criminal-regimeist courts. Whatever games they play to their own advantage before theysselfs means nothing, rather this fight must be waged so that when the Collapse comes and it is time to eliminate the wicked and those who do not belong then there will be no place for this government or its courts to hide amongst the surviving Aryan Christian Israelite Peoples.

Pastor Lindstedt does expect no justice from this Court but by raising objections is merely raising the ante in Gotterdamnarung Collapse Poker. The State of Ohio by refusing to rein in Bryan Reo has raised two nuclear reactors instead of one by refusal to be judged by this Court. Attorney Kyle Bristow wants to keep on playing "White Supremacist" lawfare agent for the false-flag operations and thus thinks that he will remain unknown before the very fools he seeks to infiltrate for his behavior. Attorney Brett Klimkowsky pissed down his leg and refused to be served, as did the U.S. Attorney for the Northern District of Ohio. Let them be judged.

Pastor Lindstedt's political and religious objectives are the extermination of the Mighty Evil Empire along with their parasitic jews and non-whites, reduction of the population to 10-20 million ex-whiggers ruled by 10,000 local theocratic military dictatorships (Ten Thousand Warlords) under Aryan Christian Israelite Biblical law. This case and these Objections is a mere necessary speed bump to that inevitable goal given the Collapse and Great Tribulation.
