**DEFENDANTS' OBJECTIONS TO MAGISTRATE PARKER'S REPORT AND
RECOMMENDATION (Doc 56) THAT THE COURT GRANT THE MOTION TO
DISMISS FILED BY LAKE COUNTY OHIO JUDGE PATRICK CONDON AND THE
LAKE COUNTY OHIO COURTS OF COMMON PLEAS**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to timely make Objections to Magistrate Judge Parker's (Doc 56) Report and Recommendation that the Court grant the Motion to Dismiss filed by the lawyers for Lake County Ohio Courts and Judge Patrick Condon. Pastor Lindstedt received this Report in the mail on 21 Aug. and has been filing his Objections for this and for this Court's other Reports recommending dismissal, Doc. 50 against Ohio; Doc. 52 against being able to amend pleadings to join City of Granby, Newton County judges, and the State of Missouri and the State of South Dakota, Reo FMI/ZPLC Attorney Robert Konrad,

Konrad's past and present law firms; and Doc. 53 recommending dismissal against long-time Bryan Reo Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center figurehead & suspected Aryan homosexual lover Attorney Kyle Bristow who like the notorious Satanic homosexual mongrel ZOGbot abomination Bryan Reo, Bryan Reo's mongrel father and Sephardic Brazilian jewess wife is addicted to calling Pastor Lindstedt a pedophile and child molester – and a convicted one at that.

Pastor Lindstedt's suing the corrupt Lake County Ohio Courts of Common Pleas and their Judge Patrick Condon involves counter-punching in this frivolous and malicious Bryan Reo lawsuit. Every single time Bryan Reo sues Pastor Lindstedt and Lindstedt's Aryan Nations Church since this "lawfare" began in April 2014, Pastor Lindstedt countersues Bryan Reo co-conspirators who are working with and for Bryan Reo as long-time antifa agent provocateur for the criminal regimes at the local, state and federal level. Bryan Reo, along with the entire FMI/ZPLC organization as displayed before this Court with Doc. 26-1 pgs 251-254, was responsible as fake "white supremacists" to deliver a riot at Charlottesville and working with the local police criminals delivers a provocation which can be used against the conservative Republicans and President Trump. So Pastor Lindstedt whenever roped into these Bryan Reo frivolous lawsuits always counter-sues Bryan Reo counter-defendants and make them have to spend time and resources in saying that they are above the law rather than quashing their pet homosexual mongrel agent provocateur. Pastor Lindstedt then puts most of it up on his Aryan Nations Church's Christian_Nationalist forum stirring the fires of the inevitable 2d Civil War. It would be best if the Lake County Courts and Judge Condon simply disbarred and quashed Bryan Reo, Kyle Bristow and Brett Klimkowsky. Instead, they got every single wannabe phineas priest, prion-poisoner, sovereign-citizen and garden-variety whigger supremacist looking to spread the

wonderful Covid-19 ZOG-virus which affects rural whites the least, destroy the lives of non-whites and sterilize the off-spring of criminal-regiment whiggers and to chernobylize the decaying Ohio nuclear power plants so feckless that they hired a crazed delusional homosexual like Bryan Reo when merely doing a web search could have revealed Bryan Reo's past history. Indeed, Bryan Reo blames Pastor Lindstedt for getting Bryan Reo fired from the North Perry Nuclear Power Plant as an "internal security risk" for keeping up all the "White Supremacist" ravings of this delusional homosexual mongrel since 2003 when it got kicked out the first time. If Bryan Reo had done as agreed and left just after Halloween in 2010 when Pastor Lindstedt figured out that "SwordBrethren"/ "SoredMamzer" was Bryan Reo the Mamzer From Mentor and not got into the FMI/ZPLC and Charlottesville then Bryan Reo could have claimed to have been an impressionable non-white caught up in foolishness nearly 20 years ago who has changed and wants to lead a quiet life. Instead Bryan Reo initiates these frivolous lawsuits on behalf of itself and its wife and its father claiming that Pastor Lindstedt is making fun of these mongrel and jew idiots while they keep on calling Pastor Lindstedt a child molester and the States of Ohio, Missouri and South Dakota and their courts and lawyers claim that they are above the law and cannot be sued in their own courts – thus giving a lie to their pretense to "rule of law" as opposed to lawyers.

Pastor Lindstedt was dragged 900 miles from Granby Missouri to Lake County Ohio to be tried along with his Aryan Nations Church – which was not allowed to be defended by Pastor Lindstedt (and his domestic partner Roxie Fausnaught who was elderly bed-bound and illiterate and never did anything to Bryan Reo) – and was tried before a Lake County Court of absolutely no jurisdiction well outside the Ohio Statutes of Limitation after losing a federal case before a lynch mob of a female African and seven gliberal whiggers where the crooked judge (Condon)

allowed Bryan Reo to “cherry-pick” out of context portions from Pastor Lindstedt’s Church’s web pages, refused to allow Pastor Lindstedt to present his evidence, allowed Reo to call Lindstedt a “child molester” before the biased jury which heard “Aryan Nations” was one of the defendants, etc. The overwhelming issue is whether a local state court can try an Aryan Nations pastor and Church for name calling years before of a non-white public figure within the White Supremacist Movement before a biased jury and crooked judge and then have that matter hold up given that neither Pastor Lindstedt nor his Church has funds or property to seize and to grant “Civil Stalking Protection Orders” based upon lies by Bryan Reo from Lake County Ohio to Pastor Lindstedt residing 900 miles away in a different state. Can a crazed delusional Satanic homosexual mongrel working as a long-time agent provocateur put an Aryan Nations pastor and his Church through frivolous and malicious case after case, costing him his inheritance and tens of thousands of dollars and engaging most of his active time for years without hope for an ending because regrettably both sides are supposedly under the power of a consolidated Mighty Evil Empire now on the way out. This Court says “yes” the counter-suits by Pastor Lindstedt and Lindstedt’s Church should be dismissed, especially against lawyers and criminal regimes. Pastor Lindstedt says no, and makes these objections.

The Church of, for, and by the Aryan Christian Israelites has existed since Adamic man’s creation some 6-7 thousand years ago as such are the only ones with souls. The right and duty to fight Satan and Satan’s children predated Satan’s government’s founding and its paper constitution “rights” and courts. Our beliefs state that there will be a Great Tribulation / Collapse and our politics mandate that we use that Collapse to set up local theocratic military dictatorships – The 10,000 Warlords – over 10-20 million ex-whiggers. Thus the current order must be

destroyed for our New Order to arrive. The current Reo litigation involving corrupt courts acting outside their jurisdiction means a clear road to our own tribunals acting in response.

Rooker-Feldman Doctrine vs. "Pet Sematary" Doctrine of Jurisdiction

This Court mentions in great detail the *Rooker-Feldman* Doctrine claiming that this court lacks jurisdiction under the *Rooker-Feldman* Doctrine that the federal courts have made up to allow local and state courts to run wild in violating the rights of Pastor Lindstedt and Lindstedt's Church in the First Amendment of a national regime which claims jurisdiction over all. Neither Pastor Lindstedt nor his Aryan Nations Church recognize the jurisdiction of the Lake County Ohio court (nor the Mentor Municipal Court whence the litigation against Pastor Lindstedt's Church originated by Bryan Reo started and which refused that spurious jurisdiction which Lake County usurped a few months later without Bryan Reo amending his complaint).

Neither Pastor Lindstedt nor his Aryan Nations Church attempt to "circumvent" the *Rooker-Feldman* Doctrine as this Court claims on page 5, para 2 Doc 56 pg 526 by "claims based upon alleged violations of federal and state law," i.e. the First Amendment but rather the "Pet Sematary" Doctrine of jurisdiction. The "Pet Sematary" Doctrine of jurisdiction holds that if a local, state or federal court breaks the written or unwritten jurisdictional boundaries preventing those of vicious intent from preying upon others well outside their boundaries – like the boundaries between the living and the dead as in Stephen King's "Pet Sematary" in which the dead were buried in "sour ground" and then came back to life – so too can a different court – either this federal court or an ecclesiastical court of Pastor Lindstedt's choosing -- give equitable relief to the aggrieved. Since the right and duty to defend Pastor Lindstedt's Dual-Seedline Christian Identity Faith and Church as an Aryan Christian Israelite predates both the Ohio and Federal Courts then this ecclesiastical court – which ruled that Lake County was to be

“quantrillized” for violation the 1865 First Civil War Armistices and the decaying North Perry Nuclear Power Plant “chernobylized” for the Lake County Court’s and Judge Condon’s violation of the First Amendment of the Bill of Goods over a pastor and church not under their valid jurisdictional dominion should be done by default unless this federal Court chooses a wiser path.

This magistrate court judge claims that Pastor Lindstedt’s First Amendment claims are “inextricably intertwined with the state court judgment”, cf. Doc 56, pg 526, para 3. However such a judge-made Gordian knot can be severed by the axe laid to the root given civil war.

Regarding Pastor Lindstedt’s counter-claim against Judge Patrick Condon, this judge didn’t have to be corrupt in acting sans jurisdiction in giving Bryan Reo his fraudulent lawsuit against Pastor Lindstedt and Lindstedt’s Church. Judge Christian Andre along with Judge Eugene Lucci likewise heard *ex parte* a Civil Stalking Protection Order against Pastor Lindstedt fraudulently initiated by Bryan Reo a second time without any valid jurisdiction in *Reo v. Lindstedt* 20CS000520 and upon questioning found that Bryan Reo was deliberately making fraudulent claims even though Pastor Lindstedt could not afford to go 900 miles to challenge this Reo lawsuit which would take away Pastor Lindstedt’s Second Amendment rights. Pastor Lindstedt filed this as Doc. 42-1 on 16 June 2020. This shows that Reo makes false claims relying on Pastor Lindstedt not being able to fight him before the corrupt Lake County Courts. Judge Lucci found out that Bryan Reo and his lawyer Brett Klimkowsky attempted similar fraudulent practice before the Ohio federal and Lake County Courts in the case of National Auto Division out of New Jersey. However whether the Lake County judge is corrupt like Condon or consciencious like Lucci either way Lake County has no jurisdiction to try Lindstedt or Church.

Younger Abstention

This magistrate in his efforts to stifle Pastor Lindstedt's counter-claims against the Lake County Ohio Court of Common Pleas and the corrupt Judge Patrick Condon goes on to claim that because Pastor Lindstedt (but not Pastor Lindstedt's Aryan Nations Church which was sued and judgment made against for \$400 in compensatory and "punitive" damages because of lawyer-made patents of nobility claiming that it is necessary to hire agents / attorneys of the very Satanic Babylonian criminal regime to fight with their own Satanic homosexual mongrel agent provocateur Bryan Reo and Reo's pencil-necked Aryan geek suspected homosexual lover of the FMI/ZPLC) has four appeals before the Eleventh District Ohio Court of Appeals that this federal court should hold off on this case, at least for now. Two of these appellate cases are from Bryan Reo wanting "pre-trial" interest and lawyers fees for itself, and Reo counter-defendants Kyle Bristow and Brett Klimkowsky and interest even though Bryan Reo asked for six or eight continuances from August 2016 until the very first day of trial on 24 June 2019.

Because there still is a federal government and a federal judiciary then Bryan Reo and the Lake County Courts and Judge Condon claim that they had jurisdiction to hear Bryan Reo never-ending litigation against Pastor Lindstedt and Lindstedt's Church and to seize Lindstedt's and Church property in Missouri and South Dakota then that is the only reason that there is this litigation. If there was no federal criminal regime nor federal courts then Lake County Ohio and Judge Condon could listen to local cases brought by Bryan Reo and Reo wouldn't be able to play White Supremacist or Christian Identity other than before an audience of fellow likeminded mamzers, jews and homosexuals. It is because there is a federal Mighty Evil Empire in existence that it becomes necessary to Chernobyl the Lake County nuclear power plants and turn Lake Erie into the Dead Sea as was similar to what was done with Sodom and Gomorrah to show that no state or local court should exceed its jurisdiction and reduce the ZOGland into 10,000 Warlords.

12(b)(6) – Failure to State a Claim

This court then goes on to claim that Lindstedt's attempted (but obviously falling quite short before this court) is a 42 USC 1983 claim. That Pastor Lindstedt must prove that: 1) he was denied a right secured by the Constitution or the laws of the United States and 2) the deprivation was committed by one acting under color of law. Doc. 56 pg 530. To which obtuse Talmudic logic-chopping the obvious response is that the First Amendment of the Bill of Rights to the Constitution should hold that Pastor Lindstedt should be able to call out a crazed delusional Satanic homosexual mongrel ZOGbot abomination and its FMI/ZPLC lawyer friends calling Pastor Lindstedt a child molester a decade ago over the Internet and not be dragged into a corrupt shithole jerkwater Sodom & Gomorrah-type court 900 miles away before a jury comprised of niggers and gliberal whiggers run by a crooked judge pretending to have any jurisdiction whatsoever and deprived of his life savings and inheritance when no damages can be proven at all. And that this deprivation has been committed by a pack of mangy thieving crooked lawyers pretending to run a regime kort of proper jurisdiction. And that the proper godly response should be to exterminate the non-whites, sterilize and enslave the salvageable whites, and to turn the offending region into a wasteland so that they have other interests than in starting and losing a second civil war. Seems to Pastor Lindstedt that he has indeed stated a claim.

Judicial Immunity

This is a judge-made claim in which those who are supposed to be upholding and defending the law claim to be above the law. Pastor Lindstedt and Pastor Lindstedt's Church agrees that those who claim to be immune from lawsuit are indeed protected by the power of the state – as long as that state exists or is strong enough to be proof against retaliation. Judge Condon's claim is merely one of an agreement of a suspended imposition of sentence and thus

the equivalent of a guilty plea. Additionally even this court holds that Judge Condon has immunity if he acted in the absence of jurisdiction. Since the gravamen of this case is that neither Lake County Courts nor Judge Condon had any authority, dominion or jurisdiction over Pastor Lindstedt and Lindstedt's Church then neither have any immunity to begin with, much less once their regime or population is destroyed.

Lake County CCP is not *Sui Juris*

This magistrate judge makes the same argument that the National-Socialist German Workers Party / Regime or the Caliphate of Baghdad or any other extinct regimes have made – that they cannot be held to account as long as their regimes exist or are strong enough to prevent retaliation. This might be the case today and tomorrow but not for much longer.

Pastor Lindstedt's political and religious objectives are the extermination of the Mighty Evil Empire along with their parasitic jews and non-whites, reduction of the population to 10-20 million ex-whiggers ruled by 10,000 local theocratic military dictatorships (Ten Thousand Warlords) under Aryan Christian Israelite Biblical law. This case and these Objections is a mere necessary speed bump to that inevitable goal given the Collapse and Great Tribulation.
