**DEFENDANTS' MOTION TO AMEND PLEADINGS TO JOIN ADDITIONAL BRYAN
REO CO-CONSPIRATORS / COUNTER DEFENDANTS ACCORDING TO THIS
COURT'S CASE MANAGEMENT CONFERENCE ORDER (DOC 37)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to make this Motion to Amend Pleadings in order to join additional Bryan Reo co-conspirators / counter-defendants / third party defendants as in this Court's 15 May 2020 Case Management Conference Order. This will of course make Bryan Reo's latest frivolous Motion for Leave to Move for Summary judgment on behalf of itself and its wife (Stefani Rossi Reo v. Martin Lindstedt 19-cv-02786) even more ridiculous and foolish than usual. Bryan Reo has been stalking Pastor Martin Lindstedt and Lindstedt's Aryan Nations Church for 11 years now and suing in federal and Lake County courts

since 2014 and has branched out in its harassment to Granby Missouri and against Pastor Lindstedt's inheritance in Stanley County South Dakota using corrupt lawyers affiliated with Bryan Reo's Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) and under this litigation which is ongoing solely because of Bryan Reo refusing to allow Pastor Lindstedt and Lindstedt's Church to be left alone in peace. These additional Bryan Reo parties should not be allowed to skulk in the shadows and should be dragged out to public scrutiny through this Bryan Reo litigation. There are the four current Bryan Reo v. Lindstedt federal lawsuits in the Northern District of Ohio:

In each of them Bryan Reo refuses to render the Rule 26 initial disclosures, writes up pages and pages of discovery / admissions over what Pastor Lindstedt published openly on Pastor Lindstedt's Church's web pages about public figure Bryan Reo and Reo's lawyer friends of the FMI/ZPLC, then files motion after motion to strike, for summary judgment while with Attorney Kyle Bristow refusing to allow Pastor Lindstedt any discovery except at tremendous expense and of dubious information. In fact the best place to go if one wants to research Bryan Reo and Reo false-flag operations is to Pastor Lindstedt's Aryan Nations Church's web page because there is where Bryan Reo, FMI/ZPLC and such court records and information are stored.

CITY OF GRANBY ADDITIONAL DEFENDANTS

Pastor Martin Lindstedt has been fighting with the City of Granby for years. Within this past month in running for South Ward City Councilman against the next-door neighbor Ashley

Edgemon who filed 11 minutes before filing season ended on 22 January 2020 Pastor Lindstedt got 20% of the vote even though a known White Supremacist. Ashley Edgemon intended to run back to Florida and was allowed to be sworn in for a term and then r.u.n/n/t.-o.f.f.t. to Vero Beach Florida and Pastor Lindstedt has been denied his lawful City Council seat. There will be litigation over this. But ever since 2015 Pastor Lindstedt has been unlawfully arrested for making fun of the Mayor and Granby City Council around a dozen times, the Granby City Clerk has been allowed to pursue an unlawful “domestic protection order” with the collusion of the Granby City Council, Newton County judges Gregory Stremel and Kevin Lee Selby and Judge Charles Curless and then Missouri Attorney General Josh Hawley and their law firm of lawyer Brian Todd Goldstein of Cummings, McClorey, Davis, Acho & Associates got an unlawful “sanction” against Pastor Lindstedt in the first of his Missouri Sunshine Enforcement Actions, Pastor Martin Lindstedt v. city of Granby Missouri 18NW-CV00601. There is no statutory provision for punishing a plaintiff protesting an open meetings lawsuit for purpose of governmental transparency but yet Judge Charles Curless unlawfully punished Pastor Lindstedt for daring to sue Granby at the suggestion of Granby Lawyer Brian Goldstein – who with the rest of the Kansas City jew community knows about Pastor Lindstedt and his Aryan Nations Church. Pastor Lindstedt lost both Sunshine Act enforcement actions that morning and then was convicted before Curless twice for violating Granby municipal ordinance #815 for ridiculing and holding in public contempt the Granby mayor and city council over two hours and 35 minutes. Pastor Lindstedt then filed for a trials de novo with a jury and these cases languish. Now Senator Josh Hawley had his assistant deputy Attorney General Caleb Wagner defend Judges Selby and Stremel for granting the bogus “domestic protection orders” and wanted Pastor Lindstedt sanctioned for daring to try to sue Newton County judges. Josh Hawley has since criticized the

Communist Chinese for doing exactly what Josh Hawley's office has done against the Hong Kongers, namely stifle dissent against an oppressive and corrupt regime screwing its subjects.

Pastor Lindstedt found out about this through a gloating e-mail sent by Bryan Reo on the night of Oct. 14, 2019 about buying the bogus settlement for \$1000. Pastor Lindstedt confronted Ashley Edgemon, pastor of the baal-synagogue of Satan next door to where Pastor Lindstedt and Roxie Fausnaught live. Ashley Edgemon said that "how else are we going to make you pay up other than selling the judgment to Bryan Reo?" Pastor Lindstedt explained that Bryan Reo used to claim to being a white supremacist until it came time to sue Pastor Lindstedt and Lindstedt's Aryan Nations Church and that knowing about Bryan Reo makes it a deliberate act of criminal regimeist treason punishable by extermination of the offending regime and family.

The next day, Oct. 15, 2019 the City of Granby hired a bulldozer without a court order to bulldoze down the grass and small trees at 338 & 337 Rabbit Track Road owned by Pastor Lindstedt and the lots owned by Pastor Lindstedt's nieces and nephews and deceased mother. Pastor Lindstedt seriously considered shooting these regime criminals at 12:29 pm but calmed down when talking to the corrupt Granby Police Chief Jacob Kelley. Since Pastor Lindstedt has no rights that the corrupt local and state and federal governments need respect, and Pastor Lindstedt still had his inheritance in South Dakota, Pastor Lindstedt decided to transfer it back to his sister and wait to ambush these criminals later. Pastor Lindstedt said nothing concerning Bryan Reo to his sister – his sister has been ruined by working for the social services of Newton County and isn't very racially patriotic and doesn't like to hear Pastor Lindstedt speak of the jews and non-whites and race-traitors but she could see the bulldozed earth. Pastor Lindstedt said nothing to her about shooting the Granby City Council-Criminals but transferred his South Dakota property back to his sister at the end of October 2019. Roxie was sick at the time.

Pastor Lindstedt wants to sue the City of Granby and Judge Charles Curtless and State of Missouri and Josh Hawley for declaratory and injunctive relief, no monetary or punitive damages. Pastor Lindstedt wants to sue Lawyer Brian Todd Goldstein and Goldstein's law firm, the past mayor T-Rampage Gamble, current Mayor Ira Hawkins, past and present city councilmembers Ashley Edgemon, Joyce Mann, Will Barrett, JoAnn Lamp, Lawna and David Price (Granby City Clerk and her husband) for compensatory and punitive damages regarding this selling of a fraudulent judgment "sanction" sold to Bryan Reo and thus applicable to this federal case involving Bryan Reo, and not the ongoing civic corruption not germane to Bryan Reo incessantly stalking and suing Pastor Lindstedt and his Church. If the Court grants leave, Pastor Lindstedt's Amended Counter-Complaint will be between 15 and 21 pages, only cover the selling of the bogus and unlawful judgment/sanction against Pastor Lindstedt in Lindstedt v. Granby 18NW-CV00601. Exhibit #1 – Assignment of Judgment against Plaintiff Pastor Lindstedt.

STATE OF SOUTH DAKOTA, STANLEY COUNTY COURTS, ROBERT KONRAD & SCHRIEBER LAW FIRM & OLLINGER LAW FIRM, STATE BAR OF SOUTH DAKOTA

Bryan Reo got wind sometime in 2013 that Pastor Lindstedt had a substantial inheritance in south Dakota to steal using "lawfare." Pastor Lindstedt has already provided this court with this greedy posting viz Doc26-2 "Prey 4 Muh Suckcess" of 25 August 2014, pgs 255-257. Bryan Reo seems to have gotten the e-mail of Pastor Lindstedt's sister Susan Bessman through Bryan Reo's South Dakota lawyer Robert Konrad formerly working for the Ollinger law firm which handled the estate. It seems that the Schrieber Law firm and Robert Konrad are antifa working with Bryan Reo, Kyle Bristow and Brett Klimkowsky of the FMI/ZPLC. They have filed suit in Stanley County South Dakota trying to force Pastor Lindstedt to take back his property from his

sister so that Bryan Reo can steal it through lawfare. South Dakota state law 15-16A-6 like Ohio and Missouri state law forbids execution until the Ohio judgment Bryan Reo got is finished with the appeals which are ongoing due to Bryan Reo delay. Bryan Reo and Reo lawyers are likewise engaged in abuse of legal process. Therefore Pastor Lindstedt seeks declaratory and injunctive relief against the State of South Dakota and the Stanley County Courts to force them to obey their own law and dismiss the Reo lawsuit and against the Schrieber Law Firm, Robert Konrad, and Ollinger Law Firm for compensatory and punitive damages and the loss of their licenses to [mal]practice law. If the Court grants leave, Pastor Lindstedt's Amended Counter-Complaint will be between 15 and 21 pages, and be within the current discovery scheduling.

Pastor Lindstedt asks of this federal court that he grant this timely filed Motion to Amend the Civil Complaint to allow the joinder of these parties involved in this never-ending Bryan Reo litigation. Pastor Lindstedt is quite well aware that the federal and state and local governments think that they are above the law and immune from suit, however given that this is ongoing pending litigation Pastor Lindstedt asks anyways.
