**DEFENDANTS' REPLY MOTION TO THE STATE OF OHIO'S MOTION TO DISMISS  
CLAIMING A LACK OF JURISDICTION & ALLEGED FAILURE TO STATE A  
CLAIM UNDER 11<sup>th</sup> AMENDMENT OF STATE IMMUNITY FOR VIOLATING THE  
FIRST 10 AMENDMENTS (BILL OF GOODS) & F.R.Civ.Proc 12(B)(2) & (6) (Doc. 31)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church) to make this Reply (Dispositive) Motion to the State of Ohio and its Attorneys Michael Walton (0092201) and Halli Watson (0082466) and their Motion to Dismiss under color of the 11<sup>th</sup> Amendment (The State governments cannot be sued for violating the First 10 Amendments of the Bill of "Rights"/Goods because the first Amendment after the First Ten was making up a new 11<sup>th</sup> Amendment to get away with breaking all or any of the First Ten) and Federal Rules of Civil Procedure Rule

12(b)(1) and Rule 6 for failure to state a compliant for which relief can be granted. Of course the State of Ohio, like Attorneys Bryan Reo, Kyle Bristow and Brett Klimkowsky of the Foundation for the MarketPlace of Ideas (FMI) / ZOGBot Poverty [F]Law Center (ZPLC) who work as fake “White Supremacist lawfare” group in order to initiate the Charlottesville Massacre, don’t recognize any limit to their lawlessness under color of law and will claim that they simply cannot understand Pastor Lindstedt’s and Lindstedt’s Aryan Nations Church’s complaint that Bryan Reo shouldn’t get to file a series of defamation actions for Pastor Lindstedt calling Reo a “homosexual mongrel ZOGBot” while Reo and Bristow incessantly call Pastor Lindstedt a “convicted child molester” and to bring Lindstedt to a trial before other lawyers 900 miles away before a liberal negro and whigger jury hostile to White Aryan Christian Israelite Aryan Nations heterosexual pastors and their Churches. In short, Pastor Lindstedt and Lindstedt’s Church have about as much “rights” as if they lived in openly repressive regimes like Stalinist Russia, Maoist China, or Saddam Hussein’s Iraq – even less because at least there is not the pretense of “rule of law”. However, on the plus side, any future white supremacist warlord of a successor regime has a free moral and legal hand in dealing with the non-whites and dissent against his regime.

This litigation arises out of four recent Bryan Reo (working with FMI/ZPLC attorneys Kyle Bristow and Brett Klimkowsky) litigation originally filed in Lake County Ohio for Pastor Lindstedt making fun of Bryan Reo as a delusional homosexual mongrel agent provocateur and republishing a public Bryan Reo Quora post in which Bryan Reo bemoaned that its Brazilian Sephardic jewess wife didn’t want to squeeze out a half-dozen or so Satanic mongrel abominations so when Reo decided to divorce her she claimed maybe one of two mamzerlings, then when the divorce was dropped to none so Bryan Reo sounded like a butt-hurt homosexual mongrel bemoaning about how it would have to live a lie or alone. Pastor Lindstedt observing

Mrs. Reo jumping up and down at the Lake County Courthouse at trial before what Pastor Lindstedt thought were two homosexual mongrels paying absolutely zero attention to her, found out when Bryan Reo sued Pastor Lindstedt that one of the “homosexual mongrels” was actually Bryan Reo’s father, Anthony Reo, regrettably not a homosexual albeit a mongrel. Bryan Reo has a history of trying to blackmail “Aryans” like “Victor Switzer” (not its real name) from Pine Bluff Arkansas and Johnny “Tonto” Britton of Idaho and not letting up until Reo figures out that they are mongrels as well. Pastor Lindstedt thought that Bryan Reo was hard-up on 25 June 2019

Both State of Ohio lawyers were present via telephone for Reo v. Lindstedt 02589.

What Pastor Lindstedt is suing the State of Ohio is that they allow Attorney Bryan Reo & family and FMI/ZPLC lawyers Kyle Bristow and Brett Klimkowsky to file all these bogus defamation lawsuits against Pastor Lindstedt and Lindstedt’s Aryan Nations Church under their “long arm” statutes claiming to have jurisdiction over what was said over the Internet coconcerning Bryan Reo (and Reo’s jew and mongrel and homo ZOGbot friends) and then also claim that according to Ohio law that Pastor Lindstedt cannot defend either his Church or his woman because Pastor Lindstedt is not a licensed lawyer. So they let Bryan Reo (Klimkowsky, Bristow) to run wild, along with Lake County / Judge Patrick Condon, to violate the supposed “freedom of speech, of the press, and of religion” before a hostile jury made up of muds and gliberal whiggers in which Pastor Lindstedt and Lindstedt’s Church doesn’t have a chance before their crooked tribunals

without a bit of legitimacy or of jurisdiction. During the past year Bryan Reo paid \$1000 to the Granby city council for a bogus judgment resulting from a Missouri Sunshine Act enforcement action. Bryan Reo is presently harassing Pastor Lindstedt and Pastor Lindstedt's sister trying to steal Pastor Lindstedt's inheritance in Stanley County South Dakota in violation of Ohio and South Dakota state law using a crooked attorney formerly working with the former estate. This is for the good because Pastor Lindstedt wants to liquidate the entire legal guild and their families (except for Pastor Lindstedt's sister's lawyers) and punish the State of South Dakota for granting a preliminary bogus *ex parte* temporary restraining order trying to make Pastor Lindstedt take back his inheritance he gave back to his sister. Both Bryan Reo and Kyle Bristow have sent e-mails threatening to destroy and impoverish Lindstedt's sister. Bryan Reo also got a second *ex parte* action before the Lake County Court based upon Bryan Reo impersonating Pastor Lindstedt and presenting it to one of his Lake County judge friends like in 2016 but now currently active. Bryan Reo, (Bristow and Klimkowsky) is relentless.

So what Pastor Lindstedt seeks from the State of Ohio giving them a chance to end Bryan Reo (Bristow and Klimkowsky) legal terrorism from fraudulent civil litigation and for them to end the fraudulent jurisdiction of the Lake County courts. Not Ohio taxpayer ZOGbux, but rather that the State of Ohio simply put an end to what happens to be unnecessary conflict leading to the inevitable Second Civil War. In short, declaratory and injunctive relief from the abuses of its local county courts and officers of its court who are running amok as agents provocateur supposedly within the White Supremacist and to the above-ground Christian Identity Movements. However since it is likely that Bryan Reo, Klimkowsky, and Bristow are working with the State of Ohio along with the federal government to have these agents provocateur infiltrate and destroy (like they did at Charlottesville) and since they cannot infiltrate a one-man

Pastor Lindstedt's Aryan Nations Church to instead use "legal state-sponsored terrorism" from Bryan Reo and FMI/ZPLC to "impoverish and render destitute and penniless" Pastor Lindstedt and Lindstedt's non-racist sister. See Doc. 26-2 pages 255-257 "Prey 4 My Suckcess" e-mail of 24 August 2014. Thus Pastor Lindstedt accuses the State of Ohio of using "legal state-sponsored terrorism" through their licensed attorneys Bryan Reo, Kyle Bristow and Brett Klimkowsky against a Dual-Seedline Christian Identity White Supremacist Pastor Lindstedt and Lindstedt's Aryan Nations Church and via their Lake County Court of Common Pleas and Judge Patrick Condon to achieve said results under color of law. Thus the State of Ohio and the U.S. Government is running an anti-white genocidal regime with massive doses of hypocrisy while at the same time whining about conditions in Russia and China, which while authoritarian isn't trying to destroy their founding stock at the behest of the jews, like Ohio and the U.S. regimes.

Now Pastor Lindstedt understands that the State of Ohio has no intension of obeying either law or custom in allowing Pastor Lindstedt or Pastor Lindstedt's Church to live in peace. What Pastor Lindstedt has preached as a Dual-Seedline Christian Identity pastor is that the Spawn of Satan is out to destroy YHWH's Servant Nation of Aryan Christian Israel and so the salvation shall come not from politics nor litigation from within their Satanic ZOG-korts but rather through the Great Collapse / Great Tribulation. This is why Pastor Lindstedt warned the Movement about Bryan Reo and the FMI/ZPLC and not going to Charlottesville where these ZPLC members worked with ZOG to cause the goings on there. Rather what must happen is staying underground and letting ZOG collapse. Previously back in 1996 Pastor Lindstedt observed that it would be easy to simply feed the dead corpses of Chronic Wasting Diseased (CWD) deer to deer in new areas. Someone was listening because Wisconsin was prion-poisoned in 2000 and Missouri in 2010, but regrettably not Ohio (yet). Thanks to Covid-19 which affects

rural whites last, there is a Collapse happening right now. Strategic domestic terrorism involves not blowing up stuff or shooting homosexual jews or mongrels but rather in reducing the “carrying capacity” of ZOGLing herd animals and letting the survivors claw and scratch theysselves to death trying to survive as ZOGLing whigger & mamzer ass-clown zombies living like The Walking Dead across a 99% Mad Max apocalyptic wasteland. Thanks to the new opportunities from the bio-war ZOG-virus and the breakdown of the financial, commercial and government sectors there more than likely won’t be a federal or any state governments left by this time next year but rather a breakup on the Mighty Evil ZOG Empire to where neither Pastor Lindstedt nor Lindstedt’s Aryan Nations Church will have to worry about what happens in Ohio 900 miles away.

Pastor Lindstedt, acting according to Biblical law, went through the motions of convening a secret ecclesiastical court to grant himself and his Aryan Nations Church a \$400 billion judgment, letter of marquee, and Biblical castration against the State of Ohio, and the eventual “chernobylization” of the North Perry Nuclear Power Plant and the “quantrillization” of Lake County upon the Collapse in order to end this ongoing Second Civil War. (The destruction of Sodom and Gomorrah was the result of abuse of legal process involving the citizens there robbing and murdering strangers outside their jurisdiction. Lake County has no more rightful jurisdiction over Pastor Lindstedt and Lindstedt’s Church than Sodom and Gomorrah over the travelers on the caravan route between the Red Sea and Mesopotamia during the time of Abraham in 2000 B.C. A badly run nuclear power plant so stupid that it hired Bryan Reo without doing a google search is easily destroyed come the Collapse. Daniel and his friends were the sons of the Judean nobility cursed to be castrated during the reign of King Hezekiah 120 years previously. ) All this above can be justified Biblically and will likely be possible in the future.

Bryan Reo's and Bryan Reo's lawyer friends' antics with the permission of the federal and Ohio regimes shows that surviving rural whites can't allow themselves to be outnumbered by the population of muds and whiggers like they were during the First Civil War and thus our only safety in setting up local theocratic military dictatorships (Ten Thousand Warlords) over the 10-20 million surviving whites is to ensure that areas like New York and Ohio are reduced to just a few hundred thousand sick and starving racist white survivors who have absolutely no interest in fighting with places run like a Ku Klux Klan county in 1910 Arkansas, Alabama, or the Missouri Ozarks. The State of Ohio simply cannot be allowed to exist as a political entity able to oppress White people like Pastor Lindstedt and Lindstedt's Church. No need for threats, merely an understanding of realities.

What Pastor Lindstedt and Pastor Lindstedt's Aryan Nations Church is asking in these pleadings before this federal court of the State of Ohio and its Attorney General is that they criminally prosecute Attorney Bryan Reo and its ZOGbot lawyer friends Kyle Bristow and Brett Klimkowsky and remove their lawyer licenses to practice law and to remove the ability of the Lake County courts and judges to censor and police the Internet of political or religious speech against anyone living well outside their jurisdiction. Also that the lawyer-made Ohio "law" allowing lawyers to attack non-lawyer individuals and churches under color of insisting that must hire a licensed attorney or lose by default must be overturned. In short, Pastor Lindstedt and Lindstedt's Aryan Nations Church wants (1) Bryan Reo, Brett Klimkowsky and Kyle Bristow to stop abusing legal process against themselves and others, (2) for the Lake County Courts / Judge Patrick Condon to be stripped of their fraudulent jurisdiction and dominion over Pastor Lindstedt and Lindstedt's Church and (3) for the State of Ohio to cease and desist in waging racial and

religious civil warfare against Pastor Lindstedt and the Church of Jesus Christ Christian / Aryan Nations of Missouri. Pastor Lindstedt understands that every single criminal regime claims that they cannot be held to account for their tyranny and treason against their subject population, hence the States set up an 11<sup>th</sup> Amendment to justify their violating the First Ten Amendments, and then later certain States like Ohio kept other States from leaving their collective co[o]nsolidated prison-Empire. As it is now the only way for Pastor Lindstedt and Lindstedt's Church to have any Freedom and/or Peace is to over the course of time and probabilities of the future to successfully destroy the State of Ohio and its inhabitants who allow Bryan Reo and friends and Ohio courts to run wild under color of law in acting against the YHWH's Servant Nation and YHWH's Church of Jesus Christ Christian / Aryan Nations of Missouri.

Pastor Lindstedt asks of this federal court that the case against the State of Ohio continue as a third-party defendant given that this tyrannical anti-white racist criminal regime obviously has no intention or interest in curbing their state-sponsored & licensed domestic "legal terrorists" Attorney Bryan Reo and its lawyer friends Kyle Bristow & Brett Klimkowsky along with the Lake County Court and/or Judge Patrick Condon as state-actor "legal terrorists" acting against Pastor Lindstedt & Lindstedt's Aryan Nations Church in working to destroy political & religious dissent and their White Founding People in violation of their purported constitutions and laws.
