PASTOR LINDSTEDT'S CONSOLIDATED OPPOSITION REPLY BRIEF IN OPPOSITION TO BRYAN REO FRAUDULENT SUMMARY JUDGMENT (Order 67 #2589) & (Order 31 #2786)

ALONG WITH ANSWERS TO ALL OF BRYAN REO & REO FAMILY FEDERAL LITIGATION, WITHDRAWAL OF SILENT "ADMISSIONS" ETC.

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Church and in point of fact Pastor Lindstedt is the *de facto* Chief ArchBishop of the entire above-ground Dual-Seedline Christian Identity Church in North America) to file this consolidated response of an Opposition Brief to Bryan Reo's Motion for Summary Judgment as ORDERED by Magistrate Judge Thomas Parker on 8 Sept. 2020 in Order #67 in Case # 2589 and in Order 31 in Case # 2786. Pastor Lindstedt has

found out quite a bit concerning Bryan Reo perjury based upon a hearing in the Stanley County Circuit Court in South Dakota on 31 August 2020 and the suborned perjurous filings of Reo's antifa lawfare lawyer Robert Konrad's filings to gain a permanent injunction against Pastor Lindstedt's sister Susan Bessman from disposing of Pastor Lindstedt's inheritance deeded back to her. Bryan Reo of course at all of its trials invariably lies that it is not only not a public figure within the White Supremacy and Christian Identity Movement along with its lawyer friends and family, but that Reo is an agent provocateur needlessly provoking Pastor Lindstedt's public response on Pastor Lindstedt's Aryan Nations Church web pages and then incessantly suing Pastor Lindstedt and Lindstedt's Church before those corrupt regime courts, thus making a mockery of the alleged First Amendment paper 'protections'. Over the course of five and a half court process, Bryan Reo denied ever being known as "SwordBrethren", of finding out about Pastor Lindstedt's inheritance in 2013 or early 2014, possibly from Attorney Robert Konrad who used to work at Ollinger Law Firm until recently and likely gave confidential files of Susan Bessman and the e-mail address of Pastor Lindstedt's sister to Bryan Reo and Kyle Bristow. During the past month Pastor Lindstedt has been busy dealing with the corruption of the Stanley County Court in doing whatever Attorney Konrad wants them to do regardless of the fact that Attorney Konrad cannot lawfully be Bryan Reo's lawyer when giving out Susan Bessman's confidential files.

Therefore, with Bryan Reo not only being a public figure but part of an false-flag "Foundation for the MarketPlace of Ideas" (FMI) domestic-terrorism sting operation responsible for setting up the Charlottesville Virginia "Unite the Right" antifa riots of August 2017, indeed their Board of Directors 501(c)(3) paperwork not only lists Bryan Reo, Kyle Bristow, and Brett Klimkowsky, who Pastor Lindstedt is counter-suing as counter-defendants but Richard Spencer,

Augustus Invictus, Mike Enoch and others well known in the Movement who were the lead operatives of the Charlottesville Disorder which has been used as a campaign tool by Joe Biden. Thus this federal court is seen entertaining frivolous and malicious civil litigation / lawfare from a ZOG police operative and officer of this court involved in entrapping domestic dissent simply because a long-time Aryan Nations pastor is reporting not only on Bryan Reo but other operatives for the Deep State. This is akin to the Soviet Regime not only entertaining a civil action against Alexander Solzhenitsyn on its final days but sponsoring the KGB agent as well.

Pastor Lindstedt, with his 30-year history as the above-ground political and religious figure in the overtly White Supremacist and Dual-Seedline Christian Identity Movements, has overtly criticized Bryan Reo and Reo's false-flag operations for over a decade. Pastor Lindstedt has said exactly the same thing all along: Bryan Reo is a Satanic homosexual mongrel of mixed jew, negro, gook, and Indian descent who is working as a fed to insinuate other jews and mongrels and homos into the leadership of the Movement and thus Bryan Reo and anyone who will have anything to do with Bryan Reo is to be kept outside Resistance organizations and operations. Bryan Reo, Reo's wife and father, Reo's FMI lawyers Kyle Bristow and Brett Klimkowsky, and the rest of Reo's kind like to call Pastor Lindstedt a convicted child molester. This is libel per se and should invalidate all of Bryan Reo litigation.

Pastor Lindstedt, along with this Opposition Motion to Bryan Reo's fraudulent Motion for Summary Judgment is submitting his "Consolidated Answers" in all four Bryan Reo Cases before this Ohio federal court, "Withdrawing all implied 'admissions' yet again" and "Stating that there are no documents" that Bryan Reo doesn't know about as they are court filings in the public record or already on Pastor Lindstedt's Church's Web pages. Thus since the 'Admissions'

are withdrawn then this Court can proceed to trial on the merits before a jury and set things up for showing exhibits as a public record. Or this Court can rule that Bryan Reo and Bryan Reo family litigation is frivolous and malicious and punish Bryan Reo and Reo's family by a judgment of \$2.5 in actual damages (Pastor Lindstedt's inheritance was worth \$2 million when he had to give it to his sister) and more in punitive damages and penalties, especially the permanent disbarment of Bryan Reo and Reo's lawyer friends Kyle Bristow and Brett Klimkowsky within the jurisdiction of this federal district court.

In these "Consolidated Answers" in all four cases, Bryan Reo admits that Pastor Lindstedt never used the term "homosexual incest" in talking about Reo's father Anthony Reo in Reo v. Lindstedt 1-19-cv-02615 or "transgendered prostitute" in mentioning Bryan Reo's Brazilian Sephardic wife Stefani Reo v. Lindstedt 1:19-cv-02615. The printed-out 18 pages of exhibits in the Stefani Reo v. Lindstedt Doc 32-1 of church web pages and Bryan Reo e-mails proves as much. The rest of the "Consolidated Answers" reveal that Bryan Reo simply is lying about what has been published about Bryan Reo and friends and family over the years on Pastor Lindstedt's Church web page as being true but Bryan Reo misstating what is said or written without showing what was actually said and then making claims based upon Reo "law" as Reo sees it. In making fun of Bryan Reo's wanting to delay proceedings in previous Reo litigation Pastor Lindstedt in one of the court filings suggested that since Reo like Michael Jackson always wanted to be a White Woman in order to get that Aryan pecker that Reo visit the "Joseph Mengele Clinic" in Paraguay. There is no "Mengele Clinic" outside the movie "Boys From Brazil" made years before Reo was spawned about a plot to clone Hitler starring Gregory Peck back in 1978 that Pastor Lindstedt liked a lot. This jape being in Lake County Court papers is

thus "privileged" as well as being permissible when talking about a delusional homosexual mongrel ZOGbot like Bryan Reo as a public figure wanting to play Neo-Nazi Holey-Mamzer.

Thus since the "admissions" have been withdrawn in the time frame of further discovery set by Magistrate Parker on 8 Sept. 2020 then Bryan Reo has no claim to summary judgment given that Reo's claims are perjurous, or already in the public record in court papers from this endless Reo litigation or controverted by Pastor Lindstedt's Consolidated Admissions of denial to Reo claims. The only absence of genuine material facts are Bryan Reo's claims on behalf of itself, its wife and father. Thus if summary judgment is warranted it should accrue to Pastor Lindstedt as opposed to Bryan Reo and Reo delusion and perjury.

Furthermore Bryan Reo (and Bryan Reo on behalf of its wife and father) has refused to obey Rule 26(1)(a)(iii) to compute its actual damages as opposed to dividing the \$2 million by four lawfare lawsuits by four and demanding accordingly. Bryan Reo in the over a decade of fighting with Pastor Lindstedt trying to kick Bryan Reo out as a homosexual mongrel ZOGbot out of the Movement could have stopped at any time – especially over a decade ago in late October 2010 when it agreed to leave the [bowel] Movement upon detection on 29 Oct. 2010 by Pastor Lindstedt – instead of founding FMI/ZPLC with its pencil-necked Aryan homo lover Kyle Bristow and then doing the Charlottesville Disaster. Instead within a week Bryan Reo broke the deal and was posting on its (SwordBrethren) SB Blog given Reo on Willaim Baal Finck's Christogenea.org forum the Eli James article "Rabbi Lindstench: jew or Race-Traitor" in which Pastor Lindstedt, like Bryan Reo & Family and Kyle Bristow do to this day, was called a "child molester" 20-some times and a convicted one at that another dozen or so times. Bryan Reo refused to obey Local Rule 16 and make arrangements to do discovery of the very same stuff over a decade old but rather to file Motions to Strike and now this Motion for Summary

Judgment. Pastor Lindstedt hasn't asked Reo and others for discovery because since Reo and Reo's lawyer in South Dakota can't admit that Bryan Reo is a public figure playing white supremacist still but rather want to pretend that this informant and provocateur are just one of a hundred thousand negro homosexuals in the Cleveland Ohio area that a racist swine like Pastor Lindstedt of the Aryan Nations just decided to defame all of a sudden that did work out in Lake County Ohio. Thus it was enjoyable to rake Bryan Reo and Reo's crooked antifa lawfare lawyer Robert Konrad over the coals before the Stanley County South Dakota circuit court even though the judge finally at the last minute decided to accept Lawyer Konrad's perjurous Findings of Fact and Conclusions of Law and thus ensured litigation for years in South Dakota in which there well might not be a payoff for Bryan Reo and ZOGbot lawyer friends and family.

Additionally the Ohio 11th District Court of Appeals heard oral argument via Zoom on 14 Oct. 2020. They might well decide to understand that they don't want jurisdiction to try an Aryan Nations pastor and his Aryan Nations Church 900 miles away, especially in pre-Civil War times.

The negro judge Solomon Oliver in Reo v. Lindstedt 1:19-cv-02103 decided to grant Bryan Reo summary judgment and to pre-emptively censor or gag-order Pastor Lindstedt and Lindstedt's Church based upon Bryan Reo lies. Pastor Lindstedt has filed a Rule 59(e) Motion for Judge Oliver to reconsider.

However, it is not the duty of Pastor Lindstedt to whine to this court or Ohio courts when they violate the First Amendment of the Bill of Goods against YHWH's Servant Nation of Aryan Christian Israel's Servant Church. It is the duty of YHWH's Soldiers to rather exterminate given provocation any Satanic regime or its population and its local, state and federal regimes which dare to do so. In an age of the ZOG-virus that kills non-whites and urban whiggers far more than
