**PASTOR LINDSTEDT’S & THE CHURCH OF JESUS CHRIST CHRISTIAN / ARYAN
NATIONS OF MISSOURI (& THIS *DE FACTO SATANIC u.S MIGHTY EVIL EMPIRE*)
CONSOLIDATED RESPONSE TO ALL OF THE SATANIC HOMOSEXUAL
MONGREL/MISCHLING ZOG AGENTS PROVACATEUR ABOMINATION BRYAN
REO AND REO FAMILY AND ATTORNEY’S FRIVOLOUS & MALICIOUS STATE &
FEDERAL LITIGATION AGAINST PASTOR LINDSTEDT, LINDSTEDT’S CHURCH
& ARYAN CHRISTIAN ISRAEL**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt’s Church and in point of fact Pastor Lindstedt is the *de facto* Chief ArchBishop of the entire above-ground Dual-Seedline Christian Identity Church in North America) to file this consolidated response to all of this ongoing Bryan Reo litigation before its sundry state and federal courts. Bryan Reo, a satanic homosexual

mongrel/mischling ZOG agent provocateur abomination, has been allowed – along with its fellow antifa lawyers practicing “lawfare” pretending to be “white supremacists” with the Foundation for the Marketplace of Ideas (FMI) also known as the ZOGbot Poverty [F]Law Center (ZPLC) – to sue Pastor Lindstedt and Lindstedt’s Aryan Nations Church before these satanic federal and state courts making their pretense of allowing freedom of speech, the press, and most importantly of religious activity nothing but a farcical lie as they pursue a satanic agenda of destroying Aryan Christian Israel starting with their leadership of Pastor Lindstedt and Lindstedt’s Aryan Nations Church. Wherefore this defensive Response stating the issues – that these federal and state regimes are illegitimate and doomed and very soon will no longer rule over Aryan Christian Israel – with further Motions, each for each separate piece of the sundry parts of this massive never-ending Bryan Reo litigation against Pastor Lindstedt, Lindstedt’s Church and Lindstedt’s sister who now has been deeded back Pastor Lindstedt’s inheritance.

There are the four current Bryan Reo v. Lindstedt federal lawsuits in the Northern District of Ohio and a *Bryan Reo v Martin Lindstedt and Susan Bessman* (Pastor Lindstedt’s sister to whom he deeded back his inheritance in Oct. 2019) 58CIV20-07 case in Stanley County South Dakota in which Bryan Reo seeks a payoff of Lindstedt’s inheritance. All these cases are addressed in this Response given that they involve a long-time homosexual mongrel federal informant and agent provocateur and its network stalking a long-time Dual-Seedline Christian Identity genuine White Supremacist Aryan Nations pastor Martin Lindstedt over the Internet because it is afraid of what might happen to it if it shows up in person and then is allowed to “lawfare” Pastor Lindstedt and Lindstedt’s Aryan Nations Church years later breaking these federal and state government’s worthless fraudulent pledges of free speech & religion by haling dissidents before these criminal regime’s pretend illegitimate courts of spurious jurisdiction.

Pastor Lindstedt in this response is merely reminding these courts that they can lose power through those they oppress simply rising in revolt, or destroying their herd animals or merely refusal to consent to their further misrule making of it a civil war if they pursue it further.

HISTORY OF THE BRYAN REO / PASTOR LINDSTEDT LITIGATION

1. Bryan Reo is a delusional self-loathing non-white homosexual mongrel of mixed negroid, oriental and jewish extraction who sometime before it graduated from Mentor High School in 2004 was infiltrating so-called White Nationalist Internet groups like Richard Barrett's in Mississippi before being found out as a homosexual mongrel and being kicked out. As Richard Barrett said around 2004-05 in kicking Bryan Reo out, "Bryan Reo is going to have to figure out that he isn't white and stop bothering the Movement." In rational moments like on the Quora Bryan Reo admitted to being of a [Sephardic marrano jew] South Italian from Calabria South Italy. But most of the time Bryan Reo pretended to be a "Teutonic Crusader" "SwordBrethren."
2. Bryan Reo re-appeared along with another Sephardic jew named "Eli James" formerly "Joseph November" and before that allegedly Joseph Putz / Kutz born in 1946 in Austria, possibly of Holohoax survivors to bring into Dual-Seedline Christian Identity a Khazar jew named William Finck who as a Jersey City jailer murdered a Puerto-Rican sneak thief named Arnaldo Ortega, inducing a wop pig named David Dumers to help in the murder of the prisoner. Later Finck 'fin[c]ked' out Dumers at jury trial and later ruined Dumers' appeal by filing an appeal of Finck's own plea bargain. Both Dumers and Finck served equal time in federal prison

for the murder. In June 2019 these three jews “Eli James” and Bryan Reo appeared at a rally to bring on as a “Greek Scholar” and new DSCI pastor William Finck of Christogenea.org.

3. One Everett “Buck” McHugh lost his stockbroker’s license and \$2.5 million because of Bryan Reo and hated Bryan Reo yet wanted to be in the Movement. Buck McHugh told Pastor Lindstedt superficial details including insurance fraud about “SwordBrethren” in 2010 but not the name of Bryan Reo or .Mentor Ohio. Pastor Lindstedt decided to find out who the mongrel homosexual that was terrorizing Christian Identity people anonymously under the guise of being a CI sub-pastor, and on 29 Oct. 2010 found out through Baal Finck’s Facebook page and Bryan Reo was well known.

4. Regarding Bryan Reo “damages.” Bryan Reo asked Pastor Lindstedt if Lindstedt would stop talking about Bryan Reo, if a “deal” could be made. Same deal as with Buck McHugh? Pastor Lindstedt said that he wouldn’t make any deal about removing Bryan Reo posts on his Church forum but if Bryan Reo would leave white supremacy and Christian Identity (CI) and not come back then Pastor Lindstedt wouldn’t put up anything new on his forums because Bryan Reo wouldn’t matter. Bryan Reo agreed, and called up Pastor Lindstedt and Buck McHugh to ask if Buck had betrayed Reo and Lindstedt said no, another Finckbot did. But on Nov. 5, 2010 Bryan Reo published on his “SwordBrethren” blog on Finck’s Christogenea forum an Eli James article about “Rabbi Lindstench” being a race-traitor or jew in which Eli James called Pastor Lindstedt a child molester 22 times and a convicted child molester 9 times. In all of Bryan Reo’s filings Bryan Reo, his father, his wife, his Aryan homosexual ZOGbot lawyer lover Kyle Bristow calls Pastor Lindstedt a child molester jailed in the Fulton state nuthouse even though the matter was dismissed before a preliminary hearing on 27 Feb 2009. Pastor Lindstedt was sent to the NutHouse for refusing to accept a public pretender to mis-represent him and regards all lawyers

as servants of Satan. In all of the Bryan Reo litigation Pastor Lindstedt calls Bryan Reo a delusional self-loathing Satanic homosexual mongrel ZOGbot and Bryan Reo calls Pastor Lindstedt a child molester, sometimes a convicted child molester at that. The Missouri case files were deleted the very day the charges were dismissed but Pastor Lindstedt keeps them up on his Church web pages in order to make the point that anyone and everyone who destroys an Aryan White Christian Israelite family must be destroyed along with their entire family – no exceptions except for those who first turn on their fellows and exterminate the rest so that a successor regime can get them all – root, branch and tender twig.

5. Bryan Reo then went on a tear removing Pastor Lindstedt's Church's web pages and forums in the U.S. on fraudulent DMCA copyright claims and in Canada and Australia for hate speech. This while pretending to be a White Supremacist Christian Identity sub-pastor for William Finck. Bryan Reo even took down a homosexual NIM-Buster forum after being caught impersonating an ex-friend of Pastor Lindstedt who Reo thought was Aryan and whom Reo was trying to blackmail for homosexual favors. Pastor Lindstedt took an Internet vacation for six months then got on a free-speech Internet Service Provider in which the deal was that Pastor Lindstedt would take down anything that Bryan Reo claimed was a copyright infraction under the Digital Millennium Copyright Act then make a counter-claim of false take-down like at the end of Nov. 2010. From June 2010 until June 2013 that was the arrangement even though Bryan Reo who was filing lawsuits under the Consumer Protection Telephone Act against companies then threatened to sue for libel and defamation. In early April 2014 Bryan Reo threatened to get a subpoena and so the ISP caved and Pastor Lindstedt agreed to move on to another server, leaving a the 2004 Mentor High Facebook picture atop a post about how a Bryan Reo in a 2003 Toyota had killed a Catherine Williams in Spartanburg SC on April 7, 2014. On Apr 16, 2014 Bryan

Reo filed a DMCA Action, Reo v. Lindstedt 1:14-cv-00816-JG for \$10.75 million which was transferred to the Western District of Missouri and dismissed because Bryan Reo couldn't prove it had \$75,000 damages on 10 Sept. 2015. Bryan Reo then filed in Lake County on 18 Sept. 2015. In all such cases, Bryan Reo has demanded a "gag order" to prevent everyone from knowing what this agent provocateur is up to, but until recently with Judge Solomon Oliver on 28 Sept. the federal and state courts have refused to so violate the First Amendment so wantonly.

6. For three years or more until late 2013 or early 2014 Bryan Reo would call Pastor Lindstedt a convicted child molester on Baal Finck's web pages and forums and Pastor Lindstedt would call Bryan Reo a "mamzer faggot ZOGbot" on his Church web pages. This stasis was in effect because Pastor Lindstedt living with Roxie Fausnaught at his hovel at 338 Rabbit Track Road in Granby didn't look like he had anything to steal. Pastor Lindstedt's sister Susan Bessman sold her inheritance in 2011 or 2012 through the Ollinger Law Firm in Pierre South Dakota. It is suspected that fellow antifa lawyer Robert Konrad was working the ZOG agents provocateur of the Foundation for the MarketPlace of Ideas (FMI/ZPLC) and got the confidential files on Susan Bessman sometime and may have notified Reo of the FMI/ZPLC about Pastor Lindstedt's inheritance in late 2013 or early 2014 or maybe later of Susan Bessman's e-mail address. At the 31 August 2020 preliminary hearing for a permanent injunction on Susan Bessman's or Pastor Lindstedt (who no longer owns the inheritance) Bryan Reo lied about not knowing anything about Lindstedt's inheritance or even ever being "SwordBrethren" in perjured testimony suborned by Attorney Robert Konrad and accepted by Judge Bridget Mayer. Pastor Lindstedt has presented the 25 August 2015 "Prey for Muh Suckcess" SwordBrethren post saying that he wants to steal Pastor Lindstedt's inheritance and render Pastor Lindstedt destitute as an exhibit before each and every court in each and every case. Reo didn't sue until Reo seen a payoff.

7. The Mighty Evil ZOG/Babylon/Satanic Beast Empire spying on White Supremacists / White Nationalists is nothing new, probably was done since the days of Charles Lindberg and George Lincoln Rockwell. Every single white nationalist or civic nationalist or militia group is crawling with informants and agents provocateur. Pastor Lindstedt's Aryan Nations Church is unable to be infiltrated because it consists only of Jesus Christ and Pastor Lindstedt. Pastor Lindstedt is "of the blood" and a "mad man" in White Supremacy and Dual-Seedline Christian Identity. While of course Pastor Lindstedt is monitored by ZOG, Pastor Lindstedt needs only tell of how to go about killing millions of ZOGLings and of course someone will listen and obey.

Bryan Reo is the Founding Member of the Foundation for the MarketPlace of Ideas (FMI) / a.k.a. ZOGbot Poverty [F]Law Center (ZPLC). Pastor Lindstedt thinks that the so-called "Executive Director" Attorney Kyle Bristow is merely Reo's pencil-necked Aryan bitch. Attorney Brett Klimkowsky is just another antifa lawyer of less ability than even Bryan Reo who Bristow used to work with defending negro gang-bangers. However the rest of the FMI/ZPLC Board of Directors were big names: Richard Spencer, one-eighth jew and homosexual and Mike Isaac Enoch Peinovich a full blooded jew who were the instigators of the ZOG false-flag Charlottesville Disaster. Charlottesville was a ZOG false-flag operation which would spur Senile Joe Biden to run for president – or so Biden says. The 2017 IRS 501 (c)(3) Income tax form provided in all this Reo litigation mentions that they took part in Charlottesville – and so they did as directed. It was no accident that a stray Uber driver picked up Dickie Spencer and Mike 'the kike' Enoch and that David Duke jumped in and let the rest of the ZOGbots & ZOGtards slog through the antifa and BLM mob at Charlottesville. (Kyle Bristow was defending as an out of state lawyer David Duke in post-Charlottesville litigation only a few months ago – something referenced by Bryan Reo at the 31 August hearing in Stanley County South Dakota.) Other

members like James Edwards of the radio show “The Political Cesspool”, lawyers William Johnson of the American Third Position Party and “Augustus Invictus” a mongrel who beat up its mongrel wife and spawn and Thom Robb’s lawyer son Jason Robb are all ZOGbots working as fake “white nationalists” and FiBbIe Klansmamzers for ZOG. The League of the South and Brad Griffin / Hunter Wallace of Occidental Dissent all promoted Charlottesville and were there and betrayed a bunch of whigger ZOGtards and are known or suspected informants.

The reason all this is brought up is because in all of this state and federal litigation initiated by Bryan Reo, Reo’s father and wife and Reo’s lawyer friends it all involves Pastor Lindstedt and Lindstedt’s Aryan Nations Church (and Lindstedt’s 63-year-old bed-bound illiterate domestic partner Roxie Fausnaught and non-racist sister Susan Bessman) being sued for ‘defamation’ of one or several of this Satanic Mighty Evil Empire’s public-figure agent provocateurs. Thus every single one of these state and federal courts are guilty of racial and religious treason and civil warfare against members and leaders of ZOG’s Aryan Christian Israelite founding stock. The penalty for that is extermination of those treasonous elites of jews and anglo-semititic ZOG lawyers, judges, police, functionaries, politicians and as much of their humanoid herd animals as possible in order for Aryan Christian Israel to survive as a People under local theocratic military dictatorships / warlords, i.e. The Ten Thousand Warlords.

8. Therefore having no choice but to defend himself (but disallowed ferom defending his Church and woman by a parasitic group of criminals and traitors claiming to be officers of the regimeist courts who usurped false patents of nobility) Pastor Lindstedt has gone along with the flow, posting to about 2/3 of Bryan Reo lawfare idiocy and deceit. In all cases Pastor Lindstedt asks for Bryan Reo’s Rule 26 FRCP computation of mythical damages – Bryan Reo could have avoided all this effort if only it had run off as it agreed to upon detection in Oct 2010. Reo

refuses to hold these mandated meetings by the Court. Bryan Reo drafts up the most ridiculous Demands for Admissions even though everything Reo bitches about is on the Church web page and Bryan Reo is still a homosexual mongrel ZOGbot and Pastor Lindstedt never was or is not a child molester. Then Bryan Reo files Motions to Strike and for Summary Judgment and actually gets one from the negro federal judge. Pastor Lindstedt doesn't expect any justice from this criminal regime that deserves extermination but merely goes through the motions to make these courts go past the point of any return to legitimacy.

WHAT MUST BE DONE

9. Pastor Lindstedt and Bryan Reo engaged in oral argument for the Lake County Ohio cases on 14 October, 2020. Pastor Lindstedt states that the Lake County Ohio courts never had or should have wanted jurisdiction to drag Pastor Lindstedt and Lindstedt's Aryan Nations Church 900 miles away for calling federal informant and agent provocateur Bryan Reo a delusional crazed Satanic homosexual mongrel pretending to be a white supremacist outside the Ohio statute of limitations and before an African female juror and liberal whigger lynch mob jury and crooked judge who wouldn't allow Pastor Lindstedt to present evidence on his own behalf or that of his Church and dismissed most of Pastor Lindstedt's counter-claims. In short Bryan Reo, Lake County courts, Judge Patrick Condon and the State of Ohio engaged in the Sins of Sodom and Gomorrah and the three Other Cities of the Plain in that they dragged Pastor Lindstedt and Lindstedt's Church to face abuse of quasi-legal process and false dominion without having any lawful and legitimate jurisdiction to do so. The penalty assessed against Sodom & Gomorrah for robbing under color of law strangers from the caravan route between the Red Sea ports and Mesopotamia was brimstone and fire from heaven killing all the population and the creation of the Dead Sea. The penalty for Lake County and Northeast Ohio dor the very same offenses but

worse should be the quatrillization of NE Ohio but especially the chernobyzation of the North Perry Nuclear Power Plant. Since the State of Ohio refuses to punish Bryan Reo and Judge Patrick Condon then the penalty should be increased to the Columbus nuclear power plant.

This punishment also has the effect of dissolving the bonds between the federal and state regimes as what happens in Lake County should have remained in Lake County.

Since the State of Ohio is to be punished for its crimes against those from another state who want nothing to do with Ohio 'justice' then Pastor Lindstedt has no objection to the State of Ohio and Lake County having more time to an extension of the dispositive motion deadline until 21 days after this magistrate judge rules on Pastor Lindstedt's objections. Pastor Lindstedt wants inevitable chernobyzation to wait until it is safe for local warlord besieging forces to do so.

10. Pastor Lindstedt doesn't want any ZOGtards to be infiltrated by ZOG agents provocateur who will be labeled "white supremacists." Pastor Lindstedt therefore asks that "lone tards" do whatever they please but that they don't involve anyone else in destroying ZOG/Babylon which is doomed and collapsing now anyways.

11. Non-whites and jews do not belong amongst Aryan Christian Israel. Thus like Judge Solomon's Doc 44 & 45 Orders of 28 Sept. 2020 Reo v. Lindstedt 1:19-cv-02103 which were the Dred Scott 2d Civil War equivalent of saying that the non-white and invader has no burden to respect any rights claimed by the white man, Aryan Christian Israelites have no burden of respecting any rights of the non-white, especially of feeding and caring for such invaders. Non-whites are to be exterminated from the Aryan Christian Israelite world; warlords decide whether there are to be any reservations for such.

12. Anyone who is a servant of the Satanic criminal regimes known as states or the federal government is to be eliminated if non-white or enslaved if white and if profitable. If enslaved if

not exterminated out of hand such are not allowed to own property until redeemed by good conduct while enslaved for their crimes against Aryan Christian Israel after generations elapse.

13. Pastor Lindstedt is not making any direct threats against Bryan Reo or any other regime criminals. In fact, Pastor Lindstedt's Resistance decree is that Bryan Reo and Reo's family are to be spared so that Reo can chernobylize the North Perry Nuclear Power Plant and the rest of the non-whites are to pay for Bryan Reo's sins and crimes.

14. No White Supremacist is to condemn White Supremacist "crimes" or "terrorism." It takes dire deeds to save Aryan Christian Israel as a People in destroying the Mighty Evil Empire and ZOGLings.

15. Pastor Lindstedt will continue to file Motions as necessary.
