**DEFENDANTS' FRCP RULE 59(e) MOTION TO ALTER OR AMEND A JUDGMENT  
(Doc 90) TO DISMISS BRYAN REO ATTORNEY (((& FELLOW FOUNDING BOARD  
MEMBER OF THE FOUNDATION FOR THE MARKETPLACE OF IDEAS (A "White  
Supremacist" "lawfare" ZOG False-Flag NGO) & Homosexual Lover)) KYLE BRISTOW**

**OR FRCP RULE 60 – RELIEF FROM JUDGMENT OR ORDER (Doc 90)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Aryan Nations Church) to timely make A Rule 59(e) Motion to Alter or Amend this Court's ORDER (Doc 90) to dismiss Plaintiff Bryan Reo's longtime antifa lawyer and board member for The Foundation for the MarketPlace of Ideas (FMI) See Doc 26-1 IRS Short Form 501(c)(3) Tax Form page 251-254 19 March 2020) and long-time "White Supremacist" pretending lawyer and still on the edges of the Movement Attorney Kyle Bristow. Attorney Kyle Bristow has been in intimate contact with non-white

antifa “white supremacist” since at least 2014 and likely before and has been oppressing through “lawfare” Pastor Lindstedt and Lindstedt’s Aryan Nations Church since early 2016 when officers of the Ohio courts Attorneys Reo, Bristow, and Brett Klimkowsky decided to set up FMI to act as a federal government agents provocateur to infiltrate, harass, and oppress under color of state and federal law the genuine racial Resistance Movement in general and especially Pastor Lindstedt and Lindstedt’s Aryan Nations Church. This Court by ORDERING that sundry Bryan Reo “counter-defendants” who happen to be officers of their own courts be dismissed from counter-litigation under sundry pretexts is morally and legally no different than every failed totalitarian and foreign authoritarian regime in allowing its secret political police & agents provocateur and employees & officials to run wild in an official and quasi-official capacity spying on dissenting parties with no reason to allow a peaceful transfer of power and thus making the Collapse and the [dis]organized Revolution both inevitable and the consequences bloody. This Court is legally, politically and morally wrong in its Opinion & ORDER (Doc 90) and so Pastor Lindstedt does Protest and Object in this Rule 59(e) Motion..

Pastor Lindstedt intends to send this Objection by e-mail on the 28<sup>th</sup> day under Federal Rule of Civil Procedure (FRCP) Rule 59(e) but if this Court does not accept it as timely filed then a FRCP Rule 60 Motion is sent instead.

#### **THIS COURT’S FRAUDULENT ‘BACKGROUND’ REGARDING REO & BRISTOW**

As in all police states /Mighty Evil Empires these state and federal regimes pretending to be a multiracial democracy must and does maintain an entire corps of agents provocateurs (known colloquially as “ZOGbots”) to infiltrate and disrupt genuine racial and religious dissent against the jews and race-traitor whiggers at the top of the heap. Pastor Lindstedt is an Aryan Nations white supremacist of over 30 years experience working to bring about a desired racial

and political end of around 20-30 million ex-whiggers ruled over by Ten Thousand Warlords ruling over localized theocratic (Dual-Seedline Christioan Identity) military dictatorships after the great die-off / Collapse / Great Tribulation which is accelerating the past year or so. This Collapse is inevitable but working at key points like chernobyling ailing and old nuclear power plants or culturing a “Dylann Storm Coof” ZOG-virus which will affect non-whites and urban whiggers to die like flies as the ZOGLand implodes can hasten the desired processes to leading to local White communities, perhaps reservations for some non-whites and extermination of jews can be accomplished. In short Pastor Lindstedt has a vision in which Whites can live together in small localized communities in which every White child has a future and a place without predation and parasitism by non-whites and jews who have no place in those small decentralized petty states joined by confederation.

To counter these inevitabilities in which the current jew, mamzer & whigger regime-criminals rule over and destroy White People this regime has set up fake “white supremacist lawfare” groups like the Foundation for the MarketPlace of Ideas (FMI) which has as founding members the non-white homosexual mongrel/mischling satanic abomination golem Bryan Reo and Bryan Reo’s blond, blue-eyed pencil-necked Aryan mangina Attorney Kyle Bristow and the Slavic Brett Klimkowsky. Along the way they got White Nationalism 1.0 ZOGBots like Thom Robb’s lawyer spawn Jason Robb and even more Alt-Right jews and mongrels like Richard Spencer and Mike Isaac Enoch Peinovitch and Augustus Invictus who did the Charlottesville 1.0 in Aug. 2017 and “Charlottesville 2.0” on the Glorious & Pathetic Sixth of January 2021.

In all these cases the task is the very same: To get foolish whiggers to show theysselves for doxxing and targeting and state-sponsored counter-terrorism as a sort of backfire to successful organic revolt and suppression. Recently it seems that more and more ZOGLing whiggers are



getting wise to these ZOG provocations and the Pretender Senile Joe Biden election “coup” and now are just waiting for the negroes to burn down the big cities as they fort up to survive.

Bryan Reo has the disadvantage of being obviously non-white and homosexual as well as being crazily evil and stupid. Since 2003 Reo has pretended to be a white supremacist and Christian Identity but found out and called out. On 29 Oct. 2010 Bryan Reo was detected by Pastor Lindstedt through William Finck’s stupidity. William Finck is a Jersey City jew who murdered a Puerto-Rican sneak thief in the Jersey City jail, fin[c]ked another pig, took a plea bargain, was recruited while in federal prison to becom a “Greek Scholar” and See-Eye Dentist pastor on “Christogenea.org” and now is high up in the ZOGbot run “League of the South”. After making a deal from 1-4 Nov. 2010 in which Pastor Lindstedt agreed to not publish any new material on Bryan Reo as long as Bryan Reo agreed to leave the Movement – for good this time Bryan Reo broke that agreement on the fifth day be publishing on his “SwordBrethren Blog” the Eli James article “Rabbi Lindstench: Race Traitor or Jew?” Bryan Reo then in conjunction with other ZOGbots took down around a dozen of so Pastor Lindstedt’s and allied web pages.

Since April 2014 Bryan Reo lawsuits against Pastor Lindstedt and Lindstedt’s Aryan Nations Church follows the same pattern: Reo makes claims on the basis of what he purports Pastor Lindstedt’s web page says and refuses to make FRCP Rule 26 Initial disclosures especially regarding damages. Pastor Lindstedt counter-sues everyone associated with Bryan Reo barratry. As in Lake County Ohio a crooked judge and biased jury finds against the “White Supremacist” and his Aryan Nations Church or at the federal level the negro judge does away with the myth of the First Amendment and this federal judge Boyko does away with the myth of the 7<sup>th</sup> Amendment trial by jury provision. Boyko also turns loose every single governmental unit, state federal and county and judge and lawyer – in this case Attorney Kyle Bristow – who is

operating this state sponsored “lawfare terrorism” by agents provocateur. Eventually the myth of “rule of law” is hollowed out & racial and religious civil warfare cums to the ZOGLand.

Attorney Kyle Bristow was the “Executive Director” of FMI since it was started in early 2016 and operated until March 2018. Bristow is still involved in white supremacist “lawfare” and was lawyer for David Duke within the past year. See yet again Doc 26-1 IRS Short Form 501(c)(3) Tax Form page 251-254 19 March 2020 in this case.

Attorney Kyle Bristow had Bryan Reo as his “law clerk” so Bristow refused as a “Movement lawyer” to help out Pastor Lindstedt on 9 Feb 2016.

Then on May 12, 2018 Bristow called Pastor Lindstedt to claim that Bryan Reo was no longer working for him but wanted to know a lot of things about Bryan Reo litigation:

Then after Bryan Reo “won” in Lake County Kyle Bristow drafted up a Motion for Attorney Fees while Bryan Reo drafted up Motions for Pre-Trial Interest: on July 24, 2019.

In fact, throughout the years since 2016 Bryan Reo and Kyle Bristow have worked together to do “lawfare” against Pastor Lindstedt and Lindstedt’s Church and some of the Bryan Reo filings have been sent from the Detroit Michigan post office.

Lastly, **Exhibit #2** is an e-mail sent both to Bryan Reo and Pastor Lindstedt dated Tuesday, April 28, 2020 at 8:07 pm in which Bristow admits that Bryan Reo is in “the top echelons of society”, claiming that Pastor Lindstedt should not possess “millions of dollars in

land despite you being a deranged lunatic who spent time in a mental institution in relation to you allegedly sodomizing your step-grandson”. Also telling is the threat – since carried out in conjunction with Bryan Reo and South Dakota antifa lawyer Robert Konrad in extorting Pastor Lindstedt’s sister to give up the inheritance given back to her or she will be rendered destitute as well as Pastor Lindstedt. “You keep digging yourself a hole, and you will only drag others – like your dear sister – down with you. Do you want to make your sister destitute too?”

Every single one of the Bryan Reo “lawfare” personages should be in the fullness of time hunted down and exterminated along with their entire families as always happens with a regime change or revolution. This federal court giving one of their officers of this court a “free pass” for carrying out state-sponsored domestic terrorism through lawfare simply shows why this form of government needs to be abolished or replaced at the end of this current Second Civil War.

#### **JUDGE BOYKO’S HOLLOW LAW AND ANALYSIS JUSTIFYING “LAWFARE”**

Judge Boyko goes through several pages of rationalizations to explain why Attorney Kyle Bristow as an officer of this Court can practice “lawfare” – legal civil warfare under color of law done by lawyers – against Pastor Lindstedt and Lindstedt’s Aryan Nations Church and not suffer any consequence for doing so whatsoever. In short, the Northern District of Ohio federal district court is a sort of “robbers’ roost” for government sponsored legal terrorism against “white supremacists” and their churches 900 miles away. The end result is that Judge Boyko will hold harmless Bryan Reo and his fellow antifa lawyers, and judges and governments and courts waging legalized banditry against Pastor Lindstedt and his Aryan Nations church by ruling that Pastor Lindstedt should pay \$750,000 to Bryan Reo as a result of Pastor Lindstedt somehow “admitting” what was denied three times (Doc 92 Order) and doing away with the 7<sup>th</sup> Amendment right to a jury trial for civil disputes over \$20. This is of course tyranny.



There will doubtless somewhere down the line serious consequences for this tyranny and state-sponsored "lawfare" terrorism in which Pastor Lindstedt along with Pastor Lindstedt's Aryan Nations Church is dragged 900 miles from their home to face Bryan Reo and friends' incessant litigation claiming that they have been harmed by what Pastor Lindstedt said about them as public figures as well as agents provocateur over the Internet without showing any real damages whatsoever. Since June 2016 when the Lake County Ohio Court ruled that since Pastor Lindstedt cannot represent his Aryan Nations Church or woman because they made up some law about needing a lawyer to fight other lawyers like Bryan Reo, Pastor Lindstedt has gotten his own ecclesiastical court to rule that if NE Ohio wants to act like Sodom and Gomorrah in running "lawfare" to rob outsiders as was done in the time of Abraham circa 2000 BC then NE Ohio would be treated like Sodom and Gomorrah by chernobyling their ailing old nuclear power plant. Claiming a jurisdiction which doesn't exist is an act of conquest and civil warfare. Claiming conversely that this court's officers who are acting like bandits, rapists and killers against outsiders and then claiming absolutely no responsibility for their conduct under color of law and is protected by the very same courts who armed and equipped them is in itself banditry. Pastor Lindstedt having to get something out today is not going to further belabor the point.
