**DEFENDANTS’ FRCP RULE 59(e) MOTION TO ALTER OR AMEND A JUDGMENT
(Doc 91) TO DISMISS STATE OF OHIO FOR SOVEREIGN IMMUNITY
OR FRCP RULE 60 – RELIEF FROM JUDGMENT OR ORDER (Doc 91)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as “Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt’s Aryan Nations Church) to timely make A Rule 59(e) Motion to Alter or Amend this Court’s ORDER (Doc 91) to dismiss the State of Ohio as a Party to this never-ending Bryan Reo and Reo Family litigation because since the State of Ohio “contends that it is absolutely immune from this suit, and that Defendant fails to allege any plausible claims against it,” (ORDER & OPINION, Doc 91 pID#978). This federal Court also claims Pastor Lindstedt is unable to assert CONstipational claims on behalf of his Aryan Nations Church because he is not an attorney – unlike Bryan Reo and other Ohio licensed attorneys given

a patent of nobility to steal anything and everything before a pack of other legal robbers running wild before their illegitimate tribunal who have given themselves *carte blanche* to do and steal from Pastor Lindstedt and Lindstedt's Church as they please. (Doc 91, pID #983). Insofar as the "material facts" are concerned, Pastor Lindstedt has always denied that he had ever claimed what Bryan Reo has said Lindstedt claimed, especially about "homosexual incest" with someone found out later to be Reo's father or "trans-sexual prostitution" from Reo's wife, neither of whom were ever mentioned by name. Rather Pastor Lindstedt has denied all of Reo's claims **first** in his initial answer and counter-claim, then a **second time** in the amended answer & counter-claims demanded in all four cases because of Pastor Lindstedt's White Supremacist and Dual-Seedline Christian Identity racial, religious and political beliefs written openly in his answers, and **then a third time** when untimely answering all of Bryan Reo's self-serving and conclusatory "Admissions Request(s)" in all four cases. In fact in some of these cases Pastor Lindstedt has shown as exhibits exactly what was published on Lindstedt's Aryan Nations Church web page and Bryan Reo is on record as lying about these genuine material facts. Yet this federal court judge Boyko in fact has dispensed with the 7th Amendment jury trial "guarantee" by deliberate refusal to allow Pastor Lindstedt to "withdraw" his [non]admissions because according to himself and other judges as a non-lawyer Pastor Lindstedt in his abusive "White Supremacist"/"Christian Identity" manner has not done so in a manner that they choose to recognize. In short this Court got the practice of tyranny down pat – far more than they practice rule of law. Looking at the nine pages of legalistic monkey-talk that is this Court's decision in Doc 91 (and all the rest designed to cloak tyranny in the garb of due process) to let the State of Ohio to have one of its and the federal government's agents provocateur as a homosexual mongrel agent provocateur Bryan Reo and its family steal under color of law Pastor

Lindstedt's inheritance given back to his sister Susan Bessman (and for Reo and Lawyers Kyle Bristow and Robert Konrad to extort Pastor Lindstedt's sister's property independent of what Pastor Lindstedt gave her unknowing about Bryan Reo) the only real conclusion to draw by Pastor Lindstedt is the same as drawn in 13 June 2016 – that the State of Ohio must be destroyed if Pastor Lindstedt and Lindstedt's Aryan Nations Church is to exist or prosper. Since the State of Ohio and the federal government act even worse than Sodom and Gomorrah and the other Three Cities of the Plain did in robbing and murdering strangers a half-day's journey under color of law over 4000 years ago in the time of Abraham then since YHWH does not change if today's ZOGlings act like the whiggers and Canaanites of Sodom and Gomorrah then they are to be destroyed like Sodom and Gomorrah. Pastor Lindstedt shall present exhibits that the Lake County courts as well as Bryan Reo and Reo's antifa ZOGbot lawyer friends have been told this since 2016 when they sued Pastor Lindstedt, Lindstedt's woman Roxie Fausnaught, and Lindstedt's Aryan Nations Church in Bryan Anthony Reo 16CV000825 and unto this very day.

Rather Bryan Reo as well as this Court and the Ohio Courts proceed as if they can use their law to despoil Pastor Lindstedt and Lindstedt's Aryan Nations Church and there will be no consequences whatsoever, much less horrific ones which will destroy them and their populations.

Pastor Lindstedt was short on funds and this past month did not keep up with this Court's ORDERS (#91, #92, #93 and #94 in this case) because first he had to make a PACER bill on 8 April, 2021 and did not get this Court's mailing on 8 April these ORDERS out until 12 April 2021. Pastor Lindstedt sent e-filed his FRCP Rule 59(e) concerning Judge Boyko's dismissal of Attorney Kyle Bristow (Doc. 90) on 20 April 2021 along with an Exhibit #1 of Doc 26-1 IRS Short Form 501©(3) Tax Form page 251-254 19 March 2020. Pastor Lindstedt shall e-file this Rule 59(e) to Doc 91 as soon as possible along with the rest of these ORDERS.

LAW AND ANALYSIS

This federal court makes a number of assumptions, none of them valid with respect to political and religious reality. Bryan Reo is NOT a private individual – just one of 100,000 negroid homosexuals living in the Northeastern Ohio around Cleveland, a liberal area altogether different area than the Ozarks of Southern Missouri which has the largest collection of racist wild White Men practicing Dual-Seedline Christian Identity and which is the complete opposite of Northeastern Ohio of anywhere within the ZOG/Babylonian Empire. Bryan Reo is rather a Satanic homosexual mongrel abomination who is well known as an agent provocateur (or as is called “a ZOGbot) which founded the Foundation for the MarketPlace of Ideas full of the mongrels, jews, homos, perverted ZOGbot which brought about the Charlottesville 1.0 disaster and likely the Charlottesville 2.0 / Glorious and Pathetic Sixth of January 2021 anti-Orangeman Bad Democrat Coup. Thus Bryan Reo is not only a public figure within the [bowel] Movement but a known perverted homosexual mongrel state-sponsored antifa terrorist as well. Thus any claim due to being recognized for what it is – especially given that over a decade ago Bryan Reo cut a deal which lasted all of four days to leave the Movement forever and be left alone if it did as agreed – isn’t actionable even under ZOG/Babylonian Mighty Evil Empire “Law.” Bryan Reo is known for the company it keeps which has been displayed in all these Reo v. Lindstedt cases by the IRS 501(c)(3) filing showing the board files of old and new pretend white supremacists, most of them like Bryan Reo neither white nor not perverted. See The Foundation for the MarketPlace of Ideas (FMI) Exhibit Doc 26-1 IRS Short Form 501(c)(3) Tax Form page 251-254 (19 March 2020) recently re-sent in talking about Attorney Kyle Bristow (dismissed as a party by this court in Doc 90).

Bryan Reo has been chasing incessantly Pastor Lindstedt and Lindstedt's Aryan Nations Church by filing all these lawsuits, four of them before this Northern District of Ohio. See **Exhibit #2** Anthony Reo v. Martin Lindstedt 19-cv-02615 Doc. 32-2 Filed 02/01/21 PageID # 409 which shows no less than 16 Bryan Reo v. Martin Lindstedt cases in the past 6 years filed in Lake County Ohio since 18 Sept. 2015. This goes to show that Lake County Ohio, the State of Ohio, and this federal government thinks that it has the jurisdiction to compel known white supremacist Pastor Martin Lindstedt and Lindstedt's Aryan Nations Church 900 miles away and try him and his Church for defaming a homosexual mongrel ZOGbot and after fraudulent legal process in which these hostile courts make up the rules like a den of thieves and murderers akin to the time of Abraham circa 2000 BC like the judiciary of Sodom and Gomorrah and Three other Cities of the Southern Dead Sea Plain by claiming an usurped jurisdiction. **Exhibit #3** Anthony Reo v. Martin Lindstedt 19-cv-2615 Doc 39-3 Lake County Ohio Reo v. Church of Jesus Christ Christian / Aryan Nations of Missouri 16cv000825 showing that both the Lake County and Ohio Appellate Courts claim jurisdiction over Pastor Lindstedt's Aryan Nations Church and the jurisdiction to bring it before their spurious tribunal and be tried.

Contrary to the self-serving notions of both this federal and Ohio state courts that they have any legitimate jurisdiction to try White Supremacist and Aryan Nations pastors and their Churches before their judges and juries hostile to everything that these Aryan Christian Israelites and their Churches stand for, i.e. White supremacy and Dual-Seedline Christian Identity and their claims that we must follow their procedures that we distrust and loathe to be subjected to their corrupt and foul ways, Pastor Lindstedt and Lindstedt's Aryan Nations Church insist that if you proceed that a state of racial and religious civil war is in effect and that we not only have the right but the duty to YHWH and YHWH's Servant Nation of Aryan Christian Israel to not only

resist but to actively take part in this regime's extermination and the putting to the sword their population which cannot be re-assimilated and to enslave those elements which can be reintegrated and to use the North Perry Nuclear Power Plant as a stationary nuclear weapon.

As Exhibit #1 containing the Lake County Order of 7 June 2016 by Judge Collins and the 13 June 2016 response on the Aryan Nations web page shows this position has been in effect since June 2016 when the Mentor Municipal Court disclaimed jurisdiction of the frivolous case Bryan Reo filed before them and the negro judge didn't want his municipal court to hear such Reo drivel so he disclaimed all jurisdiction and Judge Collins usurped it. In this 7 June 2015 Judge Collins claims that Pastor Lindstedt cannot defend his Aryan Nations Church but rather must hire out what Pastor Lindstedt thinks is a literal agent of Satan working for a Satanic regime. That and knuckle under to the sundry self-serving rules of their court without any legitimate jurisdiction to be at the mercy of Bryan Reo incessant "lawfare" i.e. legal civil warfare. As today, see Exhibit 4 **Aryan Nations Press Release** of March 15, 2021 filed by Bryan Reo to further get these corrupt federal courts to do away with all pretense to obeying their so-called First Amendment. Pastor Lindstedt makes it quite clear that using biological weaponry (spreading the ZOG-virus to Cleveland area ZOGLings) or using nuclear weapons (i.e. chernobyling the North Perry Nuclear Power Plant so as to achieve freedom from these local and state and federal courts was a necessary and YHWH-lawful means to fight this racial and religious war of liberation from this Mighty Evil Empire.

Neither Pastor Lindstedt nor his Aryan Nations Church is subject to Lake County Ohio nor to the State of Ohio nor to these federal courts which have promised rule of law and due process but rather have delivered tyranny and oppression by a Satanic homosexual mongrel ZOGbot trying and succeeding in making Pastor Lindstedt and Lindstedt's Aryan Nations

Church destitute from this “lawfare” or legalized civil warfare. Thus Pastor Lindstedt is compelled to make these satanic criminal regimes and their minions stop by slaughtering as many of their subjects until such time as their regimes collapse or their subjects revolt.

This federal court and the State of Ohio are essentially agents of Satan who have allowed an extremely evil known homosexual mongrel agent provocateur and its fellow paid informants and provocateurs who over the past decades have wormed their way into the White Racial Resistance Movement to destroy the lives of the unwary under color of law and made the penalty for speaking out the confiscation of their property and the ending of their lives and liberty. This corrupt federal court has given \$750,000 of my inheritance to Bryan Reo as a reward for legalized civil warfare because I made fun of this abomination and \$500,000 to its wife for my reprinting on the Aryan Nations web page Reos public Quora lament about how it had been deceived because she didn’t want to squeeze out any more satanic mongrel abominations in return for getting to leave Brazil for a place slightly less miscegenated and corrupt. That and how she jumped up and down to try to get the attention of what was thought to be two homosexual mongrels but turned out to be just Bryan Reo and its father, again allotted \$500,000 of my inheritance due to proceedings totally without legitimate jurisdiction. Without any provision for a jury trial due to its interpretation of rules made up to loot and destroy dissident White Aryan Christian Israelites along with their Aryan Nations Churches under color of their pretend treasonous law and under color of their spurious jurisdiction even less valid than that of Sodom and Gomorrah venturing out a half-days journey to rob the caravans between the Red Sea and Babylon of its day. And the negro federal judge has issued a “gag order” to protect the reputation of Bryan Reo as a lawyer and officer of this court in Bryan Reo v. Martin Lindstedt 19-cv-2103

as if all this Bryan Reo litigation can be kept out of the public eye and the farce of an open democracy maintained in the face of legal “lawfare” terrorism and tyranny.

Pastor Lindstedt along with his Aryan Nations Church (and his sister served separately living in Barry or Stone County Missouri 60 miles away somewhere) was just served at 10:15 am with Reo v. Lindstedt, Bessman & Aryan Nations et. Al. 21-cv-00753 about Bryan Reo wanting to make sure that it gets her independent property as well as the inheritance given back to her. Pastor Lindstedt shall of course make the case that this Mighty Evil Empire needs to be torn apart and the more evil portions burnt – like Sodom and Gomorrah.

Bryan Reo was found out by Pastor Lindstedt on Halloween 2010 and outed as a homosexual mongrel and ZOGbot. Over the past seven years Bryan Reo has been waging “lawfare” against Bryan Reo and FMI and other bowel Movement ZOGbots while the Lake County courts have dragged Pastor Lindstedt and his Aryan Nations Church 900 miles away to face a Lake County lynch mob of African she-niggers and gliberal whiggers out to punish the open White Supremacist for being true to their racial and religious beliefs. They imposed \$105,000 against Pastor Lindstedt and \$400 for Pastor Lindstedt’s Aryan Nations Church – presuming to punish them both for holding fast to their racial religion. Since that time the state courts of Ohio, Missouri and South Dakota have gotten involved as the federal court of Ohio presumes to destroy the illusion of the First through Eighth Amendments and “rule of law”.

Pastor Lindstedt hopes that crazed delusional misbegotten satanic creatures will chernobylize the North Perry Nuclear Power Plant. But as policy when this Mighty Evil Empire is torn apart due to stresses like these in which cancerous police organs such as Bryan Reo, Reo’s

family and fellow lawyers are openly destroying their Aryan Christian Israelite Founding Stock Opposition to bring about a New Satanic World Order based upon looting what little remains then the inevitable result shall be this Second Civil War of each against all in which the race-traitor whiggers find that there is no living other than with the Whites communities they have destroyed. These Aryan Nations of the former America will form Ten Thousand Warlords in a voluntary confederation in which if any non-whites are left alive they will be on reservations especially in the irradiated wasteland centered around Nuevo Sodom / Old Cleveland and New Gomorrah-Mentor. Pastor Lindstedt also suggests that the Ohio Supreme Court take up Pastor Lindstedt's and his Aryan Nations jurisdictional appeal and rule that Lake County Ohio never had jurisdiction to hear any Bryan Reo cases against Pastor Lindstedt and Lindstedt's Aryan Nations Church in the first place.

The State of Ohio must answer somewhere for the conduct of officers of its courts and if pretending to have jurisdiction over those not subject other than by conquest then to take the consequences of the Second Civil War leading to Northeastern Ohio becoming an irradiated blasted wasteland in which few survive just like happened to Sodom and Gomorrah four
