**DEFENDANTS' OBJECTIONS TO MAG. THOMAS PARKER'S REPORT &
RECOMMENDATION (DOC 110) TO DISMISS BRYAN REO ATTORNEY (((&
FELLOW FOUNDING BOARD MEMBER OF THE FOUNDATION FOR THE
MARKETPLACE OF IDEAS (A "White Supremacist" "lawfare" ZOG False-Flag NGO)))
ATTORNEY KYLE BRISTOW**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Aryan Nations Church) to timely make An Objection to Mag. Judge Thomas Parker's Report & Recommendation (Doc. 110) to dismiss Plaintiff Bryan Reo's longtime antifa lawyer and board member for The Foundation for the MarketPlace of Ideas (FMI) See Doc 26-1 IRS Short Form 501(c)(3) Tax Form page 251-254 19 March 2020) and long-time "White Supremacist" pretending lawyer and still on the edges of the Movement Attorney Kyle Bristow. This Report and Recommendation was dated 28 May 2021,

mailed out on 2d June 2021 according to the postmark and received by Pastor Lindstedt on 7th June 2021 but since this matter has been the same thing – that this federal regime is not about rule of law but rather rule by lawyer – and that one of this dying federal regime’s police state agents provocateur such as Bryan Reo and Reo’s antifa lawyer friends pretending to be White Supremacists can persecute genuine dissenters and take away their lives, liberty and property under color of their law through legal tyranny – then of course absent “absolute proof” an officer of this court such as Kyle Bristow gets away with being an agent provocateur along with Bryan Reo. In short, this federal as well as state courts get to drag Pastor Lindstedt and Lindstedt’s Aryan Nations Church across state lines 900 miles away and proceed to under color of their “law” proceed to do away with the First Amendment (as Bryan Reo and Kyle Bristow and the rest of the Reo third-party counter-defendants are public figures within the white supremacist Resistance Movement and indeed agents provocateur (known as ZOGbots) for Pastor Lindstedt calling them out, and this Court proceeds to also do away with the 7th Amendment “guarantee” of a jury trial and the 8th Amendment “guarantee” of no excessive fines.

Thus this Court is treading the well-worn path of other Mighty Evil Empires of setting up agents provocateur (and not even Aryan but rather mixed-race mongrels and homosexuals like Bryan Reo and Kyle Bristow and Richard Spencer) to furnish a pretext for tyranny and then before its own corrupt courts proceed to tyrannical proceedings to dismiss the counter-claims against its own workers of iniquity while destroying the lives of this regime’s opposition. Thus this Court is an enemy combatant acting under color of law to destroy the Founding Stock by disposing of this Founding Stock’s natural leaders and protectors. Magistrate Parker merely raises up the pretense that just because Pastor Lindstedt does not repeat the “magic monkey-talk” but rather raises the same arguments that Attorney Kyle Bristow working along with Bryan Reo

and other well-known agents provocateur from the Foundation for the MarketPlace of Ideas (henceforth FMI) See Doc. 97-1 FMI 501(c)(3) Tax Form as an agent provocateur and in collusion with Bryan Reo to destroy Pastor Lindstedt's sister as well. See Doc. 97-2 e-mail sent.

Thus Mag. Parker's Report & Recommendation is merely something to be expected from a judicial officer out to protect this dying and imploding criminal regime and its fellow officers of this court who are working as agents provocateur acting against genuine "white supremacist" political and religious and racial leadership such as Pastor Lindstedt and Lindstedt's Aryan Nations Church. Bryan Reo and Reo's antifa lawyer ZOGbots get to destroy Pastor Lindstedt and Lindstedt's Aryan Nations Church and family and this Court will of course protect its agents provocateur and fellow parasitical lawyers and claim that their legalistic pretexts as somehow "law" to be obeyed even by those subjected to it without any lawful and legitimate jurisdiction.

Attorney Kyle Bristow, Brett Klimkowsky & Bryan Reo have been ZOGbots together

Hello:

We have a mutual friend in Brad Griffin, whose web page got me your name.

I have a mongrel named Bryan Reo who has been stalking me for years living in Mentor Ohio. He's filed lawsuits against me in Lake County Ohio and I've counter-sued. I might need representation in Ohio.

Within an hour at 1:42 pm 9 Feb Attorney Bristow sent me back the following declination:

Dear Pastor Lindstedt:

I appreciate Brad having referred you to me and I am always eager to help political dissidents

with their legal problems, but unfortunately, per MRPC 1.16(a)(1) and Prof. Cond. R. 1.16(a)(1), the Michigan and Ohio Rules of Professional Conduct, respectively, prohibit me from representing you for purposes of your controversies with Bryan Reo because a conflict of interest exists. **Specifically, Reo works for me as my law clerk.**

At this time Bryan Reo, Kyle Bristow and Brett Klimkowsky were forming up with other Movement leaders and lawyers what became known as the Foundation for the Marketplace of Ideas in early 2016. They didn't want for it to get out that Bryan Reo working with Kyle Bristow was suing myself and my Aryan Nations Church and filing a fraudulent Civil Protection Stalking Order against Pastor Lindstedt as that would interfere with their "Unite the Right" pretense leading to Charlottesville 1.0 in August 2017 and litigating for Richard Spencer against sundry public universities. Brett Klimkowsky was about to become Bryan Reo's lawyer for purpose of fraudulent Telephone Consumer Protection Act litigation in Lake County and this federal district court. In Pastor Lindstedt's Exhibit #1 is the typical racist boiler-plate however it does go to show that Pastor Lindstedt thought that Attorney Kyle Bristow would do a consultation with Pastor Lindstedt and the forced revelation that Kyle Bristow and Bryan Reo were working together to inform and destroy the above-ground white nationalist movement as ZOGbots. The majority of the posting was put up the next day, Feb 10, 2016 as Pastor Lindstedt did research and made inquiries and posted the result to Pastor Lindstedt's Aryan Nations web page. The picture of Bryan Reo from 2015 was done before Bryan Reo as an agent provocateur had plastic surgery on its negroid lips and facial features and skin lightener on its pelt to pass for white better. This is exactly the sort of investigative reporting that this federal court is placing a gag order upon and violating the 1st, 7th, and 8th Amendments to punish, is Pastor Lindstedt blowing the whistle on its agents provocateur such as Bryan Reo, Kyle Bristow, and others. In short, this tyrannical criminal regime is waging a Second Civil War against "White Supremacists" and

“Aryan Nations” by bringing them 900 miles away to hale them before their corrupt regime courts sometimes with a biased prejudiced jury of non-whites and gliberal whiggers and before these federal courts with no jury whatsoever. These regime courts in Ohio (and elsewhere) both at the state and federal level, have thus not only deployed agents provocateur like Bryan Reo and Kyle Bristow (and Brett Klimkowsky) trying to gain access to the underground genuine white supremacist movement which is doubtless waiting to destroy critical infrastructure upon which millions of urban non-whites rely in order to live but to aid in spreading diseases (such as the Covid ZOGvirus made in a Chinese lab with US funding) which will destroy the very foundations of the current failing and dying System.

Attorney Kyle Bristow simply is a ZOGbot lawyer working for and with Bryan Reo. Judging by appearances and past history, it seems that Kyle Bristow is also Bryan Reo’s Aryan hump, as Bryan Reo is a consummate homosexual blackmailer of those Reo thinks is Aryan like “Victor Switzer” of Pine Bluff Arkansas or Johnny “Tonto” Britton nephew of Neumann Britton the former Aryan Nations pastor from Idaho. When they were revealed as mongrels Bryan Reo stalking and extortion for theys’ man-pussy ceased. For this court to use weasel-legalisms to protect their own officers of their courts engaged in espionage against hidden or open “White Supremacists” either imaginary as with their FMI ZOG-scam or real as with Pastor Lindstedt and his Aryan Nations Church is an act of treason against the Founding Peoples of the consolidated United States and will be treated as what is inevitable in this Second Civil War. Thus this court in protecting its own operative doing its job of tyranny is not surprising. Also not surprising is that Pastor Lindstedt hereby objects to this legalistic fraud perpetuated by this court.

Pastor Lindstedt since 13 June 2016 has called for the “chernobylization” of the North Perry Nuclear Power Plant as the standard YHWH-penalty for the Sin of Sodom-Gomorrah

which was kidnapping strangers passing well outside their jurisdiction and dominion, imposing upon them spurious legal process designed to rob, rape and murder and basing their judicial code upon this injustice. Act like Sodom and Gomorrah then get treated like Sodom and Gomorrah. An old and aging nuclear power plant that didn't due due-diligance and hired a crazed homosexual mongrel with delusions of being white and Aryan Christian Israelite and sexually normal such as Bryan Reo is a place where perhaps genuine white supremacist actors can be insinuated or its control systems hacked to somehow melt down this nuclear reactor to irradiate a portion of the country so hostile to white men who want to live in peace but cannot due to the lust to dominate and destroy YHWH's Servant Nation of Aryan Christian Israel.

However, even if before complete collapse this nuclear power plant on the shores of Lake Erie and upwind of Northeastern communist states can't be chernobylied then as policy to ensure that this level of tyranny never happens again, strategic considerations say that this nuclear power plant must be chernobylied so that this area of the country can never ever dictate to another area of the former country that its citizens be dragged off before foreign corrupt courts and have their lives, liberty and property taken to suit that criminal regime. Thus if Northeast Ohio becomes a nuclear-irradiated wasteland in which only a few diseased and sick survivors out of millions are able to eke out a miserable existence as the rest of the former ZOGland is divided into Ten Thousand mini-states ruled by local military racial dictatorships then that is to be done. Therefore in the end Northeastern Ohio must and shall be destroyed because of being made an example of as was Sodom and Gomorrah. They ought to know better than to take a genuine white supremacist and his Aryan Nations Church and presume to try them simply because a homosexual mongrel agent provocateur and his ZOGbot lawyer friends and handlers wanted to

under color of law try Pastor Lindstedt and his Aryan Nations Church without any legitimate jurisdiction other than that made up by their corrupt state and federal courts.

Furthermore, the overall banditry of this System is that all over this ZOGland that such as Bryan Reo was and is able to take property outside of Northeastern Ohio such as Pastor Lindstedt's inheritance in South Dakota. In fact Bryan Reo and Bryan Reo's attorney Robert Konrad and Pastor Lindstedt's sister's former attorney were extorting Pastor Lindstedt's sister to not only terrorize her into giving up what Pastor Lindstedt transferred up to her but her own inheritance as well. Lawyers insist that this "common-law" system in which lawyers and judges make up the law to suit themselves and from which they have barred all non-lawyers as nothing other than victims enables them – as in South Dakota, Ohio and Missouri and everywhere – to make a summary judgment and take property under color of their law which they made up. In reaction in order to get to a civil law system in which everyone is under the law and everyone knows what the law is it will become necessary to exterminate and sterilize these parasites who claim to be the law. However, the reversion to medieval living will not take place until the surplus population is eliminated in this Second Civil War and an authoritarian order established.

Lastly, as with Attorney Brett Klimkowsky who has evaded service and thus has agreed that since he doesn't want to take personal responsibility for his acts of barratry and corruption working with and on behalf of Bryan Reo working for this criminal regime both state and federal, then the Biblical law said that upon being caught and made to confess the entire family of the regime criminal or enabler of treason and tyranny against the People is to be "cut off" or destroyed with extreme prejudice. Attorney Kyle Bristow is known to the underground Movement. Since Kyle Bristow doesn't want to be responsible for his crimes, then it must be his

friends and family which are made liable for his crimes. There are no innocents in a religious and racial civil war – only sides. And Pastor Lindstedt is mindful of Attorney Kyle Bristow's 28 April 2020 threat in conjunction with Bryan Reo to render Pastor Lindstedt's sister "destitute" as they have done to Pastor Lindstedt and Lindstedt's Aryan Nations Church. Again, Pastor Lindstedt objects to Mag. Parker's Report and Recommendation (Doc 110) to excuse Attorney Kyle Bristow – the suspected homosexual lover and proven associate of Bryan Reo as an agent provocateur – from Pastor Lindstedt's counter-suit.
