Opposition Motion to Mag. Parker's Doc. 105 Report & Recommendation Agreeing that the State of Ohio can't be sued before State and Federal Ohio Courts because they have "Sovereign Immunity" and Can Do Anything They Want to Pastor Lindstedt and His Aryan Nations Church at the Whim of ZOGbot Attorney Bryan Reo Working, As One of Their Agent Provocateurs

DEFENDANTS' OPPOSITION AND OBJECTIONS TO MAG. PARKER'S REPORT & RECOMMENDATION (Doc 105) GRANTING THIRD-PARTY DEFENDANT STATE OF OHIO SUMMARY JUDGMENT TO DISMISS BECAUSE THEY AS A STATE ARE ABOVE THEIR OWN RULE OF LAW AND CAN DO WHATEVER THEY PLEASE BY ALLOWING THEIR OWN OFFICER OF THEIR COURTS AND AGENT PROVACATEUR BRYAN REO TO DRAG TO THEIR COURT PROCEEDINGS PASTOR LINDSTEDT AND LINDSTEDT'S ARYAN NATIONS CHURCH FOR CIVIL "LAWFARE" PROCEEDINGS ABSENT ANY REAL OR LEGITIMATE JURISDICTION

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt) OF THE Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter described as Pastor Lindstedt's Aryan Nations Church): to timely make an Objection to Magistrate Parker's Report & Recommendation (Doc. 105) of 11 May 2021 which recommends granting and upholding the lawless ORDER by Senior Judge Boyko Court's ORDER (Doc 91) to render summary judgment to dismiss all claims against third-party

Defendant State of Ohio on the grounds that since Pastor Lindstedt and Lindstedt's Aryan Nations Church lives under their Mighty Evil Empire and that as a Sovereign State being above the law that Ohio can not be taken to task because they allow longtime homosexual mongrel and federal agent provocateur harassing Pastor Lindstedt before the state and federal Ohio courts to file 10, 15, 20 lawsuits against Pastor Lindstedt and his Aryan Nations Church thus impoverishing Pastor Lindstedt and stealing his inheritance in South Dakota and property in Missouri courts based upon Bryan Reo's civil "lawfare" in Ohio courts. See Exhibit 98-3 in this case showing 16 Bryan Reo cases and counting against Pastor Lindstedt and Lindstedt's Aryan Nations Church including two fraudulent "Civil Stalking Protection Orders" one dating from last year in which Bryan Reo gets to file case after case until he wins the "legal jackpot" like before these corrupt federal courts. Neither the State of Ohio nor the federal government take any responsibility for what to do about one of their officers of their courts using their color of law to harass and destroy those outside its jurisdiction such as federal agent provocateur Bryan Reo and Reo's family and fellow agents provocateur pretending to be white supremacists.

There is of course Biblical precedent as what the righteous can and should do about a tyrannical regime ruling over the People and the birth certificate of this nation the Declaration of Independence can also function as a death warrant for secession and civil war. Pastor Lindstedt has often mentioned the precedent of what happened to Sodom and Gomorrah for their judicial murders over those outside their jurisdiction under color of their made-up law. Doc 98-1 and 98-2 show that Pastor Lindstedt was advocating since 13 June 2016 "chernobyling the North Perry Nuclear Power Plant" where Bryan Reo used to work and got fired from upon detection thanks in whole or part of "SwordBrethren = Bryan Reo" on Pastor Lindstedt's Aryan Nations Church web page. It would be so nice for this State of Ohio and federal criminal regime and for other states to

have responsibility for the lawyers they let prey upon the People. However today Pastor Lindstedt is asking for a legal solution for this Court to rein in Bryan Reo while understanding that there is probably no peaceful legal solution but rather one of punishing the People who support an Evil Tyrannical criminal regime.
