**DEFENDANT REQUESTS CONSIDERATION TO APPOINTMENT OF CIVIL PRO  
BONO PANEL ATTORNEY TO COMBAT BRYAN REO ABUSE OF LEGAL  
PROCESS. (Doc. 10, ORDER)**

COMES NOW the current Defendant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") of the Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter Lindstedt's Church) to make a timely filed Objection to Magistrate Judge Parker's REPORT & RECOMMENDATION (Doc. 11) of 10 Dec. 2019. The letter from this Court arrived four days later on 14 Dec. 2019, which is standard for mail having to go 853 miles from Cleveland to Granby Missouri. This Answer will take three or four days to arrive back. If Pastor Lindstedt had Electronic Filing (ECM) to counter the innumerable Bryan Reo Motions to Strike which are inevitably coming in this one of four Bryan Reo & Reo Family & Friends, then Pastor Lindstedt would have a more level playing field to practice his counter-barratry fire upon.

Pastor Lindstedt has had to fight with Professional Plaintiff Bryan Reo for a decade of Bryan Reo as a non-white non-heterosexual federal agent provocateur trying to worm its way into the White Supremacist and Christian Identity racial and religious Resistance Movements and until this year Lindstedt was able to fend Reo off by being publicly blunt as to Reo's motivations and activities and posting it on Church web pages. However, this First Amendment strategy of being honest in trying to fend Reo off no longer works due to Lake County Courts usurping jurisdiction by allowing Bryan Reo to regulate the Internet over what is said about Bryan Reo and so, having had to move this case, along with three other Reo and Reo family lawsuits trying to steal Pastor Lindstedt's inheritance from Lake County to this federal district court in Ohio, it is time for Pastor Lindstedt to admit to mistakes and modify his approach as necessary.

Therefore Pastor Lindstedt asks for leave to modify or amend his Answer & Counter-Claims against Bryan Reo, Bryan Reo's wife and father, Bryan Reo's attorney friends and fellow board-members of the 501(c)(3) pseudo-White Supremacist crypto-antifa "lawfare" corporation "Foundation for the MarketPlace of Ideas" Attorneys Kyle Bristow and Brett Klimkowsky. To drop Pastor Lindstedt's Church of Jesus Christ Christian / Aryan Nations of Missouri as a party but to joinder the Lake County Ohio Court of Common Pleas / Judge Patrick Condon for violation of Pastor Lindstedt and Lindstedt's Church's First Amendment civil rights under 42 U.S.C. 1983, as well as the State of Ohio and the U.S. government for running informants / agents provocateur like Bryan Reo and his attorney friends.

Pastor Lindstedt was forced to amend his Answer and Counter-Complaint by Judge Oliver in the first of these Bryan Reo "dialing for dollars" litigation (*Reo v. Lindstedt* 19-CV-02103) and has cut things down a bit in *Anthony Domenic Reo v. Martin Lindstedt* 19-CV-02615 (Reo's father) and *Stefani Rossi Reo v. Martin Lindstedt* 19-CV-02786 (Reo's wife). There is

absolutely no way for any of Pastor Lindstedt's pleadings which will keep Bryan Reo from making Motions to Strike and for Summary Judgment and for something from this Court which will hand over under color of law to Bryan Reo some or all of Pastor Lindstedt's life, liberty or property. However if this Court wishes to make Bryan Reo have to present a case to a jury that Pastor Lindstedt calling truthfully limited-purpose public figure Bryan Reo a "non-white homosexual federal agent provocateur playing White Supremacist" is actionable while Bryan Reo calling Pastor Lindstedt since 2010 until this very day a "convicted child molester" is not, then Magistrate Parker is well served by Pastor Lindstedt filing an amended complaint.

If it is determined that Pastor Lindstedt simply is unable for whatever reason to file the sort of legal monkey-talk which supposedly glosses over abuse of pseudo-legal process, then Magistrate Parker would be better served after giving Pastor Lindstedt another chance to amend his Answer & Counter-Claim and then finding out that there is no polite or civil manner in which to call a delusional non-white homosexual agent provocateur posing as an Aryan White Supremacist and Christian-Identity sub-pastor anything other than what Bryan Reo is, to remind Magistrate Judge Parker that Parker was to "shall also give due consideration to appointing an attorney from the Court's Civil Pro Bono panel" as Judge Boyko ORDERED, Doc. 10, page 1. If after trying to Amend his Answer and Counter-Complaint it is shown that Pastor Lindstedt cannot render sufficient legal monkeytalk to suit Bryan Reo's deceitful standards of pleading then it is time to get another legal monkeytalker to file counter-motions to strike as they see fit. Bryan Reo files these motions in the other cases Bryan Reo files, sometimes against corporate attorneys. This pro bono attorney / legal monkeytalker will of course not seek to go after the other people and regimes that enable Bryan Reo as a regimeist agent provocateur and will stick only to Bryan Reo's spurious claims that Bryan Reo gets to call Pastor Lindstedt a convicted

child molester and never-mind that Bryan Reo is a non-white homosexual antifa bothering real White Supremacists and their racist Churches and that Bryan Reo wants all their stuff. By all means let the lawyers deal with their legalisms by themselves and leave Pastor Lindstedt and Pastor Lindstedt's Church out of it. Rather than Bryan Reo, Reo's family, Reo's fellow lawyers, Lake County, State of Ohio, federal government, etc. being sued everything gets better when Bryan Reo gets disbarred. This also keeps the legal monkey-talk limited to the legal monkeys and not out amongst the unruly subjects of the Mighty Evil Empire. Pastor Lindstedt would welcome a negotiated end amongst you federal lawyers to being Professional Plaintiff Bryan Reo's Professional Defendant of Choice.

Wherefore, Pastor Lindstedt requests rather than a Motion to Strike everything in Pastor Lindstedt's admittedly flawed Answer & Counter-Claim to instead Pastor Lindstedt making an amended complaint and counter-claims against Bryan Reo, the Reo family, and Reo lawyer friends for this "dollar-mining" fraudulent lawsuit by Bryan Reo and family and friends and to joinder other Reo defendants, State of Ohio and federal government and for this process to continue to settlement or trial and then, if Pastor Lindstedt's second or third attempts to drafting up sufficiently legal monkey-talk proves inadequate, for this Magistrate Judge to obey the Court ORDER (Doc. 10) and to "give due consideration to appointing an attorney from the Court's Civil Pro Bono panel."

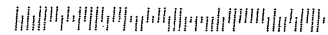
