**DEFENDANTS' THIRD OR FOURTH ANSWER/MORE DEFINITE STATEMENT TO  
BRYAN REO'S FOURTH OR FIFTH VEXATIOUS & FRIVOLOUS MOTION FOR A  
MORE DEFINITE STATEMENT OF 21 MARCH 2016**

COMES NOW on April 4<sup>th</sup>, 2016 the current Defendant Pastor Martin Lindstedt along with Lindstedt's non-profit church corporation in good standing The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter in person described as "Pastor Lindstedt" and the Church corporation referred to as "Pastor Lindstedt's Church") to file this Answer and/or More Definite Statement to Bryan Reo's evasion of giving an answer under Ohio Rule of Civil Procedure 12(2) by fraudulently claiming that Reo simply cannot understand Pastor Lindstedt's Ordered Answer & Counter-Claim filed with Reo January 6, 2016 and filed with the Court on January 7, 2016. Rather Bryan Reo chose to file a flurry of Reo-Motions to Strike and a perjurous and fraudulent civil stalking case before this Court, *Reo v. Lindstedt*, 16CS000102. Thus Bryan Reo, instead of obeying Ohio Rule 12(2) by filing an Answer within 28 days of Jan. 7<sup>th</sup>, chose to file yet another dilatory and fraudulent Motion for a More Definite Statement for the second and third times, this time yet again on 21 March 2016.

In this latest filing – once or twice per month Bryan Reo files some motion to strike or demand for more definite statement or something in order to "churn" up some demand for a largely indigent Pastor Lindstedt and Lindstedt's non-profit Church corporation to have to appear



900 miles away before this lax and corrupt Lake County Court – Bryan Reo whines that somehow the Court-Ordered Amended Answer and Counter-Complaint Pastor Lindstedt was made to file to Bryan Reo on 6 Jan 2016 (and acknowledged by Bryan Reo) and filed before this Court on 7 January 2016 is somehow defective. Using the exact same numbering as Reo’s Complaint paragraphs Pastor Lindstedt answered at length and made a counter-claim of Bryan Reo and Bryan Reo’s co-conspirator co-counter-defendants. (The Lake County civil complaint of Sept. 18, 2015 was much as was used in Bryan Reo’s bogus DMCA federal civil complaint before the Northern District of Ohio and the Western District of Missouri for \$10.75 million and was dismissed as frivolous and baseless on Sept. 10, 2015 and which presently is before the 8<sup>th</sup> U.S. Circuit Court of Appeals asking that Bryan Reo be prosecuted and imprisoned for abuse of the Digital Millennium Copyright Act (henceforth the DMCA) and that the DMCA be declared unconstitutional as it allows creatures such as Bryan Reo to take down religious and political Internet communications.) Bryan Reo can’t answer because Bryan Reo don’t have a valid case.

The time has long passed for Bryan Reo to make an effective or timely reply answer to Pastor Lindstedt’s Answer and Counter-Claim. So Bryan Reo continues to do what Bryan Reo knows best, namely make fraudulent, frivolous and vexatious motions to strike and claims that what Bryan Reo cannot answer is somehow the fault of Pastor Lindstedt because Bryan Reo says that it is. Just as Bryan Reo couldn’t answer Pastor Lindstedt’s appellate brief before the 8<sup>th</sup> U.S. Circuit Court of Appeal, or Pastor Lindstedt’s written objections to the fraudulent and bogus civil stalking charge that this idiotic and corrupt Lake County Court charged Pastor Lindstedt with *in absentia* (Reo v. Lindstedt #CS16000102) in which this Court claims that what Bryan Reo likely itself put on another forum owned by other parties was an “immanent death threat”, so too is Bryan Reo unable to admit that this particular case is nothing more than harassment and oppression against Pastor Lindstedt and Pastor Lindstedt’s Church.

Way back in early 2010, one Howard “Buck” McHugh informed Pastor Lindstedt that this particular mongrel homosexual calling itself “SwordBrethren” pretending to be a “white supremacist” and Christian-Identity sub-pastor working for two jews named William Finck and “Eli James” / Joseph November wasn’t white or heterosexual. Buck McHugh gave Pastor Lindstedt the details other than the real name and street address of “SwordMamzer” – as Pastor Lindstedt nick-named the vicious mongrel abomination. Eventually due to William Finck’s stupidity and arrogance, Pastor Lindstedt found out the real name of “SwordMamzer” to be Bryan Reo, the public Facebook profile picture (which was Bryan Reo’s 2004 Mentor High

Whereupon Bryan Reo and Reo co-conspirators took down 10-12 of Pastor Lindstedt's and Lindstedt's Church's Internet web pages, forums, blogs, etc. Upon finding a free-speech web hosting company in CrisisHost.com, for nearly three years Pastor Lindstedt's Church had Internet access, until Bryan Reo threatened CrisisHost with bogus litigation before this corrupt and incompetent and absent jurisdiction local Lake County Court, and so CrisisHost caved. However, Pastor Lindstedt found a sterner web host which has an actual legal staff which will finish off Bryan Reo in a heartbeat and doesn't listen to Bryan Reo's complaints of litigation.

However, before this incompetent and corrupt and foolish local Lake County Court, Bryan Reo has two frivolous and fraudulent cases against Pastor Lindstedt and forty other persons / corporations, in which Bryan Reo threatens to file these myriad motions which this Court will apparently take seriously – eventually to its detriment and legitimacy. Pastor Lindstedt answers most of Bryan Reo's nonsense, posts these answers to the Church web page, researches the judges involved, and then trashes them out as they are public figures. It is but a matter of time before Bryan Reo shoots up an elementary school or community college or is cornered by the police and this Lake County Court is deemed an enabler of the next Adam Lanza or John Paul Gacy or Jeffrey Dahmer or Bryan Reo. This case might well stretch on for years in appeals and before the federal courts, but it will be before the Internet forever. This Court and the reputations of its judges will be sullied by association with Bryan Reo forever.

Everything that Bryan Reo complains about from 2010-2014 is thus past the Ohio Statute of Limitations. The 2015 events are from Pastor Lindstedt publishing the public record events of a federal lawsuit Bryan Reo lost, and thus not actionable. The rest is Bryan Reo delusion as to what the law says and Bryan Reo "thinking" that it can win millions by filing these frivolous motions. This Court would do well to simply flush the toilet on this case by *sua sponte* dismissing the action on the basis of lack of jurisdiction and assessing the costs to Bryan Reo.
