**DEFENDANTS' STATEMENT AGAINST AN EXPENSIVE AND UNNECESSARY
CASE MANAGEMENT CONFERENCE WITH ALL PARTIES PRESENT FOR
PURPOSE OF BRYAN REO'S CRIMINAL CONSPIRACY USE THE LAKE COUNTY
AND MENTOR MUNICIPAL COURTS TO HARASS PASTOR LINDSTEDT AND
LINDSTEDT'S CHURCH UNDER COLOR OF LAW**

COMES NOW on April 4th, 2016 the current Defendant Pastor Martin Lindstedt along with Lindstedt's non-profit church corporation in good standing The Church of Jesus Christ Christian / Aryan Nations of Missouri (hereafter in person described as "Pastor Lindstedt" and the Church corporation referred to as "Pastor Lindstedt's Church") to file this Answer to Bryan Reo's Motion for a Case Management Conference filed, along with two other frivolous and vexatious motions on 21 March 2016. Today, on April 4, 2016, Pastor Lindstedt also received certified mail for himself, The Church of Jesus Christ Christian / Aryan Nations of Missouri, and for Roxie Fausnaught, a director of the above non-profit church corporation, a summons and civil complaint by Bryan Reo complaining about what the Church web page says about these numerous and harassing cases by Bryan Reo. Bryan Reo also recently filed a frivolous motion before the U.S. District Court for the Western District of Missouri concerning Pastor Lindstedt posting a Youtube video in which the Church refused to endorse Donald Trump and in which Reo claimed that Pastor Lindstedt and Lindstedt's Church violated some 501(c)(3) provisions against churches not endorsing or not presidential candidates. Pastor Lindstedt's Church isn't a

501(c)(3) organization which solicits donations of tithes, but rather is a work of faith and teaching known principles of Dual-Seedline Christian Identity, which says that jews and mongrels and homosexuals like Bryan Reo have no place within the Body of Christian Israel. In any case, the documents concerning Pastor Lindstedt's Petition for the U.S. Judge to Refer Bryan Reo to the U.S. Attorney's Office for Bryan Reo Perjury and Fraud (March 28, 2016) along with exhibits is presented to this Court as well as to others in state and federal law enforcement.

Bryan Reo got another branch of this Lake County Court to grant it a "civil stalking protective order" which was based upon fraud and perjury in which Bryan Reo posted death threats against itself on a forum not owned or controlled by Pastor Lindstedt or Lindstedt's Church, in Reo v. Lindstedt CS16000102. Magistrate Adrienne S. Foster refused to allow Pastor Lindstedt to appear via telephone to challenge Bryan Reo's perjury and fraud and rendered a default judgment against Pastor Lindstedt, who has never ever gone to Lake County. Bryan Reo thus presents to this Lake County Court this fraud and deceit rubber-stamped by another judge Carlotta as some sort of fact when the results are that this matter will be further litigated before the Ohio and Federal Courts for years – unless Bryan Reo goes postal or law enforcement arrests Reo and Reo's father for perjury.

Bryan Reo has also been filing dozens of frivolous motions and insofar as discovery is concerned, refused to accept Pastor Lindstedt's discovery based upon Bryan Reo's works and then simply lied and evaded making an honest and full disclosure given that Bryan Reo doesn't have a case. None of this perjurous drivell needs addressing.

Furthermore, there are other parties, namely Bryan Reo's co-conspirator co-counter-defendants, especially William Finck and Melissa Epperson, who have been duly served and who, like John Britton, live hundreds or thousands of miles away. They would have to personally appear for a conference before this Court if they were not allowed to participate by telephone. In fact, William Finck and Melissa Epperson admittedly sought and were given unauthorized practice of law by Bryan Reo, as Reo admitted and Magistrate Roll chided.

Lastly, Bryan Reo's motivations are amply revealed in Reo's e-mail of Monday January 11, 2016 @ 11:29 pm to Pastor Lindstedt's associate e-mail of JohnReitney@gmail:

Exhibit #1, Case # 3:14-cv-0593-MJW (WDMo) Document #60-3 Pages 1-5:

“Apparently you have the time to make outrageous youtube videos and discuss this case at length but you have a deficit of time when it comes to cooperating with discovery. How you use your time is entirely your business, **but these discovery issues will necessitate motions to compel and motions for sanctions and it is likely that you will have to make a half-dozen, or more, appearances in person, in court in Lake County** because of these discovery issues.

I would also submit to you that the magistrate never said I was engaged in the unauthorized practice of law viz a viz Mr. Finck or his girlfriend. The magistrate cautioned me not to venture into that issue viz a viz my father. If you insist on libeling me and casting the issue in a false light then **I am perfectly willing to file a new lawsuit against you for this fresh libel, whether the case will be filed in Mentor Municipal Court or Lake County Court of Common Pleas.** Then you may will have two cases to make outrageous youtube videos about.


I would ask that you attempt to conduct yourself in a professional and dignified manner and show the court the respect that it is due as an institution of justice in our American legal system.”

Bryan Reo thus makes it quite clear that it intends to abuse legal process before this Lake County Court to oppress under color of law Pastor Lindstedt and Lindstedt’s Church. Whether this Court is part of Reo’s criminal conspiracy will beome a matter of something to be decided before a federal court. While Pastor Lindstedt admits that this Court and its judges have “absolute immunity” from civil litigation they do not enjoy immunity from declarative and injunctive relief or from criminal prosecution if warranted.

Therefore, given that Bryan Reo has shown perjury to this Court, and that the purpose of Reo’s Motion for Case Management, Pastor Lindstedt recommends that an arrest for perjury be made against Bryan Reo, Bryan Reo’s father, and that this case be summarily dismissed with all costs to be borne by Bryan Reo along with \$25,000 in damages in favor of Pastor Lindstedt.

A copy of this motion, along with exhibits, is hereby presented to the docket of Reo v. Lindstedt, CS16000102, so that they can negate their corrupt decision because this matter is going to be made public.
