RESPONSE TO BRYAN REO'S LATEST MOTION TO STRIKE

Bryan Reo, Neverending Plaintiff in fraud, filed a Motion to Strike Roxie Fausnaught's Correspondence to this Court, in whole or in part on March 13, 2017 and contrary to its sworn statement on the Certificate of Service on Page 6 didn't mail it off until Wednesday, March 15th. All this is typical of Bryan Reo behavior before this local Lake County Court of absolutely zero jurisdiction over what was truthfully said about Reo being a perverted mongrel ZOGbot pretending to be a White Supremacist and Dual-Seedline Christian Identity pastor over the Internet whether it was seven years ago or seven days ago. Bryan Reo simply lies incessantly.

Bryan Reo claims that in its corrupt dance before this corrupt court of absolutely zero jurisdiction that Roxie Fausnaught didn't obey the Ohio Rules of Civil Procedure and Local Rules of this corrupt local Court. That is for once quite true. Roxie Fausnaught couldn't find them or if given them by Pastor Lindstedt couldn't read or understand them, and her writing abilities are even worse than her reading comprehension. Bryan Reo has deliberately filed an abusive and fraudulent action against Roxie Fausnaught as an agent of The Church of Jesus Christ Christian / Aryan Nations of Missouri, an incorporated Church Corporation in good

standing by the Missouri Secretary of State and without any funds other than provided out of Pastor Martin Lindstedt's own pocket. This corrupt court has breached the jurisdictional wall by making summary decisions against said Church, whereupon said Church set up a sub-corporation – The Lake County Geldings and Walking Wombs – to enslave and sterilize the families and children of Lake County and Ohio lawyers, politicians, judges, police, etc. upon gaining power to do so. You all will surely deserve the harshest of consequences for doing evil.

When the mail arrived 20 March 2017 bearing Bryan Reo's latest Motion to Strike, Pastor Lindstedt made yet another video to put out on Youtube once the worst/best of the racism is bleeped out.

The facts are is that Roxie doesn't read much of anything, much less what is written about Bryan Reo. She has her own computer in which she plays Slotomania, Candy Crush, and other games. She is unable to walk. Taking her to her doctor in early February 2017 she was unable to get from the van into the doctor's office and the doctor had to go outside to consult with her in the parking lot. She got really sick afterwards and forgot to take her Type II diabetes medications and nearly died of a diabetic coma the next night. Since she is hard to take 10 miles to Neosho to see a doctor there is no question of her being able to be taken 900 miles to Lake County Ohio. She has an appointment to see a primary care physician in Neosho to prescribe her basic medications on March 28th, and Pastor Lindstedt as her only and primary care giver will have to take her there and so neither of us will be able to attend other than by telephone the March 29th @ 2:30pm EDT Case Management Conference scheduled by this Court. However, even though this Court has absolutely no jurisdiction over us, we shall call in to hear what's up.

Bryan Reo initially filed this particular case as part of a never-ending harassment action before the Mentor Municipal Court. That court acknowledged to Pastor Lindstedt that Bryan Reo files these frivolous and abusive actions in order to extort and steal and harass its numerous enemies and victims, but rather than simply end it all by making a summary judgment against Reo, they chose to kick the matter up to the county to this Court. This Court, acting in concert with Bryan Reo, has claimed that Pastor Lindstedt cannot represent his domestic partner of thirty years or his Church Corporation because Ohio judges want Ohio lawyers to feed upon the lives of those outside its proper jurisdiction in Ohio and Lake County.

However, Pastor Lindstedt, seeing this legal monkeytalk by Bryan Reo asked Roxie Fausnaught to write something else so Bryan Reo could clog this Court with even more legal monkeytalk and put it up on the Internet to expose this Court to further contempt and ridicule.

“Here Dear, Write something so that Ol’ Niggerlips and its crooked legal buddies Attorneys Kyle Bristow and Brett Klimkowski, Esq(uirrels) will have something to bitch about and so that I can trash out their 501(c)(3) organization – Foundation for the MarketPlace of Ideas / ZOGbot Poverty Law Center – on the bowel Movement Internet blogs, forums, and web pages some more. So she wrote that she didn’t know “Rio Brain” and there was something about Trump and Obongocare repeal and she worried that the doctors wouldn’t give her her pills, and I reminded her to say that she had to go to see a new doctor on the 28th and that we will call in on the 29th to this Court. She don’t do dictation very well and this Court told me not to play lawyer for her like Reo does in defeating service on its father and for William & Melissa Finck.

I’ll enclose her letter, and a copy of the Reo envelope showing the March 15 postmark.

This Court, in claiming jurisdiction of this matter on 3 June 2016, said that this case might be disposed of by consolidating it with Case 15 CV001590. This case was made after Bryan Reo lost its \$10.75 million federal case. It involves, like this case, Pastor Lindstedt calling Bryan Reo a homosexual mongrel and Bryan Reo (and others) falsely claiming that Pastor Lindstedt is a child molester and a convicted one at that. Bryan Reo is under the delusion that this Court gets to censor the Internet. Pastor Lindstedt is counter-suing Bryan Reo (and others). Thus the proper matter for this case, which should be consolidated, is one of defamation (who said what and when) and of abuse of legal process by Bryan Reo.
