**MOTION TO ADD BRYAN REO'S CO-CONSPIRATOR FATHER ANTHONY D. REO
AS A PARTY TO THE CONSOLIDATED CASE IRRERSPECTIVE OF THE QUASI-
LEGAL CHICANERY BY BRYAN REO AND ATTORNEY BRETT KLIMKOWSKY
TO DEFY SERVICE UPON BRYAN REO'S FATHER AS A CO-DEFENDANT OF
BRYAN REO'S ABUSE OF LEGAL PROCESS AND MALICIOUS PROSECUTION OF
NUMEROUS FRIVOLOUS AND VEXATIOUS LAWSUITS AGAINST PASTOR
LINDSTEDT AND HIS CHURCH**

COMES NOW the current Defendant / Counter-Claimant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") to Motion that Bryan Reo's father, Anthony D. Reo, be compelled by this Court to appear as a Defendant to this consolidated action brought maliciously by Bryan Reo and Bryan Reo's Council Attorney Brett Klimkowsky and fellow board member(s) of the misnomered "Foundation for the Marketplace of Ideas" which has for the past seven years taken down Church web pages both domestically and in Canada for truthfully revealing Bryan Reo to be a mongrel homosexual. Bryan Reo in the failed federal lawsuit which he brought refused to allow service in May 2015. <http://bryanreo-lawsuits.xyz/2015/May15/050815-133622.mp3>

Now in the current litigation, at the 17 Dec. 2015 Case Management Conference Bryan Reo gloated about how he defeated legal service on his father, Anthony D. Reo and how he drafted William Finck's and Melissa Epperson's Motions to Dismiss for lack of this Court's jurisdiction. 7 Dec. 2015. (By the way, Pastor Lindstedt agrees with Bryan Reo drafting on behalf of its co-conspirators that a local Ohio county court 900 miles and several states away has

no jurisdiction over William Finck, Melissa Epperson, or Pastor Lindstedt and Lindstedt's Church over fighting whether homosexual mongrels and jews have a place pretending to be Aryan Christian Israelites. Reo was simply providing cover for its jew infiltrator co-conspirators trying to "take over" Christian Identity religious dogma. Pastor Lindstedt's and Lindstedt's Church's counter-claim(s) are that Bryan Reo and Reo co-conspirators have engaged in abuse of legal process, malicious prosecution, and vexatious litigation and that the only jurisdiction that this Ohio county court has is over Bryan Reo, Reo's father Anthony D. Reo, Attorneys Brett A. Klimkowsky and Kyle Bristow as officers of this Court engaged in unethical and unlawful abuse of legal process.) This Court warned Bryan Reo to not act as an attorney for William Finck, Melissa Epperson or his father. At the Case Management Conference for 16CV000825 Bryan Reo again was warned that neither himself nor his fellow board member and attorney Brett Klimkowsky could represent Bryan Reo's father Anthony D. Reo. This Court, in its own Opinion of 11 April 2017 admitted "there exists no present basis for the court to dismiss the claims attempted to be asserted in the amended complaint against Anthony Reo based upon Civ.R.3(A)." The case record shows that service via certified mail was attempted on 10 Nov 2015 and deliberately refused on 15 Dec. 2015, wherein at the case management conference on 17 Dec. 2015 Bryan Reo gloated about defeating this Court's service. Pastor Lindstedt nevertheless when mailing his papers to Bryan Reo would also address these copies to Anthony D. Reo throughout this case. Bryan Reo has the delusion that whatever it says that the law is usually isn't. Pastor Lindstedt would then scan in Reo's sundry motions and complaints and unwonted e-mails and then put them up on the Church web pages and forums with a ridiculous and overtly racist title for the amusement of others. Pastor Lindstedt always has wanted all this stuff to go to trial by jury eventually, as opposed to ever paying Bryan Reo and Reo co-conspirators tribute.

Once the 2 August and 20 Sept 2016 trial dates were discontinued by Bryan Reo's fraudulent claims to be out of the country for 2 August and by this setting aside the later 2016 trial date by the Court, for the new trial date of 14 Feb. 2017 Pastor Lindstedt tried twice in January 10th and Feb 27th to have Anthony Reo served yet again. The Lake County Sheriff's Department told Pastor Lindstedt that both Reos refused to accept service even on weekends and refused to come in and accept the paperwork regardless of how many requests to do so were left at their residence. Bryan Reo simply refuses to accept service or let his father be tried as a party

yet in all of Reo's pre-trial postings Reo claims that he wants his father Anthony Reo as a witness against Pastor Lindstedt and Lindstedt's Church.

On 3 Feb 2010 Bryan Reo's co-conspirator Attorney Brett A. Klimkowsky filed a fraudulent motion aimed at getting Anthony Reo off the hook by pretending that it was Pastor Lindstedt's fault that Anthony D. Reo wasn't served. Pastor Lindstedt sent a Motion filed on 9 Feb 2017 pointing out that this failure to serve was all because of Bryan Reo and Reo's father's refusal to be served without expensive process servers and that Attorney Klimkowsky was lying to this Court. A Continuance was granted to in part bring Anthony D. Reo to justice and a new trial date of 6 June 2017 was set. Pastor Lindstedt wants this harassment of himself and his Church to end by going to trial and getting a jury to render a judgment of \$100,000 and an end to Bryan Reo and Brett A. Klimkowsky and Anthony D. Reo abuse of legal process, malicious prosecution and vexatious litigation by getting a judgment sufficient so that Bryan Reo will never be allowed to become a lawyer, Brett Klimkowsky and Kyle Bristow get disbarred, Anthony Reo will refuse to allow barratry within his household, and Bryan Reo, Klimkowsky, and Bristow will never get to pretend to be White Supremacists again.

This Court never had any jurisdiction, either subject matter or personal, over what was published over the Internet about Bryan Reo's racial heritage or past behavior from 2005 to 2014, nor that Pastor Lindstedt published the pleadings from 2015 before the Western District of Missouri federal district court, which are public records. Nor does this local Court have any jurisdiction to impose a "gag order" upon publication of ongoing found facts concerning Bryan Reo and Reo co-conspirator evil-doings. The only jurisdiction that this Court possesses is on Pastor Lindstedt's and his Church's counter-claims that Bryan Reo and those of his co-conspirators who are under the jurisdiction of this Court are liable to Pastor Lindstedt and Lindstedt's Church for the abuse of legal process, malicious prosecution, and vexatious litigation. That would especially mean Bryan Reo's father Anthony D. Reo, and Ohio attorneys Brett A. Klimkowsky and Kyle Bristow.


Roxie Fausnaught was never served. After signing for Pastor Lindstedt in the bogus litigation Bryan Reo filed against Lindstedt, Lindstedt's Church, and Roxie Fausnaught, it was decided to sign for the Church. But the local post office will not deliver certified mail to a bed-bound patient and Pastor Lindstedt wasn't going to go to the bother of loading up Roxie into a wheelchair for her to pick it up herself. The Mentor Municipal Court agreed that Bryan Reo was an abusive and vexatious litigant and refused to claim jurisdiction over that case, instead kicking

it up to this Lake County Court, also without jurisdiction. While Roxie has written some quasi-literate scribbling in which Pastor Lindstedt won't inform her how to write down "Brain Rio's" name correctly, the only purpose of that was to generate yet more idiotic Bryan Reo Motions to Strike and it did induce Bryan Reo to sue Judge Richard Collins for a Writ (#2017-L-036) which was denied which Pastor Lindstedt found out about recently.

Roxie Fausnaught isn't even able to go see a primary care physician for her lymphoma and Type II diabetes. When it was attempted in April the physician refused to see her after she slipped out of the wheelchair at the door to the clinic in Carthage Missouri 15 miles away. Now she isn't even able to get into a wheelchair as of Friday, 19 May 2017 and the new proposed doctor, a fat woman with Type II diabetes won't make van calls either.

Wherefore, Pastor Lindstedt petitions this Court to rule that Anthony D. Reo has effectively been served and is to appear alongside its son, Bryan Reo for a jury trial 6 June 2017 on Pastor Lindstedt's and Lindstedt's Church's counter-suit for \$100,000 damages plus expenses for abuse of legal process, malicious prosecution, and vexatious litigation.
