<u>DEFENDANT'S PRE-TRIAL STATEMENT / EXHIBIT ADDENUM TO THE</u> PREVIOUS 5 OR 6 PRE-TRIAL STATEMENTS FOR JURY TRIAL SET 7 AUG 2018

COMES NOW the current Defendant / Counter-Claimant Pastor Martin Lindstedt (hereafter in person described as "Pastor Lindstedt") and to the limited extent possible for Roxie Fausnaught and The Church of Jesus Christ Christian / Aryan Nations of Missouri (neither of which are within the jurisdiction of this local Lake County Court except within the fevered delusions of Bryan Reo – now a licensed attorney and perjurous officer of this Court (Bar # 0097470) and furthermore Roxie Fausnaught has never been served) to make a mere Pre-Trial Statement Addendum of three pages for the Eighth Attempt at a Jury Trial set for 7 August 2018. By its "forum shopping" before this local Court and now that it has been allowed to file new cases – now up to 56 including the old one aginst Starkist Tuna – and by removing its old lawyer co-conspirators Attorneys Kyle Bristow and Brett A. Klimkowsky from this case now that the "Foundation for the MarketPlace of Ideas" / ZOGbot Poverty [F]Law Center which was supposed to conduct "lawfare" on behalf of jew, mongrel, pervert and agents provocateur pretending to be Alt-Right, White Nationalist / Supremacist has imploded in early March 2018 – there really isn't much, if anything, different than the issues presented by Defendant Pastor Lindstedt in his five or six PreTrial Motions for the jury trials scheduled for times before like on Jan 23, 2018 amended from Sept. 2016, then 6 June 2017, then Aug. 1, 2017, etc.

Pastor Lindstedt does not recognize that this Court has any jurisdiction to grant Bryan Reo the ability to censor the Internet, nor to pursue claims prior to 2015 from 2010-2014 after Bryan Reo lost his previous fraudulent federal case due to Ohio Statute of Limitations setting an

absolute bar to prosecution of one year, nor to whine about Pastor Lindstedt publishing the public records of that failed Federal case. Bryan Reo was rejected by this Court in adding new false charges dating from early 2016 about Pastor Lindstedt speculating about its relationship with Attorney Kyle Bristow being sexual in nature.

This Court simply doesn't have jurisdiction to in effect impose a blanket censorship and gag order over the Internet of what someone says about a quasi-public figure pretending to be a White Supremacist especially given that Bryan Reo is a homosexual deranged mongrel with an infinite capacity for evil like none other Pastor Lindstedt has ever before witnessed in the [bowel] Movement. Since this Court is barred from allowing Bryan Reo to prosecute a civil case for libel, slander, and defamation from 2010 to 2014 or to prosecute Pastor Lindstedt for publishing federal court public documents then the *ONLY* issue remaining is Pastor Lindstedt's counter-claims for Bryan Reo's abuse of legal process, malicious prosecution and vexatious litigation against Bryan Reo, Bryan Reo's father and co-conspirators William "Baal" Finck, Melissa Epperson, Clifton Emahiser, William Shawn DeClue, John Britton, and Reo's lawyers Kyle Bristow and Brett Klimkowsky.

The fraudulent and unconstitutional stalking case Bryan Reo used against Pastor Lindstedt, 16CS000102 should be set aside and Bryan Reo charged with perjury. Pastor Lindstedt has <u>NEVER</u> contacted Bryan Reo by telephone or mail and given Reo's often successful attempts at taking down Lindstedt's and Lindstedt's Church web pages and those of others Lindstedt does not ever directly contact Reo via the Internet. In fact it is precisely because Reo is a known homosexual mongrel working with the federal and state governments as an agent provocateur and antifa activist that Pastor Lindstedt has urged for the past eight years since Lindstedt detected Reo and Reo's co-conspirators William Finck, etc. to not harass or threaten harm or have anything to do whatsoever with Bryan Reo or anyone Bryan Reo has anything to do with because nothing good and much which is harmful will ever come of it.

Lastly, what with all these mass shootings, certain states have flirted with pre-emptively disarming patently evil and disturbed individuals who are an immanent threat to themselves or others. What with Bryan Reo's long history on Stormfront and at the North Perry Nuclear Power Plant of threatening to ambush and murder FBI, BATF, Lake County police, and just about anyone else ridiculing this Satannic mongrel abomination, (& especially Pastor Lindstedt) then if anyone should be locked up in protective custody first thing right off under any proposed or new law it is Attorney Bryan Reo, Bar No. 0097470. On July 18, 2018 a party to this lawsuit, Clifton Emahiser. died while under the care of William Finck and Melissa Epperson.
