**PASTOR LINDSTEDT'S REPLY MOTION TO DISMISS OR CHANGE
VENUE OF GOVERNMENT AGENT PROVACATEUR PROFESSIONAL
PLAINTIFF BRYAN REO'S NON-RESPONSE TO JUDGE BRENNAN'S 12
OCT. 2022 ORDER GIVEN THAT THIS FEDERAL COURT LACKS
JURISDICTION OR PROPER VENUE PURSUANT TO 28 U.S.C. § 1391 (b)**

NOW COMES Pastor Martin Lindstedt of the Church of Jesus Christ Christian / Aryan Nations of Missouri to file a Reply Motion even though Pastor Lindstedt hasn't received the Bryan Reo Reply Motions ORDERED by 14 November 2022 either by mail or e-mail.

First of all this federal court lacks any jurisdiction to hear this latest harassing case of over 25 cases plus by non-private figure and professional agent provocateur Bryan Reo who has worked in such a capacity as a pretend "white supremacist" against the disorganized racial and

religious political “wolf-packs” since 2002 and against Pastor Lindstedt and his Aryan Nations Church since 2009. Bryan Reo in real life is a delusional homosexual part-jew part negroid mongrel who by dint of civil lawfare has achieved his federal goal of seizing Pastor Lindstedt’s South Dakota inheritance and costing Pastor Lindstedt’s sister \$150,000+ in fines and lawyer fees, even though in real life Bryan Reo cannot pass for one of us “white supremacists.”

In fact, Bryan Reo acting as an agent provocateur in conjunction with the state and federal courts illustrate why the current form of government needs to be altered and abolished along with most of the current population of the US, especially of NorthEastern Ohio and of South Dakota. As the past few years illustrate, be it at Charlottesville in 2017 – where Bryan Reo was working as a member of the Foundation for the MarketPlace of Ideas (FMI) and on January 6th 2021 these agents provocateur whip up rebellion and then use the state and federal courts to punish ZOG subjects under the delusion that they are citizens with “constitutional rights.”

Bryan Reo merely relitigates before this Court sans jurisdiction the Lake County/Mentor Municipal Court from 2016 jury trial in which Pastor Lindstedt noted on his Aryan Nations web page that Bryan Reo got fired from working at the North Perry Nuclear Power Plant (NPNPP) in 2012 that Pastor Lindstedt found out about in Feb 2016. If Pastor Lindstedt had known that Bryan Reo worked in a nuclear power plant, especially an ailing one such as NPNPP, then he would have taken down all of his Bryan Reo reporting and hoped that this Satanic tool would destroy the plant around the Blue Hive of Cleveland which is targeted for destruction anyways. According to Bryan Reo’s ridiculous civil complaint Pastor Lindstedt said something on Sept. 28, 2020 of which there is no actual recording, much less a public statement. Thus like all of these Bryan Reo civil lawfare complaints they are either perjurous or simply nothing more than Bryan Reo derived causes of action as a government agent provocateur out to destroy white

supremacist and Christian Identity racial and religious dissent, with the aid of the Satanic federal and state regimes, their police and courts, thus incurring civil warfare and revolutions for freedom on the part of said white supremacist churches and groups in ensuring White survival.

When Pastor Lindstedt found out about Bryan Reo working at the NPNPP around 22 Feb 2016 upon a Google Search in response to a bogus Bryan Reo Lake County Civil Stalking Protection Order, Pastor Lindstedt thought it was a big joke to have a pretend white supremacist with obvious psychological problems working at an ailing old nuclear power plant rated #103 out of #104 nuclear power plants then in the nation. The problem is that Cleveland must keep these ailing subsidy dumpsters running because they need the electricity and this rust-belt area simply cannot afford to replace it so fraud has been used to keep it running. After a number of accidents Bryan Reo being the known non-white Internet troll “SwordBrethren” who has been active since 2002 at the age of 16 was found out and Bryan Reo thus being an embarrassment was fired, whereupon he sued one Hiram Reppert who was the main personage behind the NPNPP for kicking him out of the nuclear technicians training course at the Lakeland Community College and lost because the lawsuit was baseless because there was no point in insisting that such training continue for a blacklisted wannabe white supremacist. Unlike Pastor Lindstedt, longtime head of the Aryan Nations there was no sense to this persecution continuing to ruin using other state courts in Missouri and \South Dakota as was done via civil lawfare against Pastor Richard Butler’s Aryan Nations in 2000 by the Southern Poverty Law Center. Bryan Reo was also ZOGbotting along with Attorneys Kyle Bristow, Brett Klimkowsky, sundry other lawyers such as Thom Robb’s son Jason Robb, and Richard Spencer and Mike Enoch the false-flag “white supremacist” lawfare group incorporated as The Foundation for the Marketplace of Ideas (FMI) also known as the ZOGbotPoverty [F]Law Center (ZPLC) which would keep Movement

activists thinking that they had legal representation as opposed to doing something useful such as bombing ZOG government buildings and execution of state and federal ZOG officials and wiping out theys' families and bringing matters to open racial and religious civil warfare which will separate ZOG/Babylon into 20-30 million surviving whites ruled by local theocratic military dictatorships, which is the political and religious goal of the Aryan Nations. Another antifa lawyer named Robert Konrad stole Pastor Lindstedt's sister's confidential legal files while working at the Ollinger Law Firm—indeed Lawyer Konrad rubbed it in by handing Pastor Lindstedt an office pen at the 31 August 2020 hearing in Stanley County. For 3 1/2 years Bryan Reo and Pastor Lindstedt had exchanged invective, Bryan Reo calling Pastor Lindstedt a “convicted child molester” and Pastor Lindstedt calling Bryan Reo a ”mamzer faggot ZOGbot” i.e. a homosexual mongrel agent provocateur. Pastor Lindstedt is not a child molester, much less a convicted one while there is proof that Bryan Reo is indeed non-white & an agent provocateur and by Reo's own words and deeds that Reo is a homosexual who used extortion and blackmail to get his own way. Once established Lindstedt had something to steal these cases began

Thus Bryan Reo is NOT a private figure but a public figure who is working for the federal and state regimes and their courts to destroy and oppress Pastor Lindstedt and his white supremacist Dual-Seedline Christian-Identity Aryan Nations church because of well-founded fears that they will incite YHWH's Servant Nation of Aryan Christian Israel to rise up and exterminate the jews, the non-whites, and gliberal whiggers and theys' Satanic criminal regime pretending to be a democracy. Thus under color of civil lawfare this Ohio federal court and the State of South Dakota have not only set aside the toilet-paper pretend protections of theys' CONstitution but the First Amendment of the Bill of Goods, but the 7th Amendment claim to having a jury trial in civil matters and and 8th Amendment claim of “no excessive fines”

having already assessed \$2.75 million in judgments which the South Dakota judiciary already enforced in violation of South Dakota State Law 15-16A-6 by selling four outstanding foreign judgments and giving Pastor Lindstedt's 1800 acre inheritance to Bryan Reo prior to pending appeals presently before the 6th Circuit Court of Appeals and not to be heard until 8 Dec. 2022. See Consolidated Appeals 21-3633 / 21-3661 / 21-4191 / 22-3025 *Bryan Reo et al v. Martin Lindstedt*. This latest Bryan Reo lawsuit before this federal court without any legitimate jurisdiction and contrary to the venue requirements of 28 U.S.C. § 1391 (b) is merely yet another harassing lawsuit by agent provocateur (ZOGbot) Bryan Reo of nonsense cobbled together at the last minute in 2021 given that the previous four worked to financially destroying overt aboveground political and religious figure Pastor Lindstedt and his Aryan Nations church.

Given past experience from this Satanic criminal regime using the Federal secret political police such as the FBI, etc, and the civil lawfare of Charlottesville (which involved Bryan Reo's FMI/ZPLC civil lawfare corporation) and the January 6th provoked fake-insurrection it is likely that of course Bryan Reo was hired by the North Perry Nuclear Power Plant in order to set up a "false-f[il]ag" effort to have a small nuclear meltdown at that ailing plant and to blame it on "white supremacists." Not that it matters. Ever since 13 June 2016 the Church of Jesus Christ Christian / Aryan Nations of Missouri has a standing order asking that the North Perry Nuclear Power Plant be chernobylized because they're civil lawfare of dragging strangers to appear before their courts of absolutely no jurisdiction is absolutely the same as that of Sodom and Gomorrah's policy of kidnapping travelers in caravans between the Red Sea and Mesopotamia circa 2000 BC in the days of Abraham. The sins of Sodom of abuse of legal process to rob and murder those not remotely under their jurisdiction is the same as these Ohio regime courts and calls for the same sort of punishment, i.e. thermonuclear fire and destruction and turning Lake Erie into the New

Dead Sea. Likewise with South Dakota, ever since finding out about the Bryan Reo lawsuit there Pastor Lindstedt has called for the Oahe Dam to be destroyed and thus flood the state capitol of Pierre and the county seat of Stanley County of Ft. Pierre to be flushed away and never rebuilt and for the lawyers judges, politicians, police, etc. and theys' entire families to be destroyed or sterilized and enslaved forevermore of Northeastern Ohio and South Dakota in order that no corrupt democracy ever be established likewise forevermore.

Back in April 2014, in order to forestall Bryan Reo barratry and venue-shopping, Judge Guinn invoked 28 U.S.C. § 1391 (b) and transferred that case to the Western District of Missouri where eventually the Magistrate Judge there dismissed Bryan Reo's bogus lawsuit so Bryan Reo then sought venue in Lake County Ohio where before a lynch-mob jury and corrupt Judge Condon he won \$105,000 against Pastor Lindstedt and \$400 against Pastor Lindstedt's Aryan Nations Church.

As an initial matter, venue for this action is not proper in the Northern District of Ohio. Pursuant to 28 U.S.C. § 1391(b), a civil action may be brought in: (1) a judicial district in which any defendant resides, if all defendants reside in the same state in which the district is located; (2) a judicial district in which a substantial part of the events or omissions giving rise to the claim occurred; or (3) if there is no district in which an action may otherwise be brought as provided in this section, any judicial district in which any defendant is subject to the Court's personal jurisdiction with respect to such action. Lindstedt is a resident of Granby, Missouri. He is the only defendant. ***Venue is proper only in the Western District of Missouri where Granby is located.*** *Reo v. Lindstedt*, 1:14-cv-00816 Page ID #38

Thus Judge Guinn who has some respect for federal law on his own sent the first Bryan Reo case to the federal court in Southwestern Missouri where after a while this Bryan Reo case was dismissed because Bryan Reo wasn't a private figure nor could Bryan Reo show that he was damaged as a professional agent provocateur in any way. Eight years later the same thing holds. Pastor Lindstedt does not have sufficient money to go to Neosho Missouri to the soup kitchen more than once a month or to his house in Granby two miles away more twice a week. Having a

federal or state court using its judicial power to destroy a white supremacist pastor & his Aryan Nations church on the whinings of one of its homosexual mongrel agents provocateur certainly puts the lie to it being anything other than a Satanic criminal regime out to destroy White People.

Bryan Reo as a professional agent provocateur in his over-ruled Motions to Strike whines that Pastor Lindstedt has nothing but hatred and contempt for this so-called “republican form of government” and especially for its legal system and judiciary. He points out that given that Pastor Lindstedt foolishly transferred four cases from Lake County and lost given no jury trial and excessive fines totaling \$2.75 million and having his property awarded to Bryan Reo last week on the Stanley County Courthouse steps in violation of their own pretend law SDSL 15-16A-6, that Pastor Lindstedt who is a far better white supremacist Christian Identity domestic terrorist than attorney like Bryan Reo, Robert Konrad and Kyle Bristow seems to have lost the monkey-talk Talmudic babble which passes for justice before a dying mighty evil empire’s courts. There is an ailing NPNPP just outside Cleveland and given the Russia-ZOG Ukrainian War it is proven that it is extremely easy for these nuclear power plants to be captured and deprived of cooling water over the nuclear fuel rods leading to a meltdown and an explosion which will poison the land about for the next centuries. And given the breakdown of ZOG/Babylon the financial, police and court systems are on the verge of atavistic Revolution in which the current system and those who serve it are to be destroyed.

Bryan Reo hasn’t sent myself his Consolidated Response due 14 November 2022 by either mail or e-mail. Pastor Lindstedt shall send his by mail on Friday, Nov. 25th. Pastor Lindstedt makes it entirely clear that these Ohio courts both state and federal have as much jurisdiction over Pastor Lindstedt and his Aryan Nations Church as Sodom and Gomorrah had

over the people kidnapped and made to appear in order to be judicially robbed and murdered and thinks that the same solution applied by YHWH for this Satanic perversion of law needs to be applied to Northeastern Ohio and South Dakota as well. Pastor Lindstedt will thus simply use his collection of postage and not pretend that this Court has any jurisdiction by filing it electronically and thus keep this Court on the judgment for its tyranny. Nor is Pastor Lindstedt going to feign anything of respect for this Court or its Satanic system but rather Revolutionary steel.

Pastor Lindstedt shall carry out Revolutionary sentence both on Northeastern Ohio and on Missouri River South Dakota and its population. Northeastern Ohio is like Sodom and Gomorrah in usurping jurisdiction. South Dakota is like unto the Tribe of Benjamin in its abuse of legal process benefitting perverted Canaanites.
