PASTOR LINDSTEDT'S FEDERAL RULE OF CIVIL PROCEDURE RULE 59(e) & 60 MOTION FOR JUDGE MEEHAN TO ALTER OR AMEND HER JUDGMENTS OF 20 DEC. 2022 (Doc 20) DENYING DISMISSAL FOR THIS OHIO FEDERAL COURT'S LACK OF BOTH SUBJECT MATTER AND PERSONAL JURISDICTION AND PASTOR LINDSTEDT'S MOTIONS TO TRANSFER TO THE VENUE OF THE WESTERN DISTRICT OF MISSOURI PURSUANT TO 28 U.S.C. § 1391 (b)(1) AND 28 U.S.C. § 1404(a). ALSO BRYAN REO IS A PUBLIC FIGURE GOVERNMENT AGENT PROVOCATEUR WORKING AGAINST PASTOR LINDSTEDT AND HIS ARYAN NATIONS CHURCH THUS HAS NO CAUSE OF ACTION TO SUE FOR DEFAMATION IN THE FIRST PLACE.

NOW COMES Pastor Martin Lindstedt of the Church of Jesus Christ Christian / Aryan Nations of Missouri to file this Federal Rule of Civil Procedure (hereafter F.R.Civ.P.) Rule 59 & Rule 60

Motion for Judge Meehan to Alter, Amend, or Abolish her 20 Dec. ORDER(s)/Judgments (Doc. 20) Denying Dismissal of Professional Public Figure and Government Agent Provocateur Bryan Reo's latest (#26 or #27) lawsuit for spurious defamation on the grounds that this Ohio federal district court lacks both subject-matter and personal jurisdiction and denying the dismissal or venue transfer of this lawsuit to the Western District of Missouri just like Judge Guinn did for the first Bryan Reo lawsuit of April 2014, *Reo v. Lindstedt* *Reo v. Lindstedt*, 1:14-cv-00816 Page ID #38. Upon Bryn Reo's first lawsuit being found to be frivolous according to the Digital Millennium Copyright Act (hereafter the DMCA) Bryan Reo given 50 days (20 for the Magistrate Judge and 30 by Reo Motion) Bryan Reo was unable to show any damages whatsoever, and thus the case was dismissed. Pastor Lindstedt wants the same results for what is the 26th iteration of the same Bryan Reo agent provocateur (also known as a "ZOGbot") endless civil litigation in which civil lawfare inevitably leads to racial and religious civil warfare.

STATEMENT OF THIS CASE.

So given that Bryan Reo – in addition to being a delusional homosexual mongrel impersonating a white supremacist since 2002 – is NOT a private figure but rather a known public figure and most importantly an agent provocateur / ZOGbot – who has filed around 30 sundry state and federal lawsuits with other Movement lawyer dissidents against Pastor Lindstedt, his Aryan Nations Church, his deceased woman, and his sister in order to reduce Pastor Lindstedt, his Aryan Nations Church and his family to court-created poverty and to persecute those of the Dual-Seedline Christian Identity Faith in order to make the Mighty Evil ZOG/Neo-Babylonian Empire safe for the Spawn of Satan jews, the non-whites, and the ZOGling whigger race-traitors/Scalawags. This Court claims a fraudulent jurisdiction / dominion over self-aware Adamic Man much like the Men of Sodom & Gomorrah for which crimes

YHWH killed them all. The 6th Circuit Court of Appeals sidestepped this basic issue regarding jurisdiction over 4 Bryan Reo cases and reversed /& remanded it back to the Northern District of Ohio on 8 Dec. 2022 Case # 22-3633. Bryan Reo and his Lawyer Robert Konrad working in collusion with the State of South Dakota, its supreme court, Stanley County and the authorities there have deliberately violated South Dakota State Law 15-16A-6 which forbids execution of foreign judgments (totaling \$2.75 million in the Ohio federal courts, since reversed & remanded) and simply unlawfully transferred Pastor Lindstedt's inheritance of 1806 acres in Stanly County in an illegal sheriff's sale on the Stanley County Courthouse steps on May 26, 2022 fully knowing that these judgments were under appeal before the 6th Circuit Court of Appeals. Also Pastor Lindstedt's sister was not permitted to simply quitclaim Pastor Lindstedt's inheritance back to him when hearing for the first time about Bryan Reo in March 2020 and was robbed of \$150,000+ by the South Dakota courts because she wouldn't transfer it to Bryan Reo.

Accordingly, Pastor Lindstedt has decided to treat those criminal regime entities and personnel who act like Sodom & Gomorrah in theirs' pseudo illegality outside lawful jurisdiction and dominion as YHWH treated Sodom and Gomorrah. Given an ailing ancient nuclear power plant – the North Perry Nuclear Power Plant (henceforth NPNPP) in which Bryan Reo was infiltrated doubtless as part of a “dirty bomb ZOG false f[[lag operation” and for the spurious offense of notifying on the Aryan Nations web page(s) that Bryan Reo was a fake white supremacist known as “SwordBrethren” Bryan Reo has sued Pastor Lindstedt and the Aryan Nations in the Lake County Ohio courts and now again in this Federal case 21-cv-1809. Therefore, since 13 June 2016 when the Lake County court decreed that Pastor Lindstedt as a non-lawyer could not defend his Aryan Nations Church or his fat sick bed-ridden semi-illiterate woman Roxie Fausnaught Pastor Lindstedt has decreed that NPNPP was to be chernobylized and

Northeastern Ohio turned into a nuclear wasteland and Aryan Nations military reservation for non-whites allowed to live in the former ZOGland turned into a mélange of local theocratic military dictatorships over 20-50 million ex-whiggers turned feral ruled over by The Ten Thousand Warlords. Thanks to this latest lawsuit, any other nuclear power plant within the jurisdiction of the Northern District of Ohio is now fair game as well. Given that they claim – like Sodom & Gomorrah to have “long arm jurisdiction” every single judge, lawyer, politician and pig and theirs’ families shall either be deprived of having long arms severed above the elbows and like the Doom of Daniel have their sons turned into eunuchs by making theirs’ regime criminals “eat theirs’ spawns’ nuts” and daughters turned into “walking wombs” after rape by their parents to breed a White Supremacist new nation.

The State of South Dakota is to be treated as the Tribe of Benjamin for abuse of legal process and having no nuclear power plant but having impoundments on the Missouri River, particularly the Oahe Dam just north of Pierre the state capitol and Ft. Pierre the county seat of Stanley County, which shall be destroyed and flushed away never to be rebuilt but rather restored forever to its natural status circa 1805 when Lewis & Clark went by. Upon the bluffs overlooking the river, Revolutionary drumhead tribunals shall be established for judges, lawyers, politicians, piglice, sundry regime criminals where they and theirs’ families shall like in Northeastern Ohio be relieved of theirs’ lives, liberty, property, spawns’ nuts & maidenheads. Theirs’ ancestors shall be dug up and fed to the dogs & birds as will those who resist the new White Supremacist Aryan Nations theocratic regime.

In this case, this is merely a non-white ZOGbot Bryan Reo and fake white supremacist ZOGbot friends working with anti-white state & federal regimes to engage in a Second Civil

War against YHWH's Aryan Christian Israelite Servant Nation in general and against YHWH's Servant Nations First Servant, i.e. Pastor Lindstedt and his Aryan Nations Church in particular.

I. Alleged Factual & Procedural Background

This Court merely repeats Bryan Reo lies about how Pastor Lindstedt and Aryan Nations Church was railroaded by a hostile jury and corrupt Lake County judge hostile to this white supremacist Aryan Nations pastor and his Church living 891.1 miles in Southwestern Missouri dragged before Bryan Reo's preferred venue in Lake County. The mythical damages assessed were \$105,000 against Pastor Lindstedt and \$400 against Pastor Lindstedt's Church in which a TV5 news article was republished and Pastor Lindstedt questioned Bryan Reo's firing. Bryan Reo claims a date of Sept. 28 2020 (not as this court states Sept 28 2022) in which Pastor Lindstedt allegedly did a podcast about Bryan Reo and his working and termination from the North Perry Nuclear Power Plant. There is no such podcast or publication on this date but rather Pastor Lindstedt references continually what is public knowledge on TV Channel 5 Cleveland and all the court filings over the years of Bryan Reo's firing from the NPNPP and has questions of this public-figure ZOGbot. If Pastor Lindstedt had known before he read in Feb 2016 about this crazed delusional homosexual mongrel ZOGbot with a tenuous capacity for delusion and bottomless appetite for evil then he would have taken down all reference to Bryan Reo in the hope of having Bryan Reo chernobylize the NPNPP. From what Pastor Lindstedt read there was a number of accidents at this ailing #103 out of 104 nuclear power plants in the ZOGland and so the operators of the NPNPP upon doing the due diligence they should have done figured out that Bryan Reo was "SwordBrethren" the "Teutonic Crusader" and fake white supremacist and fired him for whatever reason and Bryan Reo whined on camera about how the operators cared nothing about safety. Bryan Reo has blamed since his firing one Hiram Reppert who he sued for

kicking him out of the Lakeland Community College as a nuclear technician after being fired and myself and my Aryan Nations web page. For years afterwards Pastor Lindstedt has joked about having the good news of saving 6 million ZOGlings and the bad news about them living in Cleveland. This while Bryan Reo founded the white supremacist lawfare NGO group Foundation for the MarketPlace of Ideas (FMI) / ZOGbot Poverty [F]Law Center (ZPLC) a take-off of the jew lawfare anti-white hate group Southern Poverty Law Center with other Movement public figures such as Lawyer Kyle Bristow (Bryan Reo's suspected Aryan homosexual hump), James Edwards, Thom Robb's lawyer spawn, Augustus Invictus, Charlottesville Alr-Righers Richard Spencer and Mike Enoch and others.

Bryan Reo simply resurrects this protected free speech about a pretend white supremacist public figure ZOGbot by longtime enemy Pastor Lindstedt in Sept 23, 2021 and says that Pastor Lindstedt repeated what was said back in 2016 repeating what was presented on a public TV news show. Bryan Reo also asks this Court for a gag order.

Then this Court repeats the events of 2022 in which Pastor Lindstedt denies that this Ohio federal court has any legitimate jurisdiction and wants this case transferred to Southwestern Missouri where it will be dismissed or brought before a local pro-white Ozark jury as opposed to an Northeastern Ohio jury.

II. Discussion: This federal court claims subject-matter jurisdiction.

After Bryan Reo as "SwordBrethren" was detected by Pastor Lindstedt on 29 Oct. 2010 Bryan Reo begged for a deal in which Pastor Lindstedt agreed to not publish any more Bryan Reo material provided Bryan Reo left the Movement forever. This deal asked for by Bryan Reo was kept from Nov. 1 to 4th 2010 until on Nov. 5, 2010 Bryan Reo reprinted an Eli James/Joseph November article entitled "Rabbi Lindstench: Race-Traitor or Jew?" on the "SwordBrethren

Blog” on William Finck’s Christogenea.org fake DSCI web page calling Pastor Lindstedt a child molester 25+ times. Then Bryan Reo proceeded to make false DMCA claims and take down web pages until April 2014. For three and a half years Bryan Reo called Pastor Lindstedt a child molester and Pastor Lindstedt called Bryan Reo a “mamzer faggot ZOGbot”. Then in late 2013 Bryan Reo found out from antifa Lawyer Robert Konrad of Pierre South Dakota who stole Pastor Lindstedt’s sister’s confidential legal files that Pastor Lindstedt had an inheritance of 1800 acres in Stanley County worth stealing. So Bryan Reo took down his lies about Pastor Lindstedt and filed his first federal lawsuit in April 2014 which was transferred by Judge Guinn to the Western District of Missouri where on 10 Sept. 2015 it was dismissed for lack of jurisdiction because Bryan Reo even given 50 days to do so couldn’t prove he has \$75000 damages.

This Court has been apprised of these matters Yet it still claims subject-matter jurisdiction.

This Court claims Personal Jurisdiction under Ohio’s “long arm” statutes.

The Ohio Supreme Court quotes *Kauffman Racing Equip.LLC v. Roberts*, 930 N.E. 2d 748 (Ohio 2010). The dissenting judge didn’t predict Bryan Reo perpetual litigation against Pastor Lindstedt and his Aryan Nations Church but did predict the situation in which predatory lawyers would be going after defendants thinking that they had free speech over the Internet.

The end result of these Ohio state and federal courts pretending to have “long arm” jurisdiction is what will result in nearly 30 cases by Bryan Reo v. Martin Lindstedt in which a crazed delusional homosexual mongrel goes after a white supremacist Aryan Nations pastor and his Church in which racial and religious civil lawfare becomes racial and religious civil warfare and the “traditional notions of fair play and substantial justice are [~~not~~] offended.” It is because of these CONstitutional pretensions that a crazed delusional part jewish/negroid homosexual

mongrel ZOGbot such as Bryan Reo who would not dare attend a Klan or Aryan Nations meeting in real life thus before the Internet is no real threat now weaponizes Ohio statutes to where a white supremacist Aryan Nations pastor loses his inheritance before an anti-white biased jury and corrupt judge by a non-white homosexual ZOGbot lawyer.

Pastor Lindsted is no Genghis Khan or Joseph Stalin but since this Court wants to claim a jurisdiction much like Sodom and Gomorrah did under color of law then the rewards for that conduct will be Cleveland burned to the ground and Lake Erie turned into the New Dead Sea.

Venue is Improper.

Back in April 2014, in order to forestall Bryan Reo barratry and venue-shopping, Judge Guinn invoked 28 U.S.C. § 1391 (b)(1) and transferred that case to the Western District of Missouri where eventually the Magistrate Judge there dismissed Bryan Reo's bogus lawsuit so Bryan Reo then sought venue in Lake County Ohio where before a lynch-mob jury and corrupt Judge Condon he won \$105,000 against Pastor Lindstedt and \$400 against Pastor Lindstedt's Aryan Nations Church.

As an initial matter, venue for this action is not proper in the Northern District of Ohio. Pursuant to 28 U.S.C. § 1391(b), a civil action may be brought in: (1) a judicial district in which any defendant resides, if all defendants reside in the same state in which the district is located; (2) a judicial district in which a substantial part of the events or omissions giving rise to the claim occurred; or (3) if there is no district in which an action may otherwise be brought as provided in this section, any judicial district in which any defendant is subject to the Court's personal jurisdiction with respect to such action. Lindstedt is a resident of Granby, Missouri. He is the only defendant. *Venue is proper only in the Western District of Missouri where Granby is located.* *Reo v. Lindstedt*, 1:14-cv-00816 Page ID #38

Thus Judge Guinn who has some respect for federal law on his own sent the first Bryan Reo case to the federal court in Southwestern Missouri where after a while this Bryan Reo case was dismissed because Bryan Reo wasn't a private figure nor could Bryan Reo show that he was damaged as a professional agent provocateur in any way. Eight years later the same thing holds.

Judge Bridget Meehan has decided to go with Bryan Reo on this matter for whatever reason. She wants to pretend that Pastor Lindstedt hasn't incanted the "magic words" under 28 U.S.C. § 1391(b) or 28 U.S.C. § 1404. One must suppose that this federal court as well as the States of Ohio and South Dakota must relearn the hard way that racial and religious civil warfare in letting non-white agents provocateur proceed against white supremacists and their Aryan Nations DSCI churches living in another state is neither fun nor profitable.

III. Conclusion.

Pastor Martin Lindstedt has long since sought a pretext for racial and religious civil warfare leading to 20-30 million whites ruled by local theocratic white supremacist military dictatorships and the extermination of the non-whites, especially the jews, and the destruction of this Mighty Evil Satanic ZOG/Babylonian Empire. However first this corrupt actions by a satanic court must be challenged even though it will be lost before its own venue in which it insists it must be obeyed. Thus this F.R.Civ.P. Rule 59 & 60 display.
